#### Quorum

### **Adoption of 2017-18 Florida Kiwanis Family Operational Budgets:**

Lt. Governor Sullivan made a motion to ratify the approval of the organizational budgets by the 2016-17 board for Kiwanis, CKI, Key Club and Aktion Club for the 2017-18 administrative year. The motion was seconded by Lt. Governor Hartselle and carried.

#### **Nominations and Election to the Executive Committee:**

The following lieutenant governors accepted nominations to the Executive Committee:

Lt. Governors Flanagan, Hedges, and Morrell were elected by ballot.

Lt. Governor Sullivan made a motion to confirm the election of Lt. Governors Flanagan, Hedges, and Morrell. The motion was seconded by Lt. Governor McCampbell and carried.

### **Nominations and Election to the Personnel Committee:**

The following lieutenant governors accepted nominations to the Personnel Committee: Lt. Governor Jan Muenzemaier (D23) and John Sullivan (D21).

Lt. Governor Hedges made a motion to confirm Lt. Governors Muenzemaier and Sullivan as the 2017-18 representatives of the Personnel Committee. The motion was seconded by Lt. Governor Hartselle and carried.

### **Lt. Governor Report Deadlines:**

Governor Smith reminded the Board Members that to qualify for eligible reimbursement of the 2018 International Convention, board members must attend the district caucus and the business session in Las Vegas. There will not be a board meeting at the International convention.

He also reminded them that they must complete three visits to each club.

- a. Report of Training and Contact Visits and Reimbursement Request due December 1, 2017.
- b. Report of Official Club Visit & Reimbursement Request is due March 31, 2018.
- c. Report of Official Board Visit & Reimbursement Request due May 15, 2018. Reimbursement request must be submitted with report.

### **Executive Director's Report:**

Executive Director Winternheimer provided a written report in the board packet.

In addition, she briefly highlighted the weekend's convention activities and thanked everyone for ensuring that our members and guests had the best possible convention experience. She expressed her gratitude that Board Counselor Gary Levine and his wife Julia not only agreed to attend the convention but that they became such an integral part of it. She added that the support of our Service Leadership Program board members was extraordinary and gave special thanks CKI Governor Phoebe Sartori and Key Club Governor Felanté Charlemagne.

### **Membership Update:**

Formula Coordinator Stewart Ross provided an extensive update on the 2016-17 year and our positive outlook for 2017-18. He explained that the lieutenant governors are the nuts and bolts of the Formula team and that this is their chance to make a difference in the Florida District. He gave special thanks to Todd Brister, Jim Gillies, and Rhonda Vrell for all of their support and for agreeing to assist in 2017-18.

### Remarks by Florida Kiwanis Foundation President Bill Ricigliano:

President Bill Ricigliano provided a Foundation update and pledged the Florida Kiwanis Foundation's continued support to our Service Leadership Programs, to Kiwanis, and to the children in Florida. He thanked the lieutenant governors for working so well with the division trustees to raise awareness of the Foundation and its work for the children.

### Remarks by Florida CKI Governor Phoebe Sartori:

CKI Governor Sartori thanked Kiwanis for their overwhelming support and for allowing the CKI members to attend the convention. She encouraged everyone reach out the CKIs in their areas. She encouraged all board members to participate in CKI projects, their board meetings, and to sign up for the CKI Mentorship Program.

### Remarks by Key Club Governor Felanté Charlemagne:

Key Club Governor Felanté Charlemagne expressed his thanks for the board's commitment to service regardless of their personal or professional obligations. Key Club would not exist without the support of Kiwanis and Kiwanians serving as mentors, teachers, friends, parents, and financial support. He thanked the lieutenant governors for working alongside their Key Club counterparts and for helping with their projects. It is truly amazing what our organization can accomplish when we work together as a larger, stronger family.

He stressed that we all look at the urgency of the membership situation and work as a team to make a difference.
