OFFICIAL RULES

<u>Raffle:</u> Persons who meet eligibility requirements may enter into this contest ("Raffle") to win two (2) week-long Patron Badges ("Prize") to the 2024 Memorial Tournament presented by Workday. The Raffle is being conducted by The Kiwanis Club of Mason, a 501(C)4 non-profit service organization, chartered April 12, 1956 and is part of Kiwanis International.

Prize: Winning Entrant (("Entrant") being defined as one who meets all eligibility requirements and has completed an eligible entry into the Raffle) will receive a certificate from The Memorial Tournament good for two (2) week-long Patron Badges to the 2024 Memorial Tournament presented by Workday for the dates of June 3 – June 9, 2024. Winner will need to immediately contact the tournament office to redeem the certificate for the badges. Instructions for this have been provided by The Memorial Tournament. Patron Badges have a value of \$275 per badge and are good for admission to the grounds for all seven days of the tournament.

In order to be declared the Winner ("Winner") of the Raffle, winning Entrant must complete and execute a <u>Declaration of</u> <u>Compliance and Release</u> and otherwise comply with the Raffle rules ("Official Rules.")

Terms and Conditions: Entry to the Raffle is done electronically by Entrant at MasonKiwanis.org/memorial. Entrant will complete all information requested on the electronic form and will complete payment for the Raffle ticket to complete an eligible entry. A confirmation email will be sent to the email address provided on the Raffle entry to confirm participation in the Raffle.

Drawing will take place at the Kiwanis Club of Mason weekly meeting at Noon EDT on May 16, 2024 at the Manor House, 7440 Mason-Montgomery Rd., Mason OH 45040. Winner will be notified on May 16, 2024 through the contact information provided on Entry form. Winner will be published on the MasonKiwanis.org website.

The prize that may be awarded to the eligible Winner is not transferable, redeemable for cash, or exchangeable for any other prize. Entrants must provide valid and accurate contact information. If a Winner cannot be contacted or is disqualified for any reason, the Kiwanis Club of Mason reserves the right to determine an alternate Winner or not to award that Winner's prize, in its sole discretion.

Cancellation Policy: In the event the 2024 Memorial Tournament is cancelled for any reason, OR patron participation is suspended or limited for any reason, to include the Raffle patron badges, prior to the conclusion of the Raffle on May 16, 2024, the Raffle will convert to a 50-50 Raffle, with the Winner receiving 50% of Raffle proceeds in cash, the total of which will be as of the end of ticket sales on 11:59 P.M. EDT May 15, 2024, exclusive of processing fees.

<u>Eligibility and Limitations.</u> Entrants and Winner must be U.S. residents. Entrants and Winner must be 18 years or older to participate in Raffle. Entrant must be able to show proof of purchase of a valid entry into the Raffle. Proof of purchase will be provided via email at time of valid Raffle entry. Winning Entrant must complete and execute a <u>Declaration of Compliance and Release</u> and otherwise comply with the Official Rules.

<u>Entries.</u> Only entries submitted at the website MasonKiwanis.org/memorial will be considered an eligible entry. Winner will be selected at random from all eligible entries received. All entry information requested must be filled in accurately and completely or entry may be considered ineligible. There is no maximum number of tickets offered for sale. All ticket sales are final.

Publicity: Use of Personal Information. By participating, where allowed by law, all Entrants and Winner grant the Kiwanis Club of Mason exclusive permission to use their names, characters, photographs, voices, videotape, and likenesses in connection with promotion of this and other raffles and waive any claims to royalty, right, or remuneration for such use. By participating in the Raffle, where allowed by law, Entrants agree that the Kiwanis Club of Mason will not disclose personal information obtained from Entrants in the Raffle to third-parties beyond the Memorial Tournament Office.

Disqualification; Fraud. Failure to comply with the Official Rules is grounds for immediate disqualification from the Raffle. The Kiwanis Club of Mason reserves the right to disqualify any entry not conforming to the Official Rules of the Raffle at any time. The Kiwanis Club of Mason and its partners assume no responsibility for entry fraud committed by any Entrant. In the event it is determined that an ineligible Entrant wins a prize, the Kiwanis Club of Mason reserves all rights to the ownership and return of the prize and all costs associated with remedying any prize award to an ineligible entry or Entrant.

Misinformation. The Kiwanis Club of Mason is not responsible for undeliverable, lost, delayed, misdirected, or misaddressed email or any other issues regarding the electronic delivery of the confirmation of Raffle entry or notification of Raffle Winner. This includes, but is not limited to, the speed and reliability of Entrant's internet service provider. The sole determiner of eligibility for the final drawing will be compliance with the Official Rules and receipt of eligible Entry by 11:59 P.M. EDT May 15, 2024.

<u>Release</u>. By participating in the Raffle, each Entrant and Winner waives any and all claims of liability against the Kiwanis Club of Mason, its volunteers, the Raffle's sponsor and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Raffle, or from the use of any prize. Conduct and Decisions. By participating in the Raffle, Entrants agree to be bound by the decisions of the Kiwanis Club of Mason. Persons who violate any rule, gain unfair advantage in participating in the Raffle, or obtain Winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing, or threatening behavior is prohibited. The Kiwanis Club of Mason will interpret these Official Rules and resolve any disputes, conflicting claims or ambiguities concerning the Official Rules or the Raffle and the Kiwanis Club of Mason's decisions concerning such disputes shall be final. If the conduct or outcome of the Raffle is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Kiwanis Club of Mason, the Kiwanis Club of Mason reserves the right to terminate this Raffle or make such other decisions regarding the outcome as the Kiwanis Club of Mason may waive any of these Official Rules in its sole discretion. Any attempt by an Entrant or any other individual to deliberately circumvent, disrupt, damage or undermine the legitimate operation of this Raffle is a violation of criminal and civil laws. Should such an attempt be made, the Kiwanis Club of Mason reserves the right to seek civil and/or criminal prosecution and/or damages from any such person to the fullest extent permitted by law.

<u>Miscellaneous.</u> Void where prohibited by law. Odds of winning depend upon the number of Entrants. Winner must submit proof of eligibility and sign the Kiwanis Club of Mason's <u>Declaration of Compliance and Release</u> form to claim the prize. The Kiwanis Club of Mason may substitute prizes, amend the Official Rules or discontinue the Raffle at any time as announced.
