PENNSYLVNIA DISTRICT BOARD OF TRUSTEES MEETING BOARD MEETING MINUTES July 20, 2019

The sixth meeting of the 2018-19 Pennsylvania District Board of Trustees was held on July 20, 2019 at the Kiwanis District office. The following board members were present: Governor-elect Mike Haven, Immediate Past Governor Judy Raub, Trustees Roger Janes, John Mazurowski, Matt Wise, Ben Osterhout, Mike Coolbaugh, Sarah Zulueta and Executive Director Kevin Thomas; Trustee Alice Arnold arrived later in the meeting. Guests included Division 15 Lt. Governor and Builders Club Chair Tiffany Callaio, Past Trustee Judy Janes, and District Administrative Assistant Michelle March. Governor Phil Weber was not able to attend and accordingly the board chose Governor-elect Mike Haven to preside.

The minutes from the April 13, 2019 and May 13, 2019 board meeting were considered for approval (P1-P5). John Mazurowski moved to accept the minutes as presented, Judy Raub seconded, all approved. The Action Matrix from those board meetings was reviewed; see P6-P7.

Mike Coolbaugh made a motion to accept all items in the consent agenda (P8-P39) as presented except the Immediate Past Governor's and the Executive Director's reports which were considered separately later. The motion was seconded and approved.

The Membership Committee report (P40-P52) was presented by Trustee Matt Wise. Currently, we are only at 53% of our membership goal with only a quarter left in the Kiwanis year. We do not anticipate a net membership growth this year and are down 14.5% from 10/1/2013. Sarah Zulueta discussed Club strengthening. Boost materials have been updated and should be distributed to trustees by August. After hosting Regional boost meetings, the next step is to develop metrics to see what the return in investment is and finding ways to hold to clubs accountable to the goals they set. There is a new Club opening effort being focused in Media/Concordville. The Tiger Team will be coming out on Sept. 19 and in addition to the Media effort they will be working on building membership with the West Chester and Upper Main Line Clubs.

A potential dual membership proposal for senior Circle K members was discussed (See P17). Due to questions regarding the two-year dues waiver already in place, it was determined that more questions need to be asked regarding the effect on dues and how the proposal can be rolled out to Circle K members and Clubs.

With the consent of all board members present, the Foundation Report, which was received after other reports were sent out, was entered into the consent agenda reports.

The Audit Committee report (P52-P53) was approved by proper motion, second and vote.

The Finance Committee report was reviewed (P54–P63). Roger Janes added that he reviewed the checkbook for June and found no aberrations. Ben brought up the discussion on the formal issuance and signing of checks – who should sign checks and for what amount should a second signature be necessary. Recommendations will be submitted to the Board before the next meeting. Kevin also mentioned that the committee will need to have developed a budget before the next Board meeting. The report was approved presented by proper motion, second and vote. Seconded and all approved.

The Circle K budget was discussed (P64-P67). Kevin pointed out that the Circle K District Convention lost \$2,281. However, this will not be able to continue as a free-standing event if attendance continues to decline. Kevin also brought up a conflict regarding room cancellations, for which the Sheraton is holding Circle K accountable. It has been requested that the hotel remove the charges or we will look elsewhere to hold our 2021 Kiwanis District Convention. If the issue continues to be unresolved, Kevin is considering taking the Sheraton Erie to arbitration. A motion was made, seconded and approved to accept the 2019- 20 Circle K budget as presented.

Non-Dues Income:

Kiwanis Kash Raffle was discussed. We are substantially off the mark for what had been budgeted, but expenses are also below what was budgeted. A suggestion was made that a page be added to the District Website so that people can order

tickets online. Michelle will do a follow-up email to the Clubs that have not returned their raffle tickets. The raffle report from Chair Jen Vare was, also, reviewed. See P 67.

Unclaimed Property was updated. Everything has been completed, and there is nothing additional to submit. If we do receive everything that was claimed this time, then some of the money can go to the Foundation as well as one of our Clubs. It was suggested that the District keep 5-10% of the returns as a handling fee.

Phillies Kiwanis Night was discussed; see P68. It was suggested that a date be chosen in 2020 so as to not conflict with Officer training and Conventions. It was suggested that the Lt. Governor/Trustee training be moved to May; discussion will be had with the new Governor-Elect regarding this topic. It was also brought up that Jen Gräb is trying to organize a Kiwanis Pirates game at some point in the upcoming year.

Purse Hooks were reviewed. Sarah Zulueta sold some at International Convention and raised \$100. They will be sold at the upcoming District Convention.

Mike Coolbaugh asked if we had a Fundraising Chair/Committee for the District and, if not, he suggested one should be created. Kevin commented that there was merit in the idea.

The two reports removed from the consent agenda were reviewed. The Executive Director's report was discussed; see P 30 He addressed the concern of some that the minutes were not being published within 30 days, indicating that with the justified exception of the January 2019 minutes no minutes in recent years have exceed the 30 day publication time line. A motion was made, seconded and approved to accept the report.

The Immediate-Past Governor's Report was discussed; see P35-P36. The Key Leader concern will be addressed later in the meeting. The Foundation nominating committee was, also, discussed. There are six Kiwanians who submitted applications for the Foundation Board this year. Jeff Rose will be the new President and Janine Surmick the new Vice-President. Kevin suggested that, sometime after District Convention, the District Executive Officers have a conference call with the new Foundation Executive Officers to clarify and set expectations for the year moving forward. A motion was made, seconded and approved to accept the Immediate-Past Governor's report.

It was reported all active clubs have paid dues for 2018-19.

Clubs not submitting an Election Report were reviewed.

Club Leadership Education was discussed. The revised program will have some focus on leadership development and conflict resolution. The sessions will be open to all Club members.

Don Smith of the Kiwanis Clubs of Annville-Cleona and Palmyra Area has declared his candidacy for Governor-elect in 2019-20. At this time, it looks like there will be no other candidates.

Vacant 2019- 20 Lt. Governor positions were reviewed; see P69-P71. Governor-elect Mike Haven encouraged the Trustees to connect at the Club level to be an encourager for potential leadership. The question of re-divisioning in order to better meet club cultural needs was discussed. It was suggested a committee be formed to look at this possibility.

The topic of Enos Martin's candidacy for Lt. Governor was brought up. He has never been a Club President or Secretary and therefore does not meet the bylaw requirements to serve as a Lt. Governor. Mike Haven, Mike Coolbaugh, and Phil Weber will have a discussion with Enos and ask if he would be willing to take on the tasks of a Lt. Governor only without the title. Suggestions were made to call that position either "Lt. Governor Advocate" or "Divisional Advocate". Discussion was had about possibly holding a special convention to amend the bylaws to allow members that have not served as Club President or Secretary to serve as a Lt. Governor. A motion seconded and approved to accept all 2019-20 Lt Governors as shown on P69-P71 with the exception of Enos Martin.

Redivisioning of Divisions 17, 18 and 19 was discussed. The Clubs of Divisions 17 and 18 had met, and all but one Club was in favor of the proposal. Only one Club responded from the Clubs in Division 19. Upper Perkiomen responded that they don't care what division they are in. Kevin suggested that, according to By-laws, the Board could take action on combining

Divisions 17 and 18 and move the Upper Perkiomen Kiwanis Club to Division 19 effective October 1, 2019. Ben Osterhout formally made a motion to do such, and it was seconded and all approved.

The Foundation Nominee Committee Report was reviewed and discussed. See P72-P80.

The 2019 District Convention was discussed. Kevin Thomas asked that the board formally approve the agenda again, as there had been some changes and updates made; see P83-P87. A motion was made, seconded and approved to accept the agenda as presented.

Registrations were discussed. We are currently off the mark for ads but have picked up a lot over the last few days.

A discussion was had regarding event numbers and expectations.

On sponsorships, between the fundraising from the Williamsport club and incoming sponsorships, we have raised \$9300. Our budget goal was \$9,000

For the 2021 District Convention, we have a contract in hand but will not sign it due to the conflict from the Circle K convention. Once resolved, he will either sign or start looking for other bids in Erie.

The 2022 District Convention was discussed. Information has been received on five potential sites. More follow up will have to be done so the board can make a decision. See P88 – P90.

Key Leader Chair Stef Stamatopoulos' report was discussed; see P91-P101. Financial information was, also reviewed. A motion to accept a contract from Camp Conrad Weiser for the 2020 event was seconded and approved. Discussion was had on what attendance number was needed to break even for the event. It was suggested that Stef be consulted regarding Key Leader price points.

An anti-bullying task force was created prior at the April Board meeting consisting of Matt Wise, Mike Coolbaugh, and Mary Dolan. The report of the committee is P81-P82 & P102-P115. Much appreciation was expressed for Mary's help in defining what bullying is and creating levels of resolution and education. The proposed policy addresses the District's need for something to have in alleged bullying situations, and shows that we take a stand against bullying – whether it be a Kiwanian to another Kiwanian, a Kiwanian to an SLP member, etc. Specific recommendations from the task force were reviewed. Matt Wise made a motion that the Board adopt the District anti-bullying policy and the draft of the Club anti-bullying policy and that it be distributed to the Club officers and their membership, pending approval of Kiwanis International. The motion was seconded and approved.

Proposed changes/additions to the District Policy Code in relation to the District Foundation were considered. See P116. A motion was made to accept the proposed policies. The motion was seconded and approved. The policy will be sent to Kiwanis International for review.

The Action Matrix from the June Board retreat was reviewed. See P118-P119.

Mike Haven brought up his Governor's Project for 2019-20 year. He wants to ask that the Clubs participate in donating towards a Make-A-Wish. The goal would be \$250 per Club. There was some discussion regarding potential conflicts with other Kiwanis projects and programs, with the solution being to move forward without dollar amount targets and the effort being clearly branded as the "Governor's Project".

A concern was raised about club grant application notices from the Foundation not going out yet. Judy provided an update on the four grants that had been approved.

With board concurrence, Ben extended a "thank you" to Judy and Sarah for their service on the board.

With no further business to discuss, a motion to adjourn was made, seconded and approved.

PENNSYLVNIA DISTRICT BOARD OF TRUSTEES MEETING BOARD MEETING MINUTES April 13, 2019

The fourth meeting of the 2018-19 Pennsylvania District Board of Trustees was held on April 13, 2019. Governor Phil Weber presided. The following board members were present at the meeting: Governor Phil Weber, Governor-elect Mike Haven, Immediate Past Governor Judy Raub, Trustees Roger Janes, John Mazurowski (on speakerphone), Matt Wise, Ben Osterhout, Mike Coolbaugh, Sarah Zulueta and Executive Director Kevin Thomas. Trustee Alice Arnold was in attendance later in the meeting. Guests included Past Governor, Public Relations and Audit Chair Bob Raub, Division 15 Lt. Governor and Builders Club Chair Tiffany Callaio, Past Trustee Judy Janes, and District Administrative Assistant Michelle March.

The minutes from the January 19, 2019 board meeting were considered for approval. See P1-P2 for the minutes as presented. The minutes were approved as presented.

The consent agenda was considered. Prior to the meeting, it was requested that the Immediate Past Governor's and Executive Director's reports be pulled from the consent the agenda for discussion and possible approval later in the meeting. All other items on the consent agenda were approved by proper motion, second and vote. See P3– P23 for the items approved.

Membership and New Club Building was discussed. Trustee and Membership co-chair Matt Wise led the discussion. Extensive discussion took place on membership growth and the proper approach to take on membership growth and establishing new Clubs. See P24—P31.

The Foundation report was emailed to board members for review by Foundation President Kristina Badali; see P32–P33. The board is still waiting on a formal response from the Foundation about the Unclaimed Properties proposal. Executive Director Kevin Thomas recommended, after talking with Kiwanis International By-laws and Policies Chair Diane O'Brien, that a policy be adopted so that any proposed changes to the Foundation by-laws be approved by the District board first. Governor Phil Weber proposed that Kevin create a draft of the new policy to be presented to the board on the next conference call. There was continued discussion regarding the allocation of money collected from defunct Club foundations.

There was a discussion regarding the Foundation Nominating Committee. There are currently 5 vacancies on the upcoming Foundation board. Governor Phil will work with Governor-Elect Mike Haven and Immediate-Past Governor Judy Raub, and the Past Governor's Association to find additional Nominating Committee members. Governor Phil appointed Judy Raub to Chair to Foundation nominating committee in accordance with District policies and procedures which are on P34–P35.

The board reviewed the Finance report, as submitted by Committee Chair Paul Kasoff. It was noted that this report was issued without the review or approval of the Finance Committee, and therefore could not be represented as the "Committee Report," only that of the Chair. There was discussion about Paul Kasoff's request to step down from the position of Committee Chair. Governor Phil Weber proposed to have someone fill the role temporarily until the end of the administrative year. Trustee Roger Janes volunteered to temporarily fill the role of Committee Chair. Trustee Ben Osterhout volunteered to serve on the Finance Committee to keep the number of committee members at 5. Ben moved that the operating budget and account balances be noted as received. The motion was seconded and approved. See P36–P43 for the Finance Committee report, the account balance report and the budget report.

The 2019 Holiday Party was discussed. See P44 for the Holiday Party Financial report. Kevin suggested that a note be sent to Stef Stamatopoulos for her generous donation of the money that was rebated to her from the event hall.

The Kiwanis Kash Raffle was discussed. All Clubs have received their letter and allotted number of tickets either at the Midwinter conference or via mail.

Trustee Sarah Zulueta provided an update on the purse hook fundraiser; see P45 for an update. It was noted that emphasis needs to be made that this is a District fundraiser. Governor Phil Weber mentioned being approached by a Kiwanian with another fundraiser idea. It was decided that all fundraising ideas should be forwarded to either Sarah Zulueta or the District office.

The Kiwanis Day at Citizens Bank Park with the Philadelphia Phillies on June 22nd was discussed. To date, 63 tickets have been sold.

The incident regarding the traffic accident at the Washington Crossing-Yardley Club was discussed. The families of the three injured children have retained counsel, and the District was so notified by their counsel. Any questions posed by the media or other parties should be directed to Public Relations Chair Bob Raub in the form of a written inquiry. A claim has been established with the Kiwanis International Insurance carrier.

A discussion was had regarding the Audit report; see P46. The results from the 2017-18 year have been added to the report. The IRS form 990 has been filed. Audit Chair Bob Raub requested that the board proceed to put out an RFP for audit and Form 990 preparations. Trustee Ben Osterhout moved that the RFP ask for quotes to see what prices would be for an audit and 990 prep, versus a financial review and 990 prep. Motion was seconded and approved.

An update was provided on Clubs that have not paid 2018-19 dues. At the time of the meeting, only Johnstown and Kingston had not paid.

An update was provided on the new District Website, which is now up and operational.

Executive Director Kevin Thomas requested that the board meeting go into Executive Session and asked that all non-board members excuse themselves until the requested Executive Session was completed. The closed discussion focused on incidences of bullying taking place within the District. A committee consisting of Matt Wise, Mike Coolbaugh and Mary Dolan (of the Kiwanis Club of Elizabethtown) was appointed to come up with a District policy on bullying to define what constitutes bullying and what action will follow where cases of bullying are reported.

Immediate-Past Governor Judy Raub's report, which was removed from the consent agenda, was reviewed and discussed by the board. The report was accepted after review and discussion. See P47-P48.

The Executive Director's report, which was removed from the consent agenda, was reviewed by the board. The report was accepted. See P49-P52.

A discussion was had regarding improving training for District Leadership. Mike Haven, Jen Vare, and Sarah Zulueta will put together a program to be discussed by the board at a later date.

The various open District Leadership positions, primarily Lt. Governors, were reviewed. See P53.

A discussion was had regarding re-aligning certain Divisions to better balance Lt. Governor workload; see P54. Governor Phil has discussed this with Trustee Mike Coolbaugh and Lt. Governors Young Chang (Div 18) and Jen Vare (Div 19) [Note there is no Lt. Governor for Div 17]. After checking the District Policies, a motion was made to waive Article 3, Section C, paragraph 2, sub-paragraph 5 (deadline date of March 1) for this proposal. The motion was seconded and approved. Governor Phil Weber and Governor-Elect Mike Haven will work on getting notifications out to the Clubs in Divisions 17, 18 and 19.

An update was provided regarding Lt. Governor training for the 2019 - 20 class. The training will take place at the Genetti Hotel in Williamsport on Saturday June 15^{th} . A discussion was held on whether the invitation to the training should be extended to Lt. Governor-Elects for the 2020 - 21 class, if they are so identified. The Board agreed to make this extension, citing how it is policy to invite co-Lt. Governors. It was suggested that the Trustee training be held the evening before the Lt. Governor training, at the Genetti Hotel on Friday, June 14^{th} , at 6 pm.

A report was provided on the 2019 Midwinter Conference. See P55-P63.

The future of the Midwinter Conference was discussed. The board reviewed the comments and results of the Mid-Winter evaluation surveys and the report of the Committee tasked with proposing the future direction of Mid-Winter. Trustee Ben Osterhout made a motion that the board accept a proposal from the Penn Stater to host the Mid-Winter Conference for 2020; the motion was seconded and approved. A suggestion was made and accepted to change the name from Midwinter Conference to Mid-Year Conference. Executive Director Kevin Thomas made a motion that the Steering Committee study the alternative Gala suggested in their report and come back with a more detailed plan at the September board meeting, which could be used for budgeting and program purposes. Both motions were individually seconded and approved. The report of the steering committee is P65–P66.

Kevin Thomas made a motion that a committee of three Trustees evaluate the Fall Regional meetings in terms of agenda and efficacy of the Governor's visits and deliver the committee's recommendations to the board at the July meeting. Governor Phil Weber, Governor-Elect Mike Haven, Public Relations and Audit Chair Bob Raub, and Trustees Matt Wise, Mike Coolbaugh, and Ben Osterhout volunteered to serve on the committee. Motion was seconded and approved.

The 2019 District Convention in Williamsport was reviewed by Governor-elect and Convention Chair Mike Haven and discussed by the board. Governor Phil Weber set a Board meeting via conference call on Monday, May 13th at 8:30 pm to approve the convention budget and program. See P66–P67.

The 2019 International Convention on Orlando, FL was discussed by the board. Executive Director Kevin Thomas moved that the board endorse Peter Mancuso of the New York District for Kiwanis International Vice President and that that the board endorse Gary Cooper from the Carolinas District for Kiwanis International Trustee. The motion was seconded and approved, with Trustee Ben Osterhout abstaining.

A discussion was had regarding the upcoming by-laws amendments that will be presented at the 2019 Kiwanis International Convention; see P68– P82. A motion was made that the board support Amendment #1 (Non Discrimination) and Shawn Smith's proposed amendment to that proposed amendment to make the amendment language more inclusive. The motion was seconded and approved, with Trustee Ben Osterhout abstaining. A motion was made that the board oppose Amendment #2 (allowing abstentions when voting for multiple vacancies). The motion was seconded and approved, with Trustee Ben Osterhout abstaining. Governor Phil Weber asked for a motion on Amendment #3 (mandating a gap year). No motion was made. Kevin Thomas moved that the board oppose Amendment #4 (setting aside 1 International Trustee position for a Kiwanian under the age of 50). The motion was seconded and approved, with Trustee Ben Osterhout abstaining. Another motion was made to oppose Amendment #5 (Family discount for International dues). The motion was seconded and approved, with Trustee Ben Osterhout abstaining.

The board discussed a District social gathering at the 2019 International Convention; see the report (P83–P84) compiled by Sarah Zulueta. Executive Director Kevin Thomas moved to proceed with the 'happy hour' suggestion, with the provision that is was financially self-supporting and proved no financial risk to the District itself. The motion was seconded and approved.

Kevin submitted a report on Early Childhood Development that showed the current guide distribution. See P85–P90.

There was discussion about becoming an organizational supporter for Strong Start PA. Immediate-Past Governor Judy Raub suggested that the board review the supplied documents and have a discussion at the July board meeting. This suggestion was accepted.

A discussion was held regarding distributing materials for the PA Department of Treasury's Education Savings Account Program. Trustee Alice Arnold moved that the District help distribute materials regarding this program through its networks. Motion was seconded and approved, with Trustee Matt Wise abstaining. See P91–P92 for more information on this program.

Governor Phil Weber asked that any other Foundation discussion be tabled until the next regular meeting.

A discussion was had regarding the American Red Cross: Sound the Alarm program. Since this information is coming through Kiwanis International itself, Executive Director Kevin Thomas moved that the District share this information with the Clubs. The motion was seconded and approved. See P93-P94.

Proposed dates for the 2019-20 Board Meetings were discussed. After consideration, Trustee Ben Osterhout suggested that the proposed April board meeting be moved to the Sunday following the 2020 Midwinter Conference. This suggestion was accepted by the board. Accordingly, the board will meet in these four dates during the 2019-20 year: September 28, 2019; January 18, 2020; March 22, 2020 and July 18, 2020.

With no further business to discuss, the meeting was adjourned.

Pennsylvania District Kiwanis International Board of Trustees Meeting – Conference Call May 13, 2019

The 2018-19 District Board of Trustees held a conference call to conduct District business on May 13, 2019 commencing at 8:30PM. This was the fifth official meeting of the 2018-19 year.

Governor Phil Weber presided. In addition to Governor Weber, the following board members were on the call: Governor-elect Mike Haven, Immediate Past Governor Judy Raub, Trustees John Mazurowski, Matt Wise, Ben Osterhout, Mike Coolbaugh and Sarah Zulueta and Executive Director Kevin Thomas. Circle K Governor Emily Stoner, ex-officio board member, was on the call. Guests included International Trustees Greg Beard and Richard Olmstead as well Past Governor, Public Relations Chair and Audit Committee Chair Bob Raub.

The 2019 District Convention Budget was presented for approval. See P1. A motion to adopt the budget was presented by John Mazurowski and seconded by Sarah Zulueta. After discussion, the budget was approved as presented without dissent.

The tentative 2019 Convention Program was presented to the board for discussion. See P2. A motion to adopt the tentative program was made by Judy Raub and seconded by John Mazurowski. After discussion, the tentative program was approved as presented without dissent.

A proposal from the Erie Bayfront & Convention Center, Sheraton Erie and the Courtyard by Marriott to host the 2021 District Convention was considered. A motion was made by Judy Raub and seconded by Ben Osterhout to approve the proposal as presented. After discussion, the proposal was approved without dissent. See P3-P5 for a summary of the proposal.

A report was presented on the Foundation Nominating Committee by chair Judy Raub. Judy reported that she believes there are four applications for open positions, two from Kiwanians presently on the board and two from Kiwanians not presently on the board. However, Judy indicated that requests to have the applications sent to her as well as information on the Foundation Webpage changed have not resulted in the appropriate action being taken. Accordingly, Judy introduced the following motion: The District board directs that the foundation, without delay, make the necessary corrections to its website and that the names of any and all interested applications be forwarded to Judy Raub immediately. Kevin Thomas seconded the motion. The motion was approved without dissent.

The District Finance Committee was discussed and reviewed. Efforts to schedule a meeting of the committee will be prompted.

An update was provided on the proposed redivisioning of Division 17, 18 and 19. To date, all the clubs in Division 18 have approved the merger. In Division 17, 3 of the 6 clubs have approved the plan; 3 have not yet responded. So far, Division 19 has not had any clubs responding.

Greg Beard, Dick Olmstead and Emily Stoner all provided comments.

With no further items to discuss, the meeting was adjourned.

July Pennsylvania Key Club Governor's Report

Hello everyone,

I hope everyone has had a wonderful summer so far! The District board was trained in early April and has been serving our District since. Most lieutenant governors have hosted their first Divisional council meeting which included club officer training. This DCM provides attendees with information about our District as well as Key Club international. All DCMs have an emphasis placed on Youth Serving Youth as well as the importance of club communication with their Lieutenant Governors. Lieutenant Governors were able to gather contact information, provide assistance to clubs, and train the 2019-20 club officers. New to this year is a DCM report form that Lieutenant Governors complete following any DCM they host. This allows Lieutenant Governors to reflect on their DCM so they can provide a more educational event for clubs in the future. Committees have been restructured since the 2018-19 term. Instead of thirteen general committees, the number has been reduced to eight. Each Lieutenant Governor has been placed into two committees and will be assigned into one of four District Convention meetings coming later this July. Each committee meets at least once per month via online conference call and communicates through a group message. They have been working towards initiatives that I have set for them this year as well as their own goals. Our Growth and Sustainment committee has been working to ensure that not only is there club and member growth, but also a retainment of current active members. They have been working to reestablish the DOME award for club growth. This award will be an elite honor for only two clubs each year. One will be for member growth per person and one will be for member growth by percentage, so small and large clubs have an equal opportunity to obtain this award. The Kiwanis Family Relations Committee has been working to make an educational graphic featuring a Kiwianis Family Branch to include each month in Lieutenant Governor's newletters. One of the Communication Committee's primary focuses is to tell the importance of communication with Lieutenant Governors to clubs. They're currently working to contact unresponsive clubs in our District in order to establish a reliable contact. This committee also creates our District publication, The Keystonian. This upcoming publication will be released in late July, so keep an eye out! The Executive Committee is currently working on updating our bylaws to reflect the ways we currently work. For example, our bylaws state that award submissions must be mailed to the District

Administrator, but all award submissions are online now. We are also working to add a new policy that prohibits the use of any campaign materials when running for District office.

Personally, I have been working to ensure that all Lieutenant Governors and executive board members have been actively helping their respective clubs and our District. Each month I create a monthly report, so I can stay updated on their work. In addition to sending out monthly updates and multiple emails, I have held progress calls with all Lieutenant Governors at least once, have had several calls with my executive board, and have attended various committee meetings. In late May, I distributed my Governor's Greeting to the entire District. I have filled out all forms required by Key Club International and I have worked closely with my trustee. I recently had the honor of being one of three members of the International Elections Committee, which provided me with a wonderful learning experience that I hope to use to help our District. The District recently attended International Convention in Baltimore, MD, which was a wonderful learning experience for everyone in attendance. Congratulations to our Immediate Past Governor, Margaret Karpinski, for being named Distinguished Governor! The Key Club District Board will be meeting July 27th-28th, and we are ready to continue serving our District as well as our homes, schools, and communities!

Hello everyone!

I thought that I would give you a quick heads up on a few items that were passed on the Circle K side of things. All items are subject to Kiwanis board approval. I do not have the exact final wording yet but I was told that the amendments passed (with a few amendments to the amendments). I figure you could use a quick heads up before my formal board report. This way, if you need additional information or have questions - I can get it ready for it!!!

First - Multi-school clubs can be formed upon a process that included approval from the Circle K Board of Trustees. There was pre-HOD discussion about how long the multi-school club can stay together and numbers so I am not sure on what passed there. This should allow for some schools in close proximity to form up.

My opinion is that this is a quick band aid to get a quick burst in membership. There will be issues in meetings, projects, promotions, and identity - let alone distribution of school resources.

Second - Students approved dual membership upon graduation. So student will be allowed to join Kiwanis upon their graduation (if they are not going to another school).

My opinion is that there is a lot to still be worked out but the door is open for a lot of new things. Many CKI students are ready to join early - but are their prospective clubs ready to take them in. Next would be dues payment - I wouldn't like to see the student's loose a full year of dues reduction for 4-5 months. But that is a different battle.

The things that I like about it is that we can keep some of the talent that gets lost during transition. Typically, once the graduating students leave Circle K DCON - they are looking to their future and other things find ways to fill in time that was used for K-family. Now, K-family does not have to be on hold.

This should allow the Kiwanis Membership team to send representatives to the PACK DCON to help start the transitions to a Kiwanis club. Graduating student could join and go to Kiwanis DCON - I feel that you may need to add some sort of gathering for recently graduated senior (maybe a gathering -in the very least a special invitation). It may also help to give a group of recruits to help make those final pushes at the end of the year.

To put this a bit more into reality - Past Governors Miranda and Devyn could be in a Kiwanis club now and making plans to attend their nearby Kiwanis DCON.

For the last three years our Youth Serves Youth (YSY) project has been Early Childhood Learning (ECL). The participation level by clubs is less than what we would like it to be. It is my assessment that this board does not fully understand ECL and therefore does an inadequate job at properly promoting the program. Further education

of our current board needs to be conducted and will be done at the upcoming summer meeting. However, in order to bolster our YSY program, we are currently looking for something different. ECL will still be promoted as an active Key Club program and a way to build K Family relations. Clubs participating in the program will still be acknowledged with awards and recognitions. The district board will be meeting with representatives from ChildFund International. This group has been working with several other Key Club districts. Their program looks very interesting and I believe it will be embraced by our members. Throughout this administrative year we will be identifying 10 to 15 clubs to serve as a pilot program to see how well this is received. If beneficial, we will be introducing it as our YSY for the 2020 – 2021 administrative year.

At this past international convention, the delegates past a wide range of amendments to the bylaws. Most concerning, to me at least, is a motion that passed removing the name God from the pledge and replacing it with "world". It is my understanding that the K.I. board needs to approve this change. Our District board may want to discuss to option of formally opposing this change and petition the K.I. board to strike down this change.





Region-by-Region Review

We thought it important to provide the board with an update of our Regional activities across the district over the past several months. We know that the Board members are aware of what is happening in your respective Regions, but we thought that sharing the thoughts, ideas, and progress would help spur further conversations.

Region 1: Division One has had a lot of support from some ladies from the Fort LeBoeuf club. Valerie Rose and Yvonne have been taking their show on the road in division one and their ideas are being well received. However; we believe there needs to be more sense of urgency on growing the clubs. We have clubs that have been strong for a long time that are stating they want to grow, however; they are not putting in place action steps to promote their club to entice prospects to join their club. More coaching may be needed.

A new plan is in the works to develop improved boosting strategies for the Region. We will begin working on this with the Fort LeBoeuf club, Val Rose and LTG Randy Gorske. We are hoping it will get a lot of response from the clubs. This is going to take quite a bit of forward thinking on our part.

Summit Kiwanis has some potential new members and they have been invited to projects to further encourage their membership.

There have been challenges in Division Two in terms of communication and committing to a solid growth plan. There does not seem to be much participation byt calls are being planned to continue coaching efforts.

Region 2: This Region participated in Pittsburgh's Pride event which provided an opportunity to brand Kiwanis in the LGBTQ community and meet with prospective members while doing a service project at their table. An interest meeting on Saturday July 20th at Fudge Farm in Pittsburgh inviting prospects that signed up to learn more about Kiwanis at Pride. Barb Byers and Shawn Smith are working to strengthen several clubs through their efforts. There was much follow up from the Pride event which will surely garner additional members to surrounding clubs and possibly a new club with a single focus to support the LGBTQ community.

Region Two has put a lot of thought and planning into this event and truly are thinking outside the box. This event has really got many from Region Two motivated about membership.

Barb, Shawn, Marianne and several others have been instrumental in making this all come together.

Region 3: The Nittany Club was encouraged by the Regional Meeting as well as the Mid Year Convention and have discussed their ideas to strengthen membership. Matt is working with the Bellefonte club on how to strengthen their membership.

Cathy has been working with LTG Barb Harer who has been a truly bright star this year in Division 11E. She has some great ideas and her work with the clubs on membership is well respected. I believe she should be on the membership committee for next year.

The Juniata County Club is working hard on membership and with the help and direction of Alice they have some plans in place to grow their membership. LTG Barb Harer was instrumental in an amazing membership night for the Lewistown club and they gained several new members from that evening as well as many prospects.

There is a huge need for the existing clubs to grow in this area and if we could find additional people to help fill the void we could see this area grow.

Region 4: Over the weekend, the Bald Eagles and Nittany Valleys club had a discussion about a potential for either a new club or a satellite in the Renovo Area, we will be revisting this option with them in the future.

Prior to the start of this year, we had discussed the concern that for the entire Williamsport area, there is only one club option that meets at noon every Thursday. Without any other meeting and service opportunities, it begs the question as to whether or not an additional offering should exist. After District Convention, a conversation with Williamsport club board and members will need to take place about how to move this forward.

Region 5: A new coach for the new club Southern Lancaster and Linglestown will be needed with the Raub's moving to Ohio. Greater York had a successful charter ceremony on June 7th and coaching for the first year will be handled by Emily Reed and Ryan Hartman, who are charter members of the club. No new club sites are planned for Region 5. Region 5 is having a Boost Workshop on August 24th in Dillsburg.

Region 6: A new club in Bethlehem is on hold due to lack of sponsorship. This effort will be revisited in the Spring 2020. Survey results from the recent Club Boost Workshop were very positive. Matt will work with Trustee Mike Coolbaugh and LTG Tiffany Callaio to follow-up with the clubs on their progress of their commitments made during the boost.

Mike Coolbaugh and Tiffany Callaio reported that the Kiwanis Club of Laflin (Wesley Village) needs to be revamped. They have offered recommendations to the club and waiting to hear back from them on their plan.

Kiwanis Club of Back Mountain is still going strong. They are doing a lot of service and the members are enjoying the service projects. They are planning on holding a one year celebration in September. Mike will keep us all updated on the date for that.

Region 7: A new club opening event for 2 Communities are planned for Media and Concordville in Delaware County. The New Club Opening event is set for September 9th week with KI Tiger team. Facebook pages for both sites are set and the Interest meetings start for Media on 7/25 and the following week for Concordville. The sponsoring clubs will benefit from these club opening events as we plan to strengthen and have appointments for the sponsoring clubs which are Upper Main Line, Main Line and West Chester.

Active coaching is being conducted with South Philadelphia, West Chester and Main Line. Upper Main Line will look to be revamped as they just lost another long time member to death so they are really down to three active members although there are more names on the roster.

Orlando Membership Coordinator Training

Governor Elect Mike Haven, Sarah Zulueta and Valerie Rose attended Membership Coordinator training in Orlando at ICON. It was a rewarding experience and Sarah has developed a generic Boost Book, which is based off West Virginia's efforts, presented at ICON and will be decimated to all District Membership Coordinators through International.



District Audit Committee Report to the District Board

July 29, 2019

At the last District Board meeting, the Audit Committee received approval to solicit proposals from CPA firms to conduct an annual audit, or possibly a review, for the Kiwanis year 2018-2019. Additionally, the proposal should include the preparation of the IRS for 990 for the same year.

Members of the Board expressed a desire to extend our solicitation to CPA firms outside the immediate Harrisburg or central PA area to possibly take advantage of less expensive professional services rates in these other areas. The Audit Committee chair specifically requested members who were aware of CPA firms capable of doing work for non-profits such as Kiwanis to let the committee know of the name and contact information. A reasonable response date was established and no information was forthcoming regarding these "other firms."

Additionally, the board requested that our solicitation include language to obtain a proposal for a "review" rather than an "audit" as the cost should certainly be less than that for a full audit. The committee consider the "review" question a year ago and did not pursue obtaining proposals for a review, because in the committee members' understand of the review, such an effort would rely on the District's ability to provide good quality financial reports such as a year-end balance sheet, profit and loss statements and other documents that reflect a good understanding of accounting principles. After several years of professional audits provided by RKL, the District has not provided the Board with periodic balance sheets and profit and loss statements as recommended by the auditors. Without the ability to create these financial statements, it is the audit committee's belief that a "review" would fall well short of the financial inspection and recommendations needed by the Board to continue to attempt to make progress toward fiscal responsibility and being able to have proper documentation with which to make sound financial decisions.

However, as directed by the Board, the solicitations that were prepared and sent to 4 CPA firms for their consideration include a proposal to do an annual review t=rather than a full audit. The proposals should include commentary about the differences between the two approaches and the advisability to conduct one or the other.

Requests for proposals (RFPs) were sent to:

Brown, Smith Sheridan, and Fritz in Harrisburg
GIFT CPAs in Harrisburg

RKL in York, and

Smoker Smith and Associates in Hershey

Proposals were requested to be submitted to the Audit Committee Chair through the District Office by August 21, 2019. This would provide time to review and provide a recommendation to the Board at its September/October meeting.

With the Board's concurrence, the Audit Committee will follow up with the listed firms to insure that any questions are answered or requests for documents are fulfilled so that they can prepare proper responses to our RFP.

The Audit Chair, Bob Raub, will not attend this board meeting because of a conflicting Division Council meeting held at the same time. Any questions can be handled by telephone or email.

Finance Committee:

You will find the Financial Reports for June 2019.

Largely with the exception of convention, the raffle, some new member fees and little bit of dues revenue, our revenues are largely collected.

I am concerned about convention, particularly in area of attendance and ad sales. However since we have minimal concerns as it relates to attrition, I think we should be alright if we get attendance up and can reach our goal for ad sales or come close to it.

However, the raffle is a bigger concern. We have a large gap between where we are and where we want to be. A recent inquiry I made about a raffle update and promotion activities went unanswered. While we can expect more raffle revenue to come in, I am concerned we will miss our projection considerably as I see things now. Now if there is any upside to that, it is that our expenses will be below projection too. We all need to get involved in this raffle in the way of promotion and sales.

Even with that, it would be my expectation that our revenues and will exceed expenses for the 2018-19 year. But given the uncertainty outlined above, I am not prepared to give you any projection about amounts or margins.

Shortly after the District Convention, the Committee should meet to discuss two points. First, we will need to prepare a budget for 2019-20. Second, we should discuss the best options available to us for managing cash flow till dues revenue starts coming in November.

We will talk with you this evening.

It is surprising to people, but this is my 16th year in Kiwanis. I joined the Hershey Hummelstown Kiwanis Club in 2003 and when I decided to stay in Pittsburgh after college, I joined the Sheraden Kiwanis Club. While a member of the Sheraden Kiwanis Club, I participated on 2 District Convention Host Committees, held the title of International Convention Chair for the Pennsylvania District, and have presented several forums at Pennsylvania District Conventions. As a member of the Sheraden Kiwanis Club, I have chaired our annual Easter Egg Hunt, annual rose sale, sat on our Board of Directors, was named the 2011-2012 Sheraden Kiwanian of the Year, and currently serve as President. I have attended countless Mid-Winter conventions, District Conventions, and International conventions.

Through my attendance at various Kiwanis Family events, I have developed an understanding of Kiwanis, and how the Foundation works. I have attended countless Foundation forums and luncheons at Kiwanis conventions, both District and International. Both of my parents served terms as Governors of Kiwanis, and both have served on the Foundation Board. Through them, I know what is expected of me to serve as a Foundation Director and the expectations I have for myself to ensure that I am contributing to the Foundation.

I am capable of holding a position on the Foundation Board because of my extensive Kiwanis experience. Specifically, my experience with one of the foundation's main fundraisers, the rose sale. For the last few years, I have co-chaired the Kiwanis Club of Sheraden's rose sale. At the most recent Kiwanis convention in Las Vegas, I tagged along with current Pennsylvania Foundation President, Kristina Badali to the Kiwanis Children's Fund presentation. This experience gave me several ideas that can be adapted for use by the Pennsylvania Foundation. Those ideas include: focusing on the individual stories of clubs who receive grants, how best to highlight the work the Foundation does to assist clubs to increase the mission or scope of specific projects they lack the funds for, and how important it is to have a diverse board.

If you ask any Kiwanian if they have a love of service, most if, not all will enthusiastically say yes. As a Foundation Board member, I would hope to use the Foundation as a catalyst to increase that love of service so what we may continue to increase our service to the children in Pennsylvania. This is why I should be elected to the Pennsylvania Foundation Board of Directors.

- Celebrate the foundation's upcoming 40th anniversary with a signature event.
- Provide Kiwanis Clubs easy social media plans to use around their rose sale to increase impressions with their social media
- The Development of a quarterly e-mail newsletter outside of the Keystone Kiwanian, advertising the Foundation, highlighting its efforts, and updating the Kiwanis membership on what the foundation has accomplished.
- This isn't really innovative, but I would like to see the Foundation develop a social media plan to tout our successful club grants, top rose sale clubs, really just an expanded social media presence specifically on Facebook.

My Kiwanis roots run deep and go back 23 years to when I was only 14 years old. I was a 4-year Key Club member at Reynolds High School (2 as president); 3-year Circle K member at Pitt-Greensburg (2 as president); and have been a Kiwanian for 13 years (2 as president). I lead with this information, because I think my personal experience growing up as part of our service leadership programs helps me understand a lot about our organization. It's one thing to talk about our service leadership programs, but it's another to be able to speak from experience. My love for Kiwanis runs deep.

Today, I am the club and Kiwanis advisor to the Circle K Club at Pitt-Greensburg, where I work, and to the Circle K Club at St. Vincent College in nearby Latrobe. I have spent a great deal of time over the past decade working closely with college students who are passionate about service, whether it be through Circle K or in other capacities.

I have experience serving a stint as a Lt. Governor; and I have volunteered at Key Leader events. I have helped charter a new Circle K Cub. Contract

We have received the contract from South Mountain YMCA Camp, the property managers of Camp Conrad Weiser. The dates presently reserved are April 24-26,2020. Our angel donor is willing to provide the financial guarantee for this year. We would ask that the District Board please approve the contract so that we may publish the dates and start promoting Key Leader 2020.

Registration Software

We will be examining new registration software for 2020. We have reached out to other Districts to determine if there is a software that simplifies the registration/payment process as well as the other logistical elements such as assigning students to cabins and neighborhoods (small groups). The system that the District currently uses for other District events, PortalBuzz, will also be included in this consideration.

District Chair

We continue to work to identify a District Chair. At this time, Stef Stamatopoulos is willing and able to continue to serve in this capacity with the support of her committee for regional speaking engagements, etc. Most of the communications are completed via phone/email which she has completed from New York for the last three years.

Key Leader Board Report Addendum

A copy of the Immediate Past Governor's report was received from the District Secretary on July 16* to allow for response to concerns regarding the Key Leader program. (cc:ed Governor and Governor-Elect)

In response to that report, we would like to share the additional information:

Suggested Overstated Registrations

There is no benefit to the program to overstate registrations. It would result in us turning down students that are interested in attending. It would also put our angel donor at greater financial risk. When registration numbers are shared, they are accurate.

Event Space - Meeting Room

The camp reserves the right to place groups in different facilities to meet the demands of the groups on property. While we plan on returning to the larger event space, The Wigwam, in 2020, the smaller hall did not make this year's Key Leader experience any less impactful on our graduates. As the report reflects, 42 attendees were first time attendees and would have no knowledge of the additional space.

As a general note, there are always other groups on property at the time of Key Leader. Over the years, these groups have ranged from outdoor adventure clubs to church youth groups to live action role players. Many years, the camps annual bike race also takes place on the same weekend. The District Chair met with the camp staff and the leader of the other group on property to ensure that both groups were respectful of each other's assigned space. These guidelines are also reviewed with our students during our welcome message, prior to breaks, and before we return to cabins for curfew.

Event Space - Cabins

As previously mentioned, the camp reserves the right to place groups in different facilities to meet the demands of the groups on property. On property, there are four different villages, each containing 6 cabins. We are assigned to two villages – one for males, one for females. The villages are all within walking distance of the meeting rooms. They are all accessible by vehicle and fully ADA compliant. We commonly are assigned the two villages on the east of the mountain, this year we were assigned to the west of the mountain (meeting rooms are at the top of the mountain). However, the cabins themselves are identical – 14 bunk beds, thermostat-controlled electric heat, and plenty of outlets for cellphone charging. Prior to this year, 2014 would have been the most recent year that we used the cabins on the west side of the mountain.

"Disheveled" Appearance

Per the structure of professionally-designed, National Association of Secondary School Principals (NASSP) gold-seal sanctioned Key Leader curriculum, 30 team-drawn posters are hung on the walls. These posters represent each neighborhood's team identity, their vision of the perfect Key Leader, and an action plan for a service project. These neighborhoods are an essential element of the Key Leader learning experience. They are led by a student who has graduated from the Key Leader program and allow each attendee to have a voice and make meaningful contributions in a peer setting.

Each student also hangs decorated lunch bag as a mailbox where they can receive notes of encouragement from other attendees. The walls are busy, but with elements designed to give attendees a strong feeling of belonging and inclusiveness.

With 59 students in one space for over twelve hours, the room is full of hoodies, reusable water bottles, workbooks, and markers. Neighborhoods are required to maintain the space and at no time did the lead facilitator, the camp staff, or the Key Leader committee allow the space to become unsafe.

We have dedicated adult volunteers that ensure that our snacks and beverages are well-organized and properly handled. We also have adult volunteers that manage materials and supplies. It's a busy learning environment with a lot to accomplish in less than 48 hours.

Event Contract

When the District Chair reached out to the camp to provide the final attendee count in April 2019, it was determined that there had been an error with the 2019 contract. This year represented the first year that the contract should have gone directly to the District versus to Kiwanis International. Two requests for this contract were made by the District Chair in 2018, one in April and a second in August. However, the contract was never sent by the camp. The camp took full ownership of this error. In fact, the Director couldn't believe that he had missed it. As he is a member of the Kiwanis Club of Greater Reading Berks County, he had been discussing sending students to Key Leader for months. The club had six students from two different schools attend this year.

In looking for ways to ensure that this does not occur moving forward, the District Chair took full ownership of having not clearly notified the District office to anticipate receipt of this document. Given that the District had never received a copy of the contract during the last 14 years of the program, it was not a document that was noted as not received.

The South Mountain YMCA staff worked diligently with us to ensure that all of our needs for meeting space, cabins, meals, and ropes course were meet. As you haven seen in the original report, the 2019 contract has been received.

Communications

The Key Leader committee would ask that if any Board members or Kiwanians have concerns regarding the program, that those concerns be brought to the immediate attention of the District Chair and Governor. Waiting nearly 90 days and submitting a report to the board containing these concerns without any notification of the District Chair undermines the sense of team and open communication that this year's District Board has worked so hard to foster.

Thank you for allowing us to address these concerns.

Anti-Bullying/Anti-Harassment Task Force Report to District Board 7/20/2019

Task Force Members: Matt Wise, chair; Mike Coolbaugh, Mary Dolan.

The task force has met four times to discuss the policy development and additional recommendations. Below you will find an overview of our discussion to-date.

Discussion and findings:

- If there is no policy, then we, as a District, will not have anything to reference in dealing with bullying behavior both adult-to-adult and adult-to-youth.
- It is important that we adopt a policy that takes a bold stand against bullying behavior as it will only benefit the club climate and environment and, therefore, the member experience.
- We are seeing an influx of a new generation of young people who have been educated on bullying. They expect organizations to have a strong stance against this behavior as well as a procedure dealing with it.
- We know first hand of incidents where members have resigned their membership due to bullying behavior.
- Kiwanis International, at the 2019 International Convention in Orlando, Florida, has adopted a "Safe Kids Resolution" reassuring us that "Kiwanis International stands against violence, neglect, and abuse directed towards children."
- Any policy that is developed would have to be for District Officers, Chairs, Administrators, and staff.
- Kiwanian-to-Kiwanian presents a different issue than Kiwanian-to-youth bullying, therefore it is imperative that any of the consequences be tied back to existing Kiwanis International policy.
- The idea of keeping this under the Conduct Unbecoming policy and doing more education around this is important. When something like this (adult-to-youth) comes to the District Board, then you can point to the policy which points to the "discipline".
- Adults don't often see their behavior as bullying (i.e. I'm just assertive, etc.). On the level that is not elevated to the point that is at the Pennsylvania Crimes Code, adult-to-adult bullying is very toxic to any organization.
- This is why it is important that we educate members that we should treat each other with respect, civility, etc. The best thing to do is to turn to Gary Naime's work on workplace bullying. There is a difference in bullying/harassment and conflict. The issue is that you cannot address it the same as in the workplace (no HR, etc.).
- The Centers for Disease Control (CDC) has a broader definition of bullying. The PA Crime Code has a definition of Harassment that does not necessarily sound like bullying. At a certain point, the behavior crosses the line from "mean" to actual harassment. From a Law Enforcement background this would have to be on a case-by-case basis as to what actually happened, since generally harassment is a summary offense.

Recommendations:

- The District needs to address Kiwanian-to-youth inappropriate as well as Kiwanian-to-Kiwanian inappropriate behavior.
- The District should adopt an anti-bullying policy (draft attached).

- The District should recommend a similar policy for clubs to adopt as part of their governance package (draft attached).
- The District should develop education on appropriate behavior conduct that is becoming a Kiwanian (i.e. Pro-social interaction, healthy relationships, communication, respectful behavior, inclusivity, and other soft skills). Several ways to approach this is through Club Leadership Education, Leadership Retreats, Handouts, Workshops, and Webinars for members. The message should be spun in a positive way that illustrates the District's commitment to supporting a positive club culture, climate, and interactions among each other, our youth, and our partners.
- Develop a process at the District level in which the adopted policy(ies) are openly discussed between the District Board and the Sponsored Leadership Program Administrators.
- Identify any exposed risk of such policy adoption through consult of pro bono legal counsel.

The Pennsylvania District of Kiwanis International is committed to supporting an environment of respect for others where initiatives and projects to help improve children's lives can be created and implemented.

We do not tolerate bullying at any district sanctioned event, board meetings or club events. We will promote an atmosphere that exemplifies behavior that is becoming of a Kiwanian. Members involved with Sponsored Leadership Programs are expected to treat youth in the same manner the adult members are expected to treat one another.

Any member who feels they are a target of bullying behavior or any member witnessing bullying should report the concerns to the Governor or designated person or committee.

Definitions of Bullying

- 1. Whereas, a person is being bullied when he/she is exposed, repeatedly and over time, to negative actions on the part of one or more other persons. Negative action is when a person intentionally inflicts injury or discomfort upon another person, through physical contact, through words or in other ways. (Dan Olweus, Researcher, University of Bergen, Norway)
- 2. Whereas, according to the Center for Disease Control (2018), bullying is defined as "any unwanted aggressive behavior(s) by another youth or group of youths, who are not siblings or current dating partners that involves an observed or perceived power imbalance and is repeated multiple times or is highly likely to be repeated. Bullying may inflict harm or distress on the targeted youth including physical, psychological, social, or educational harm."
- 3. Whereas, other examples of bullying (adult-to-adult, adult-to-youth, youth-to-adult and youth-to-youth) include but are not limited to:
 - Cyberbullying: Posting unkind words or pictures via the Internet including social media, email, text messaging or any other form of electronic communication.
 - Humiliating a person publicly by pointing out mistakes, characteristics, etc.

Procedures:

It is very important to note that mediation or other restorative practice approach should **only** be utilized if the target of the bullying behavior would like to utilize such method. The alleged perpetrator has the right to submit a written rebuttal to the original report. The Governor, designated person, or committee is not in a position to decide upon guilt or innocence. The goal is to move the members to an agreed solution.

Consequences:

If the behavior does not cease after the intervention, the district will proceed under the defined process for "conduct unbecoming a member of the Kiwanis family" for next steps. If behavior is believed to be criminal in nature, the appropriate authorities will be notified.

The President, designated person, or committee should also notify the Pennsylvania District Executive Director and/or Governor at the beginning of this process. It is very important to note that mediation or other restorative practice approach should only be utilized if the target of the bullying

behavior would like to utilize such method. The alleged perpetrator has the right to submit a written rebuttal to the original report. The President, designated person, or committee is not in a position to decide upon guilt or innocence. The goal is to move the members to an agreed solution.

Consequences:

If the behavior does not cease after the intervention, the district will proceed under the defined process for "conduct unbecoming a member of the Kiwanis family" for next steps. If behavior is believed to be criminal in nature, the appropriate authorities will be notified.

11. Definition of 'Conduct Unbecoming'

A. Conduct Unbecoming a Member of the Kiwanis Family (4/13)

"Conduct unbecoming a member of the Kiwanis family" is defined as any conduct that: (4/12)

- Is incompatible with the best interests of the public or of members of the Kiwanis family; or (4/12)
- Tends to harm the standing of Kiwanis in the local or global community. (4/12) Note: For conduct unbecoming purposes, the Kiwanis family is defined in the Kiwanis International Bylaws as members of Kiwanis clubs, Aktion Clubs, Circle K clubs, and Key Clubs. (4/12)

B. Conduct Unbecoming a Kiwanis International Officer (4/13)

In addition to the basic definition of 'conduct unbecoming a member of the Kiwanis family' as shown above, the definition is expanded for Kiwanis International officers (Kiwanis International Board Members and District Governors) to further include any of the following offenses committed while serving in office: (4/12) (4/13)

- 1. Engaging in profanity or making derogatory statements or engaging in offensive behavior based on race, color, gender, age, disability, economic status, religion, or national origin. (4/12)
- 2. Engaging in unwanted touching at any time. (6/99)
- 3. Creating a hostile atmosphere. (6/99)
- 4. Being convicted of any felony or misdemeanor involving moral turpitude. (4/12)

12. Club Member Accused of 'Conduct Unbecoming'

- a. If an allegation of 'conduct unbecoming a member of the Kiwanis family' is made against a member of a Kiwanis club, the member's club shall follow the process generally described below, as further defined in Kiwanis International procedure. If the member belongs to more than one club, the club associated with the 'conduct unbecoming' shall act. (10/12) (4/13)
- b. The president of the club (or immediate past president, if the president is accused) shall immediately request from Kiwanis International a copy of the detailed procedures to be followed by the club and shall appoint a special investigator who will conduct an investigation and produce a report summarizing the findings. The Board shall consider the investigation report and determine whether to hold a hearing on the matter. The President shall notify the accused member of the investigation results and whether the Board intends to pursue the allegation(s). If a hearing is held, the Board shall then meet and report its decision whether the accused member did or did not engage in 'conduct unbecoming' and, based on that decision, the appropriate disciplinary action, if any, as follows: informal counseling, a verbal reprimand, written reprimand, suspension from office or club membership, or removal from office or club membership. The determination of the discipline should be based on the seriousness of the unbecoming conduct. All disciplinary actions shall be documented in club records. (10/12) (4/13)
- c. If the accused member is also a district officer or a Kiwanis International officer and the 'conduct unbecoming' appears to have been committed in his/her capacity as an officer, or if it is impossible to determine in what capacity the 'conduct unbecoming' was committed, the matter

CLUB PROCESS FOR 'CONDUCT UNBECOMING'

Kiwanis International Policies, which are determined by the Kiwanis International Board, define 'conduct unbecoming' as follows. Be aware that clubs (or districts) do not have the option to adjust this definition in any way.

Conduct Unbecoming a Member of the Kiwanis Family (4/13)

"Conduct unbecoming a member of the Kiwanis family" is defined as any conduct that: (4/12)

- Is incompatible with the best interests of the public or of members of the Kiwanis family; or (4/12)
- Tends to harm the standing of Kiwanis in the local or global community. (4/12)

Note: For conduct unbecoming purposes, the Kiwanis family is defined in the Kiwanis International Bylaws as members of Kiwanis clubs, Aktion Clubs, Circle K clubs, and Key Clubs. (4/12)

344 - CLUB MEMBER ACCUSED OF 'CONDUCT UNBECOMING'

344.1 - Allegation and Investigation (4/13)

A. Allegation: If any club member observes or has knowledge of* behavior by another club member that he or she believes constitutes 'conduct unbecoming a member of the Kiwanis family,' as defined in Kiwanis International policy, the member shall report such allegation in writing (hereinafter referred to as the "Allegation Report") immediately to the president of the Kiwanis club to which the accused member belongs. (10/12) (4/13)

However, if the president is the subject of the allegation, then, throughout the entire 'conduct unbecoming' process, whenever it is stated that the president shall normally act, the immediate past president shall act instead. (10/12) (4/13)

The allegation report shall include as much detail as possible regarding the time, place, persons, actions, etc. (10/12) (4/13)

- *Note: "Has knowledge of" may include a nonmember making a club member aware of behavior or actions by another Kiwanian, in which case, such allegation shall be submitted via the club member who has been made aware of it. (10/12) (4/13)
- B. Capacity: If the accused member is also a district officer or a Kiwanis International officer and the 'conduct unbecoming' appears to have been committed in his/her capacity as an officer, or if it is impossible to determine in what capacity the 'conduct unbecoming' was committed, the matter shall first be submitted to the Kiwanis International President or the district governor, in that order, as appropriate, who shall determine the capacity and either begin an investigation at the International or District level or refer it back to the club level to investigate and decide. If the President or governor alone is unable to clearly determine the capacity of the allegation, he/she may

consult up to two fellow officers as deemed necessary. (4/13)

- C. Allegation Process: Upon receipt of an Allegation Report, the president shall follow the steps outlined in this procedure. (10/12) (4/13)
- D. Investigator: Also within seven (7) days of receiving the Allegation Report, the president shall appoint a special investigator, which may be a single individual or a committee (hereinafter referred to as "the Investigator"). The Investigator shall be composed of disinterested club members (that is, those without bias on the allegations or for/against the accused member personally) and shall not include any members of the club board of directors. In the event the president believes no club member has the necessary skills or lack of bias to adequately investigate the subject matter, the president may select a non-club member or non-Kiwanian as the Investigator. If the Investigator charges a fee for his/her services or if the investigation itself involves some costs (such as fees for requesting records, etc.), then such fees/costs must be approved by the board. The Investigator will represent the club throughout the entire investigation, determination, and discipline process, and appeal if any. (10/12) (4/13)
- E. Investigation Process and Initial Notice: Within fourteen (14) days after being appointed, the Investigator shall endeavor to gather enough information to determine if the allegation is substantive enough to warrant investigation. If so determined, the president or designee shall send written notice to the accused member of the allegation, a copy of the process to be followed, and the possible outcomes, and the investigation shall continue more fully, including a reasonable attempt to interview the accused member and other relevant persons. (10/12)
- F. Investigation Reports: The Investigator shall provide a progress report to the president within thirty (30) days of appointment. A final written report of the Investigator's findings (hereinafter referred to as 'the Investigation Report') shall be made by the Investigator, signed by all persons who comprise the Investigator, and submitted to the president within 30 days after the initial progress report (no later than sixty (60) days after the appointment of the Investigator), unless there are extenuating circumstances. The Investigation Report shall include an outline of the investigation as well as (1) whether the investigation finds in favor of the accused; or (2) whether the Investigator finds the matter can be resolved without a hearing; or (3) a recommendation of the charges and related specifications to be made against the accused member. (10/12) (4/13)
- G. Charges and Specifications: A charge sets forth the general offense the accused member is alleged to have committed. A specification states specifically what the accused member is alleged to have done which, if true, constitutes an instance supporting the charge. Charges and specifications must be carefully worded to make no broader allegation than intended or can be supported. An accused member must be found 'guilty' of at least one specification in order to be found 'guilty' of the related charge, and an accused member must be found 'guilty' of at least one charge before a penalty can be imposed. (If necessary, refer to Robert Rules, Section 63 Investigation and Trial, for more information and examples of charges and specifications.) (10/12)

344.2 - Disclosure and Confidentiality

- A. During Investigation: During the investigation, the president shall not disclose any information regarding the investigation to the public or to any other member of the club, including the club board, until the investigation process is complete, except that, the president may report to the board only that an allegation has been received and an investigation is being conducted, without disclosing the name of the accused member or any details of the investigation. (10/12) (4/13)
- B. After Investigation: Once the investigation is complete, the president may disclose information regarding the investigation only to the board for a hearing on the matter (and to any club staff who has a need to know), but not to the public or to any other member of the club. (10/12) (4/13)
- C. If Appealed: In the event the final determination by the board is appealed to the club membership, then information can be disclosed to those members who attend the appeal meeting, subject to the obligation of those club members to keep the information confidential. (10/12)
- D. General: All materials, facts, and information related to the investigation, determination, and appeal (if any) shall be kept confidential at all times by any parties or persons involved in any part of the process. The person presiding over each step should remind all participants of the need to maintain confidentiality. (10/12)

344.3 - Criminal Wrongdoing

If at any time during the investigation, the Investigator discovers criminal wrongdoing or what appears to be criminal wrongdoing, it must be reported immediately to the president, who is then obligated to report the matter to the proper authorities. If the president does not act, then the Investigator is obligated to report the matter to the proper authorities. In any case, the process regarding conduct unbecoming shall proceed to conclusion. (10/12)

344.4 - Resignation

An accused member may resign at any time during the conduct unbecoming process, and the club may or may not accept the resignation; however, after investigation, charges and specifications are made against the accused member, then the club is obligated to continue the hearing, determination, and discipline processes through to completion. (10/12) (4/13)

344.5 - Board Hearing

- A. Referral to Board: After receiving the Investigation Report, the President shall refer it to the club board to determine whether to proceed with a hearing. A special board meeting for this purpose shall be held within seven (7) days after the matter is referred to the board, and shall be conducted in executive session (i.e., closed to non-board members). (10/12) (4/13)
- B. Notice of Hearing: Within seven (7) days after the special board meeting, the president or designee shall send notice to the accused member of the investigation results, including charges and specifications, and whether the board intends to pursue the allegation(s) and proceed with a hearing. If a hearing is to be held, the accused member

shall have the option to say nothing or to admit or deny the allegation(s). If denied, the hearing shall determine if the allegation(s) are true. If admitted, the hearing shall determine the resulting discipline. A date for a hearing shall be set in consultation with the accused member, to be held as soon as reasonably possible but no later than thirty (30) days after the accused member receives notice of the allegation. The date shall be set when at least a quorum (which is a majority) of the board members can be present. (10/12)

- C. Temporary Suspension: If the board intends to proceed with a hearing, the accused member may be temporarily suspended from club membership, pending the outcome of the proceedings. (10/12)
- D. Hearing: A special meeting of the board, with at least a quorum present, shall be held to conduct a hearing. The only persons allowed to attend the hearing are club board members, the accused member, the Investigator, and any representatives or counsel for the accused or the club (and any club staff as needed). Witnesses are permitted only during their own testimony. The president shall preside; however, if the president is the subject of the allegation or wishes to decline, the board shall determine who presides. If a board member is the subject of the allegation, he/she shall continue to be counted as a board member in determining the number needed for quorum, but will not be allowed to be present during deliberations or to vote at any point in the process. (10/12) (4/13)

At the hearing, the Investigator shall present evidence on behalf of the club, and the accused member shall have the opportunity to present evidence in his/her defense. If the Investigator is a committee, any member of the committee may represent the club at the hearing. The Investigator or the accused member may present evidence through testimony of witnesses. Witnesses shall not be required to swear-in. Either side may question the other or any witnesses. The accused member may testify in his/her behalf, either in person or in written form without being present. The accused member also shall have the right of representation at the hearing by the person of his/her choice and/or by legal counsel, at the member's own expense. Legal counsel may be engaged by the club board to provide advice to the board; however, the role of such legal counsel is entirely separate from the role of the Investigator. Counsel for the club or the accused may be a non-Kiwanian. (10/12) (4/13)

If it is determined that additional time is needed to present evidence not available at the initial hearing, the board may adjourn the hearing and reconvene it later. (10/12)

If the accused member fails to appear for the hearing, it shall proceed without him/her. (10/12)

- E. Hearing Record: A written record of the hearing (hereinafter referred to as "the Hearing Record") shall be made. The hearing also may be recorded for transcription purposes. The Hearing Record shall include:
 - Date, time, and location of the hearing;
 - Names of all persons present or participating;
 - Nature of allegation(s), including charges and specifications;
 - Evidence, including testimony of witnesses;
 - A summary of the essential content of all discussions;

- Any findings determined during the proceedings;
- Any motions made or votes taken.

The Hearing Record shall be reviewed and adopted by the board in an executive session at the next special meeting of the board on the subject (see next step) and retained by the club secretary. (10/12)

344.6 – Determination and Discipline (4/13)

- A. Determination: Within seven (7) days of conclusion of the hearing—or within no later than thirty (30) days, if extenuating circumstances exist—the board shall hold another special meeting in executive session (attendance limited to board members) to consider the charges and specifications against the accused member. Each of the specifications, and then the charge, is read, opened to debate, and voted on separately, although the several votes can be collected on a single written ballot. If the accused is found guilty of one or more of the specifications but not of the charge, a lesser charge may be moved and voted on. In each case, a majority vote* is necessary. If the accused is a member of the Board, he/she shall not have a vote on the matter. (10/12) (4/13)
- B. Discipline: If the accused member is determined to have engaged in conduct unbecoming as alleged by at least one of the charges, then, by separate majority vote*, the board shall determine the appropriate disciplinary action, as follows: informal counseling, a verbal reprimand, written reprimand, suspension from office or club membership, or removal from office or club membership. The determination of the discipline should be based on the seriousness of the unbecoming conduct. (4/13)

If the discipline is removal from club membership, a two-thirds (2/3) vote* is required, per the Standard Form for Club Bylaws. For all other discipline, a majority vote* is required. If the accused member is a member of the board, he/she shall not have a vote on the matter. (10/12)

*Each of these votes refers to those board members present and eligible to vote. (10/12)

Note: If the discipline is determined to be suspension, and if the member was previously suspended, then the time the accused member has already been temporarily suspended may be credited toward the discipline. (10/12)

C. Board Report: Within seven (7) days of conclusion of the special meeting, the board shall produce a written report of its findings, conclusions, and decision(s) (hereinafter referred to as "the Board Report"), which shall become part of the club record on the matter. The board report shall include a copy of the Hearing Record, as reviewed and adopted by the board. A copy of the Board Report shall be provided immediately to the accused member and the investigator. The club membership shall be informed of the board's decision(s) on the matter, but other details from the Board Report shall remain confidential unless needed during a subsequent appeal of the board's decision(s) to the membership. (10/12) (4/13)

344.7 - Due Diligence (4/13)

As stated in the Kiwanis International bylaws: "A club shall discipline any member whose conduct is determined to be 'conduct unbecoming a member of the Kiwanis family,' or else the club shall be considered out of compliance with acceptable standards of Kiwanis

International and may have its charter suspended or revoked as provided in the Kiwanis International Bylaws." (10/12)

Therefore, if an accused member is determined to have engaged in 'conduct unbecoming,' some form of discipline must be given for the club to have properly completed due diligence on the matter. (10/12)

344.8 – Reinstatement of membership (4/13)

If the charges against the accused member are not substantiated by the hearing or, if substantiated, then after discipline has been completed by the accused member (other than removal from membership), the accused may be reinstated to membership in the club. (10/12) (4/13)

344.9 - Appeal

A. Request for appeal: Within thirty (30) days of the Board Report being provided to the accused member and the investigator, either party has the right to appeal the board's decision(s) to the club membership. Such appeal must be made in writing to the president (or secretary, if the president is accused) and must state the specific reason(s) for the appeal. Either party may appeal either the board's finding that 'conduct unbecoming' did or did not occur or the resulting disciplinary action. (10/12)

An appeal may **not** be used to "re-try" the allegations against the accused member, and and no new facts that were reasonably accessible at the time of the hearing will be allowed. An appeal will be allowed only if some part of the process or facts used to determine the board's decision(s), the Hearing Record, or the board's report is alleged to be faulty, incorrect, insufficient, or otherwise erroneous, or if the decision of the Board was contrary to the overwhelming weight of the evidence. (10/12) (4/13)

- B. Appeal Process: If a written notice of appeal is received by the club president (or secretary, if the president is accused), the board shall call a special appeal meeting of the club membership to consider the appeal within thirty (30) days, provided at least fourteen (14) days advance notice of the meeting is given to the club membership. Any person who is not a current club member in good standing shall be excluded from the meeting. The accused member, investigator, and counsel for either side shall be excluded from the meeting, even if they are club members. All materials and information provided to the club membership shall remain confidential among those attending. At least a quorum of the membership (which is one-third) must be present at the appeal meeting. The president shall preside; however, if the president is the subject of the allegation or wishes to decline, the board shall determine who presides. The materials to be considered for the appeal shall be the Hearing Record, the Board Report, and the appealant's basis for appeal. Members may ask only questions that are relevant to the appeal, and relevancy shall be determined by the presiding officer at the appeal. (10/12) (4/13)
- C. Permitted Motions: Only two separate and specific types of motions may be made during the appeal meeting by a club member in attendance, as follows: (4/13)
 - 1. Regarding the board's original determination of 'conduct unbecoming': move either to uphold the original decision; or they may move to overturn the original decision. Other motions are out of order.

2. Regarding the resulting disciplinary action, if any was given and if any is still in order: move either to uphold the board's original discipline; or they may move to overturn the board's original discipline and change it to some other disciplinary measure(s) which must be specified as part of the motion. Other motions are out of order

Any motion shall require a majority vote of those present and eligible to vote to adopt. (10/12)

- **D. Final Authority:** The decision of the club membership on the matter shall be final. (10/12)
- E. Appeal Record: A written record of the appeal meeting of the club membership (hereinafter referred to as the "the Appeal Record") shall be made, similar to that for the Hearing Record, and shall be reviewed and approved by the club board and retained by the club secretary. (10/12)

344.10 - Official Records, Notification, and Separate Disciplinary Action

- A. Official Records: The club shall retain all official records on the matter in a confidential file, as long as required by applicable law. Official records are: the Allegation Report, Investigation Report, Hearing Record, Board Report, and Appeal Record if any. (10/12) (4/13)
- B. Notification of Kiwanis International: A copy of all official records shall be sent to the Executive Director of Kiwanis International within thirty (30) days of the conclusion of all proceedings to retain in a confidential file. This provides documentation that the club completed due diligence regarding the allegation, as well as a safeguard against club records being lost or destroyed at a later date. (10/12) (4/13)

If the member was disciplined by the club in any way for 'conduct unbecoming' and if he/she is also a Kiwanis International officer, Kiwanis International may take separate disciplinary action against the member as it deems appropriate. (4/13)

C. Notification of District: If an accused member is removed from the club for 'conduct unbecoming', the club shall so notify the district governor. (10/12) (4/13)

If the member was disciplined by the club in any way for 'conduct unbecoming' and if he/she is also a district officer, Kiwanis International shall send a copy of the official records on the matter to the district governor, and the district may take separate disciplinary action against the member as it deems appropriate. (4/13)

D. Notification of Other Clubs: If the member was disciplined by the club in any way for 'conduct unbecoming' and he/she also belongs to another Kiwanis club(s), Kiwanis International shall send a copy of the official records on the matter to the president(s) of the member's other club(s) and each club may take separate disciplinary action against the member as it deems appropriate. (4/13)

344.11 - Parliamentary Authority

The most recent edition of Roberts Rules of Order shall be the parliamentary authority for all procedural matters related to investigation, determination, discipline, and appeal (if any) for 'conduct unbecoming' which may not be specifically covered in Kiwanis governing documents, including but not limited to this procedure. (In the 11th edition of Roberts Rules, see Section 63 – Investigation and Trial). In the event of any inconsistency between Kiwanis governing documents and Roberts Rules, the Kiwanis provisions shall prevail. (10/12)

RESOLUTION

WHEREAS, The Kiwanis motto is Serving the Children of the World; and

WHEREAS, The Kiwanis defining statement includes the phrase, "improving the world one child and one community at a time"; and

WHEREAS, The Fifth Object of Kiwanis is: "To provide, through Kiwanis clubs a practical means...to build better communities"; and

WHEREAS, The Sixth Object of Kiwanis is: "To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and goodwill";

THEREFORE BE IT RESOLVED, that Kiwanis International stands against violence, neglect, and abuse directed towards children.

Proposed District Policy Code Amendment

XVIII. Pennsylvania Kiwanis Foundation

- b. Any proposed amendments to the bylaws of the Pennsylvania Kiwanis Foundation must be approved by the Kiwanis International Board of Trustees and the Pennsylvania District Kiwanis International Board of Trustees prior to those changes taking effect. This provision In no way waves the requirements set forth in Article VI of the Pennsylvania Kiwanis Foundation Bylaws.
- c. All proposed changes and additions to the standing policies of the Pennsylvania Kiwanis Foundation must approved by the Pennsylvania District Kiwanis International before those policies take effect.
- d. The Pennsylvania Kiwanis Foundation Board of Directors shall supply a quarterly financial report to the Pennsylvania District Kiwanis International Board of Trustees.
