### Introduction to the Kiwanis International Structure Part 2 Who Controls What? by PLG Marj Buck

In some ways the structure of Kiwanis International is like our political structure in Canada. Kiwanis International (Federal level), District (Provincial level) and Clubs (Municipal level).

Kiwanis International (KI) has the authority to direct, manage, supervise, and control the business, property, KI funds and any sponsored organizations or programs. It has the authority to create, supervise and control clubs, districts, federations or other groups of clubs and divisions. KI must approve the formation and bylaws of and documents to be filed with government agencies by foundations, charitable organizations, or any other legal KI entities, (subsidiaries). Finally, KI determines the appropriate use of its intellectual property, including use by affiliates and subsidiaries, and to establish guidelines for such use.

The officers of Kiwanis International are President, President Elect, Immediate Past President, Vice President, Executive Director, fifteen (15) Trustees and the District Governor of each District.

Kiwanis International created standard bylaws for the various **Districts** in its organization. This bylaw outlines primary purpose of a district: "to assist clubs and Kiwanis International to advance the Objects, objectives, policies, and strategic goals of Kiwanis and specifically to cooperate with Kiwanis International in:

- building new clubs
- strengthening existing clubs,
- delivering education to clubs
- delivering service leadership programs
- delivering global campaigns for children programming to and through clubs."

The District is also responsible for promote clubs within their district to Kiwanis International. The District, in accordance with the standard by-law, must have all proposed District bylaw changes approved by their membership prior to submission to KI for final approval and execution.

Kiwanis International created the standard bylaw for **clubs** in 2013, which all clubs are required to use. This bylaw provided clubs with fewer restrictions and greater flexibility than the previous version. They also provide clubs with a mandatory standard policies document covering items such as: dues and fee; criteria for members in good standing; how often a club meets; and details of the election process. There are optional policies that the club may include such as standing committees, special membership types, additional duties of officers and directors. The Club by-law and policies must be approved by Kiwanis International before the club enacts any part of the document.

This document governs our local clubs and describes how we conduct our business, programs, and finances.

The standard bylaw outlines the officers of the club and their duties. However, clubs through their own policies add additional duties to any given position.

The standard bylaw states that separate accounting records must be maintained for service funds and administrative funds and such accounts are to be examined annually by either a qualified accounting firm or by a standing financial review committee.

In addition, funds raised from service activities, regardless of source may be used only for service activities.

Clubs raising funds through lottery programs are required to follow local government regulations. In all matters where there is a conflict with Kiwanis International policies and procedures, local government legislation governs the matter.

All three levels of Kiwanis have a discipline clause which outlines the actions to be taken if a written allegation of "conduct unbecoming a member of the Kiwanis family" is made. Although rarely used it is an option should there be concerns about an individual. (In my 29 years in this organization, I am only aware of one case in our local Division where an officer was removed from their position.)

Kiwanis clubs may conduct any program, activity, or fund raiser that serves their community provided they meets all local, provincial and federal government laws and regulations as well as any applicable Kiwanis International policies.

The club meetings may be conducted as the club wishes, however, annual general meetings have a KI time restriction, with election results to be reported within in a specific time frame. Replacing officers of the club has restrictions but all of these are established so all clubs conduct business in a similar manner. Officer training needs to be conducted at the Divisional, District and International levels, with some limitations in place.

The training program is set by Kiwanis International with trainers approved by the District and Divisions to present the program. Adjustments to the training program are permitted but with limited restrictions in place from Kiwanis International and the District. This year, for example, the District Governor has ruled that all training must be completed in person, unless he approves otherwise, and the following individuals from clubs must attend: President, President-Elect, Treasurer, Secretary and Membership Chair. He has made this decision as he believes that if the executive trains as a team they will work as a team.

- 4: To develop, by precept and example, a more intelligent, aggressive and serviceable citizenship.
- 5: To provide, through Kiwanis clubs, a practical means to form enduring friendships, to render altruistic service and to build better communities
- 6: To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism and good will.
