Community ID of the Palm Beaches



Our program on August 6 was presented by Sol Couto, Community ID of the Palm Beaches Coordinator.

Administered by the Legal Aid Society of Palm Beach County

(LAS), the Community ID of the Palm Beaches (CID) is for ANY Palm Beach County resident 16 years or older who may have limited access to government issued forms of identification, and for those who support a diverse and inclusive community.

CID is not a government issued form of ID or a driver's license, but a verifiable form of identification that says you are part of our community. It can be used within your community to gain access to essential services and as a tool to better identify, serve and protect

you.

Launched in 2019, CID has provided families with access to essential services and/or programs, such as, but not limited to: health centers, medical providers, medication, vaccinations, immunizations, schools, libraries, diagnostic centers, food pantries, shelters, and urgent or emergency care facilities.

CID has enabled individuals to participate in the workforce, gain access to their community, and gain entry at numerous gated and/or private communities. As cardholders, seasonal residents and newly integrated individuals shared similar benefits.

To date, LAS has provided over 4,000 Community IDs to Palm Beach County residents. For more information go to www.legalaidpbc.org.

Hurricane Season is Upon Us

As we enter the height of hurricane season, it's critical to stay prepared and informed. Storm activity in the Atlantic is at its peak, and the risk of severe weather, especially tornadoes, dramatically increases.

Hurricanes bring more than just strong winds and flooding—they can also spawn fast-moving tornadoes, especially in outer rain bands, catching communities off guard. If you haven't already, now is the time to:

Review your emergency plan; Stock up on essential supplies; Understand


how to secure your home; Know your evacuation zone and have

multiple ways to receive emergency alerts; and Communicate your plan with family, friends, and neighbors.

Awesome Greyhounds

Our program on August 27th was presented by Laura Leibson, Event Coordinator for Awesome Greyhound Adoptions (AGA) and Capt. Shawn Campana of the Miami Dade Fire Rescue.

AGA is completely run by volunteers who are dedicated to finding responsible, loving homes for racing greyhounds that no longer qualify to compete at the racetrack. These highly-trainable dogs are given the chance to find placement as pets, as therapy dogs or as fully-trained service dogs for veterans and first responders.

AGA carefully evaluates each greyhound for temperament and health to place each dog into a pet home or to have them carefully selected as a service or therapy dog for veterans and first responders through the Hounds & Heroes Program.

Whether you choose to adopt a greyhound, foster a greyhound, volunteer or simply want to donate, you can help! Every dollar makes a difference. Their fostering, training and adoption program brings greyhounds in from the race track and performs a series of health evaluations - many are costly. Making A Difference

Our program on August 20th was presented by Sue Mann, the Founder of Bright Minds Processing, a non-profit addressing visual (VPD) and auditory processing disorders (APD).

Bright Minds Processing help children who learn differently, thrive by targeting the cause, not just the symptoms. Better focus. Better listening. Better learning.

1 in 5 kids at school has some form of Processing disorders and gifted kids are no different. It is worse for gifted kids as they can have a high IQ but cannot do their school work. The testing process for being gifted (which is a learning difference in most States) is taking an IQ test and scoring above 130. But how can a gifted child pass this type of test if they have APD and VPD? If a gifted child has been deemed with a low IQ (due to a low score on an IQ test) with the right diagnosis and therapy, they can go back and take the very same test and score over 130.

Bright Minds Processing is comprised of a group of Doctors, Audiologists, Developmental Optometrist, Psychologists, Councilors, Therapists, Teachers, and Parents who are passionate about raising awareness towards this "hidden" learning disability. The cost of therapy is excruciating because APD and VPD are not considered learning disabilities. Therefore, medical insurance will not cover any therapy. Until Schools recognize APD and VPD as learning disabilities. Only ADD, ADHD or Autism, will receive available resources.

Their mission is to educate as many parents about children with APD and VPD. Together we can lobby schools to implement solutions. Our collaboration of professionals will empower parents and families so they can work with us to implement our APD and VPD programs into their schools.

Board Meeting Notes

Our club's recent Board Meeting took place via Zoom on July 7th. Here are the notes:

I. Board Attendance: President Dave Freeburn, President-Elect Diane Colonna, Secretary Jay Alperin, Treasurer Bill Morse. Directors: Kelleher, Davidson, Pam; Krieg, Davidson, Joel; Sablo, DeVoe.

II. Foundation Attendance : President Freeburn, Vice-President Pollack; Secretary Alperin; Treasurer Morse, Directors: Youngberg, PDavidson Colonna.

III. Secretary's Report: Minutes of July 7, 2025 Kiwanis board meeting. Motion to approve made by Bill Morse. Seconded by J. Davidson. Approved unanimously

IV. Financial Report: Bill Morse reported that there is \$8,367 in the Foundation account, and \$20,920 in the Administration account. Tax returns have been filed for both entities. Financial reports will be completed next month.

V. Old Business:

A. Alternate Meeting Locations: Club member Ronnie Dunayer was present to discuss her findings regarding the identification of a meeting place while the golf club is being renovated. She looked at a number of venues and felt that the best choice was the Fairmont Inn on West Atlantic Avenue. For approximately \$15 per person members could eat from the buffet that is available to hotel guests. Another option is Cason Church but that would involve arranging for a food truck. A decision will have to be made before the golf club shuts down, estimated to be in December.

B. Story Trail : Joel Davidson reported that the budget numbers were changing. Not much was accomplished in July due to several people being on vacation. He is trying to meet with the printer. They plan to meet with City staff regarding the layout of the trail, and the possibility of installing it at Catherine Strong Park instead of Barwick.

C. Education Breakfast August 28th. Ten people have signed up so far.

D. Pancakes, Pints, and Pigskins, November 16, 2025 at Finnegan's: Peggy Kelleher - Committee met, they will need help getting sponsorships and raffle prizes. Scott made a flyer for the event. Rich Pollack, committee co-chair said they want to gross \$10,000. He plans to be a sponsor to raise money for the Foundation. Sponsorships will be at varying levels. Tickets will be \$40 each.

E. Happy Hour: Scheduled for this Thursday. Scott reported that so far there are 9 people planning to attend.

F. Fundraising Committee: David Freeburn reported. A survey was

sent to members to rank each event according to several factors. The most favorably ranked ideas were the Mahjongg tournament and the Mayor's breakfast. Another possibility is the Talent Show. The Fundraising Committee will hold another meeting and make some decisions on which items to move forward.

G. Women's Club: Peggy informed the board that the Women's Club's fundraising event will likely be moved to the City Library, which means those two entities will be partnering on it.

H. Key Club: David is to follow up with Key Club members.

I. Golf Tournament: Scott reported there are 7 hole sponsors and 9-1/2 teams so far. Trying to get renewals of last year's sponsors. The consultant has brought in 3 teams.

J. Calendar and Budget: Jay stated that additional input is needed on events. The Foundation budget starts in January and the Club budget starts in October.

K. First Day of School—High Fives: Rich Pollack reminded the board that the first day of school was coming up (Monday August 11). Participating members need to be at the school at 7 a.m.

VI. New Business:

A. Civic Education Program: Ezra Krieg was informed about this program geared toward middle and high school students, helping them to learn about civic engagement and involvement. He is seeking direction from the board to learn more about the program and a possible partnership with Delray Kiwanis. The consensus of the board was to have Ezra get additional information and report back.

B. Election Polls: Ezra sent a note to the Supervisor of Elections informing them that the club would be interested in working the polls for the upcoming elections. It's an opportunity to raise money for the club. Two members will have to work a full day (Ezra and Bill volunteered). Other shifts will be shorter.

C. 250th United States birthday: Ezra thought maybe the club could participate in Delray Beach's celebration of the country's 250th birthday. It would be a way of getting exposure for the club.

D. Mini Grant Requests: None pending.

E. Thanksgiving: Ezra said it's time to begin organizing for the Thanksgiving meal deliveries. He'd like to have a meeting on September 10th after the breakfast meeting.

F. Other: Joel - Is the board interested in having additional members become Sustaining Members? Some clubs automatically add it to members' bills once a year. It would give our club a chance to get additional funds from the Kiwanis District Foundation. After discussion it was determined to invite club members to sign up as sustaining members at a future meeting, and put the item on a future board agenda.



DID YOU KNOW?

5 Things You Never Knew About the \$2 Bill

Without question, the \$2 bill is the black sheep of the U.S. currency family. Despite being a small enough denomination to fairly easily acquire, the "Tom" — nicknamed for its portrait of Thomas Jefferson — rarely surfaces in day-to-day transactions. In fact, many folks erroneously believe the \$2 note to be out of circulation, with some cashiers even refusing to accept these unfamiliar bills.

Make no mistake, the \$2 bill is very real and remains in regular circulation, albeit at a smaller volume compared to commonly found denominations such as \$1s and \$20s. But while the Tom lacks the everyday presence of the others, it also sports a more intriguing backstory than its brethren bills. Here are a few fun facts about the not-so-terrible \$2.



Six Types of \$2 Bills Have Appeared Since 1862

Not counting the \$2 denominations that appeared with the Continental Currency notes that funded the American Revolution, there have been six categories of \$2 bills issued by the U.S. federal government. These are: United States Notes, which initially featured Alexander Hamilton in 1862 before switching to Jefferson seven years later; National Bank Notes, which circulated during the Reconstruction years and are known as the "Lazy Deuce" for their horizontal digits; Silver Certificates, which featured a series of elaborate vignettes during their mid-1880s to mid-1920s run; Treasury Coin Notes, which featured Union General James B. McPherson and were only printed in the 1890s; Federal Reserve Bank Notes, which displayed the USS New York battleship and received an even briefer run after World War I; and Federal Reserve Notes, which appeared in 1976 to celebrate the United States bicentennial after the \$2 bill had been discontinued for a decade due to its low usage.

Some \$2 Bills Are Very Valuable

While its scarcity has spawned a perception of the \$2 bill being a valuable keepsake, most existing \$2s are worth that exact amount. Still, there are more valuable specimens to be found for those who seek to collect or turn a profit off such rarities. Older bills are of course more highly prized, with the earliest federally issued \$2s worth more than \$3,000 and uncirculated 1890 Treasury Notes valued at more than \$4,500, according to U.S. Currency Auctions. Additionally, a distinct serial number, such as the "12345678" on aptly named "ladder notes," can fetch a significant return even for newer notes. A 1976 bill with a serial number of "00000001," for example, is said to be worth at least \$20,000.

The \$2 Bill Historically Has a Bad Reputation

The Tom's limited availability in public settings may partly stem from its longstanding ties to the seedier sides of human nature. According to The Two Dollar Bill Documentary, the bill at various points has allegedly been favored for acts of election bribery, gambling, and prostitution. It's also been linked to the devil, necessitating the tearing of a \$2's corners to ward off evil spirits.

While all these associations are now attributed to urban legends, there also may have been practical reasons for the corner-tearing tradition. As more \$1 bills were printed in the 1880s, people who grouped smaller bills together would shortchange themselves when a stray \$2 ended up in a pile of \$1s. As a result, it became a common practice to rip a corner of a \$2 to help avoid that mistake and ward off the bad juju of miscounting money.

The \$2 Bill Was the Only U.S. Bill Allowed in Mexico During World War II

In 1942, the government of Mexico announced it was restricting the import of U.S. currency, as part of efforts to prevent American money seized by Axis powers during World War II from being spent. People in possession of U.S. dollars were ordered to immediately turn them over to a bank, where they would be exchanged for pesos to those who could prove the cash was, according to The New York Times, "legitimately acquired and free from Axis taint." Shortly afterward, the U.S. government followed suit by cracking down on U.S. money allowed in and out of the country. The lone exceptions were coins and \$2 bills, the latter apparently not commonly found in the grasp of Axis hands. Unsurprisingly, demand for the \$2 bill along the United States-Mexico border soared during the World War II years.

IRS verified social media accounts and e-news services are best sources for tax-related information

Social media can be a resource for up-to-date tax information, especially with the many changes to the federal taxes in 2025. However, taxpayers should be mindful of what accounts they're following for tax advice. Unfortunately, there's a lot of inaccurate or scam advice being shared. Which is why it's important that taxpayer get tax-related information from IRS verified social media account or e-news services.

IRS social media platforms

The IRS **never** contacts taxpayers on social media to ask for their personal or financial information. Taxpayers should be aware [scammers may pose as the IRS](#) to steal a taxpayer's identity or defraud them. To stay informed, be sure to follow, like and subscribe.



Lessons from the Kiwanis Polar Dip

The Kiwanis Club of Tysons adopted an existing event and turned it into a successful fundraiser. By Jeffrey Wolff, event chair, Kiwanis Club of Tysons Polar Dip



Want to raise money for your club, but struggling to find a successful project? At the Kiwanis Club of Tysons, Virginia, U.S., we've benefited from maintaining partnerships and connections in the community: Our club of about 25 members has transformed a preexisting "polar dip" into a major fundraiser. With the right preparations and a suitable body of water, it's the kind of event that other clubs can replicate.

The Kiwanis Polar Dip is an annual event in which teams and individuals jump into Lake Anne in February to raise money for charity. The event was previously held by Camp Sunshine, which provides free getaways to children with illnesses and their families. After participating as a team, our club worked with Camp Sunshine to assume responsibility for the event and turn it into a Kiwanis fundraiser.

While it requires an "all hands on deck" approach on the day of the event, much of the work — such as recruiting jumpers — can be done from home beforehand. The club just needs to find a place to hold the event, coordinate logistics and set up a website for donations. The Kiwanis name itself adds to donor confidence, making it easier to secure sponsorships and donations.

Learning and adapting

Our club had more manpower than the individual who ran the event for Camp Sunshine, but our biggest challenge was to learn everything she'd figured out over the previous 15 years — including vendor relationships and the complicated web of organizations that had to be contacted to make the event happen.

Another key to success was adding a sense of friendly competition. For instance, a leaderboard on the event website tracks how much individuals and teams have raised. We find that you raise more money when you spur competition between jump teams. In addition, the event day has a party-like atmosphere, featuring a DJ and face painting, which make it a fun experience for the participants and the hundreds of spectators.

The goal for our first year managing the Polar Dip was to raise US\$25,000. In just its second year, the event has grossed almost US\$50,000. Those funds help fulfill our club's dual mission: to support the 11 Service Leadership Program (SLP) clubs we sponsor — nine Key Clubs, one CKI club and one K-Kids club — and to fight food insecurity in Northern Virginia. In the past, the Kiwanis Polar Dip had solely supported Camp Sunshine. But to support our mission as well, we added Food for Neighbors, which provides meals for middle school and high school students, as a major beneficiary of the event.

The event also has received significant community support, with roughly 60-70 jumpers and 150-200 spectators. It also has been featured on the front page of local newspapers. The success of the Kiwanis Polar Dip has had a positive impact on the Kiwanis Club of Tysons, increasing its visibility and fostering a greater sense of success and involvement with local beneficiaries and the community.
