Officers and members, you may think this isn't important, but it is! Without information KI and the Districts are not able to provide clubs with the necessary materials and ideas to help their clubs prosper and grow. The monthly report, which can be found on the secretaries dashboard, is due on the 10th of the month after the previous month ends.

After it is submitted to KI, click on the envelope and it will be emailed to your club president, Div. Lt Governor and District Secretary at kansaskiwanis@gmail.com. You may have to put in their email addresses the first time. Presidents, please make sure you received a copy. If you don't receive it, let your secretary know. Discuss the report with your board members at your meeting. Work with your secretary on club communication to make sure ALL members know what is happening. Some may never make it to a meeting, but they are still members and should not be forgotten! This is one of the steps to reach Distinguished Club! Last year in the first 6 months only 20% of the 70 clubs were filing club reports. Not a very good rate. I know all of you are great secretaries and we all do have a lot on our plates, but maybe you can squeeze 20 minutes in each week for the report.

The Kansas District is awesome and we have very talented and inspiring members! Let's tap the resources and grow! LEADERSHIP

I would like to touch on a subject that is widely discussed among current and previous leaders of the district, but may not be as well known by the district membership. That subject would be the lack of district members willing to step up and assume additional leadership roles within both the divisions and the district levels. This lack of willingness leads to a smaller and smaller pool of people who are available to help facilitate the successful operations of the district. This dwindling pool results in several detrimental effects for the district:

1. The "wearing of many hats" by members of the district leadership to ensure the successful operation of the district. There are numerous positions currently filled at the district level by the same person. There are several examples of this in the district, but I will use myself as the example for this point. I am currently the Governor-elect, but I also act as the assistant district secretary, and webmaster. While this may not sound like a lot, it shows that there are at least two positions that could theoretically be performed by other members of the district, if members were interested. There are also others in the district with more "hats" than I.

2. The lack of qualified members to be elected to leadership positions for the district. Many members may not realize, but in order to serve in one of the elected positions at the district, a candidate must have completed a successful term as a club president or secretary and as a Lt Governor. There are currently several Lt. Governor positions vacant in the district, and others filled by the same Lt Governor for several years. These vacancies and successive terms in office over a period of time reduce the available candidates for these district elected positions. At some point in the future, the district will face the possibility that they will have no individuals "qualified" to be elected to these positions. My division, division 4 for example, had a vacancy in the Lt Governor position last year for the first time in over 20 years. This vacancy, in addition to the reduction of candidates mentioned above, also prevents the clubs in my division from having a voice in the operations of the district because they have no representation of the district board. 3. Lack of new ideas for how things are accomplished within the district. This is not to say that the current leadership is lacking in ideas or not willing to try new approaches to operations in the district. But as anyone who has attempted to organize anything by committee knows, everyone has a different idea on how to accomplish any goal. The strength of an organization is the discussion of these ideas, coming up with a plan that works best for the organization and putting that plan into action. Without new people to provide new ideas for discussion, organizations tend to fall into doing the same things while expecting different results and this rarely happens. For those members who don't know me personally, you may think that I am being rather pessimistic in my outlook for the future of the district, but I do believe in informing members of what I perceive to be issues that need to be corrected before they reach the point of no return. I personally like to be more optimistic about things in life and know that by putting this information out to our membership, others will start thinking about ways that they can help find a solution to these perceived problems and start solving them. After all, we are Kiwanians and that is what we do - We find and implement solutions to improve our communities. We just sometimes need to be reminded that our communities don't stop at the city limits. Many members feel they don't have the time to give to do more, but I once had a very good friend of mine tell me "that just means that it's not important enough to you for you to find the time to do it".

So I am asking you as a member of the district, find one thing in Kiwanis that is important enough to you to give a little of your time to, then contact someone in the district leadership and offer to help make our district a better organization.
