E

very holiday season from Thanksgiving Day Detroit Lions game to Christmas Eve we see the Salvation Army Red Kettles in front of many stores across the country. Bell ringers from various walks of life and service organizations, including Kiwanis Clubs, each year. The Salvation Army Red Kettle program began in San Fransico in 1891 to fund Christmas Dinner for 1,000 people in need. Bells were not rung until 1900 when Salvation Army Officer Cadet Amelia Kunkle was a kettle ringer in New York City. Amelia and her girl-

cadets would stand outside in The Battery, near Wall Street, and she noticed many businessmen who came to and from the financial district each day would rarely stop to put money in the kettle.

One day Amelia went to one her Administrators, Major Chadwell, and complained to him about these businessmen who largely ignored the kettles. He suggested she get a stick and knocked it on the outside of the metal bucket to draw attention to it. Kunkle did not like the idea, so Major Chadwell encouraged her to come up with another idea.

The next day, Amelia was in a nearby Woolworth's store and found a small bell with a short, dark wooden handle. She picked it up and the bell made a nice tinkle. It was only 10 cents.

During her next kettle

duty day, she rang her bell during her shift. More people stopped and she greeted them with a cheery "God Bless You" and "Merry Christmas". Her idea spread quickly and soon all cadets were ringing bells, raising funds for the Salvation Army's Christmas Dinner.

The Red Kettle Campaign celebrated 125 years in 2015 and set a fundraising record. That year, roughly 25,000 bell ringers and corporate sponsors raised close to \$150 million, with \$.85 per dollar going directly into the communities where the money was raised.

As Kiwanis International continues their focus on human and spiritual values in the 2023-2024 year, the Salvation Army's Red Kettle program is a great way to show support to the children and families in your community by volunteering as bell ringers. Let's channel the spirit of Officer Cadet Amelia Kunkle and have fun doing the honors of ringing the bells to collect funds in the Red Kettle campaign. The funds you raise impacts the community through social services assistance, homeless shelters, disaster relief, children's programs, rehabilitation services, anti-human trafficking, and more.

There are three main ways to register your Kiwanis club as bell ringers. First, you will want to go to the Salvation Army's Register to Ring website at Register to Ring. Then you will choose to either "I'm Ringing as an Individual", "I'm Ringing with a Group", or "I'm a Virtual Ringer". You will need to create an account so you can login and schedule your bell ringer hours. In most areas, there is a minimum of two hours per shift, but if you choose to



do more, you can do so. The Salvation Army encourages volunteers to work in teams of two, if possible, and it can be more fun volunteering with a friend.

Of particular interest to some of our Kiwanis members who are unable to participate as a bell ringer in person is the Virtual Ringers option. You can create a virtual Red Kettle and share it on your social media websites – including your Kiwanis club's page – from the comfort of your home. Make sure to share your virtual Red Kettle with family and friends and especially your community so they can donate online as well.

Kiwanis clubs will soon receive a letter from the Michigan District of Kiwanis Human and Spiritual committee chairperson, Krista Surratt, inviting individual clubs to join in the Red Kettle campaign. It has information you need to submit your bell ringing deeds for service hours and how to receive your patch. The deadline to send in your club's information is February 10, 2024.

Many of us do not have to worry about our next meal, where we are going to sleep, or how to find mental health or spiritual programs for our children. But, if you ever do find yourself in this situation, remember the Salvation Army's Red Kettle campaign and why it's necessary to support the work of this service organization. More importantly, as a Kiwanis club member, volunteering before the need arises is even better.

# Where have all the workers gone?

I am sure you have seen these signs at various businesses near your home, they are now commonplace. People everywhere are asking where have all the workers gone. Kiwanis could ask the same as 49% of our membership has disappeared since 1991, our peak year.

Scholars for centuries have looked at the Fall of the Roman Empire and determined that its fall was due to a decline in the birth rate and the aging of their population. They didn't have enough people to defend the Empire.

A co-worker of mine once said, 'history is easier to understand once you've lived it.' So, since I have witnessed our membership decline firsthand, I feel confident when I say I believe we are at a tipping point. It is imperative for us to find new members or like many businesses without workers, we will be forced to close. In 2022 KI reported that 490 Clubs turned in their charters, twice as many as were opened.

I have spent most of my adult life helping the vulnerable through Kiwanis. I believe in it.

I state the following as both a warning and as a call to arms. In the 1950s Detroit No.1 had 350 members with its own paid Secretary. When I joined in the 1980s there were 110 and the average age was about 45. By the time I was its 104th President there were around 40 and the average age was around 52. These trends mirrored those throughout KI. Today our average age is 63.

#### It is Job 1 of the Governor to grow the organization.

It is the No. 1 Job of the Governor Elect to put together their team so that they can hit the ground running.



# district news || tax filing

# IS YOUR TAX COMPLIANT?

This is the time of year when individuals and corporations take the time to minimize their tax exposure for the year. All Kiwanis Clubs should also take the time to ensure that they are compliant with the tax filings required each year by both the IRS and the State of Michigan to avoid possible fines and loss of tax-exempt status.

#### **IRS TAX FILING REQUIREMENTS:**

#### YOU CAN CHECK YOUR CLUB'S FILINGS WITH THE IRS

Form 990 series are annual information returns that most tax-exempt organizations must file with the IRS. They provide information on the organization's mission, programs, finances, governance, and compliance with federal tax laws. The IRS uses this information to monitor the activities and operations of tax-exempt organizations and to enforce the tax laws that apply to them.

The filing requirement and penalties for non-filing vary depending on the type and size of the organization. Generally, organizations that have gross receipts of \$200,000 or more, or total assets of \$500,000 or more, must file Form 990. Organizations that have gross receipts greater than \$50,000 but less than \$200,000 with assets less than \$500,000 may file Form 990EZ. Smaller organizations with annual gross receipts normally less than \$50,000 may file Form 990-N (e-Postcard), which is a simple electronic notice. Some types of organizations, such as churches, are exempt from filing any Form 990 series return.

Form 990-N is an annual electronic notice that most small tax-exempt organizations must file with the IRS by the 15th day of the 5th month after the end of their fiscal year. It is also known as the e-Postcard. The purpose of Form 990-N is to help the IRS maintain an accurate list of active nonprofits and monitor their compliance with tax laws. If an organization fails to file Form 990-N for three consecutive years, it will automatically lose its tax-exempt status and may face penalties and back taxes.

The penalty for failing to file a required Form 990 series return is \$20 per day for each day the return is late, up to a maximum of \$10,000 or 5% of the organization's gross receipts, whichever is less. For larger organizations, the penalty is \$100 per day, up to a maximum of \$50,000. In addition, the IRS may revoke the tax-exempt status of an organization that fails to file a required Form 990 series return for three consecutive years.

#### MICHIGAN FILING REQUIREMENTS: Annual Report

#### YOU CAN CHECK YOUR CLUB'S ANNUAL REPORT FILINGS

If you are running a nonprofit corporation in Michigan, you need to be aware of the annual report filing requirement. According to the Michigan Nonprofit Corporation Act, every nonprofit corporation must file an annual report with the Department of Licensing and Regulatory Affairs (LARA) by October 1 of each year, starting from the year after incorporation. The annual report fee is \$20 and can be paid online or by mail. The annual report form (CSCL/CD-2000) is mailed or emailed to the corporation's resident agent about three months before the due date. You can also file the report online at www.michigan.gov/corpfileonline. Failing to file the annual report or pay the fee within two years of the due date will result in the automatic dissolution of the corporation. To restore the corporation's existence, you will have to file all the missing reports and pay all the fees plus a \$5 penalty for each delinquent report.

#### LICENSE TO SOLICIT

#### YOU CAN CHECK ON THE STATUS OF YOUR CHARITY

Nonprofits that solicit or receive contributions more than \$25,000 per year are required to file an annual License to Solicit with the Attorney General's office, unless exempt by law. Not filing or renewing a license may lead to penalties, fines, or license loss. Check with a lawyer or the Charitable Trust Section if you are not sure about your exemption status.

- 2. When the club hits "Submit" an email containing their answers is automatically generated to all District Governors and Secretaries, as well as the club member who submitted the entry and Kiwanis International.
- 3. Despite the 3-week+ window for contest submissions, 87% of them are historically received within the last four days of the deadline. Please encourage your clubs to enter them early so if there is a technical issue at their end there will be plenty of time to work through it. The contest close date is firm.
- 4. At the end of the 3-week+ contest window each district should coordinate judging process with district staff to select your two best entries – one from Group I clubs (27 and few members) and one from Group II clubs (28 and greater members) that have been chosen to represent your district in the contest. Some districts may not have club entries from both small and large clubs to judge and submit to KI.
- 5. Using the contest judging criteria (attached), district judges review and rate/score each entry. Using this online form districts submit their selections. District entries cannot be received by KI via email, only via this online form.
- 6. Districts will be notified in early April if either of their club projects have been selected to the Top 10 of each club group.
- 7. 1st, 2nd, and 3rd place winners for each club group will be recognized at the annual Kiwanis International convention in July.
- 8. Complete contest rules are found here.
- 9. Clubs can read the application questions ahead of time to prepare their answers (highly recommended).



This Kiwanian, a member of the Chelsea Kiwanis Club for two years, has led the club in volunteer hours and set the example of serving others beyond self.

Sherri Rizzo performs between 40-90 volunteer service hours each month as part of the Chelsea Kiwanis satellite at the Chelsea Retirement Community, a continuum care living facility for four hundred residents. Six of her monthly hours are spent with her therapy dog Zeva visiting nursing and dementia residents.

She leads activities that bring residents together who might otherwise spend their days alone. And she brings hope to people whose health has severely reduced their former abilities. As a senior citizen and widowed, Sherri knows the social needs of residents and the limitations aging can bring. Although an eye disease limits her vision such that she can no longer drive, she gets around campus on her three-wheeled bicycle.

Her service includes maintaining a monthly display of former and current hobbies. Past displays included resident wood carving, antique toys, veteran memorabilia, and "what's in your purse or wallet". Sherri leads the Monday night Bingo game and helps staff host the monthly birthday celebration and new member welcome tea. With paid staff shortages she fills in by arranging outdoor lawn games, potlucks, and picnics for independent residents.

The assisted living and dementia units look forward to therapy dog Zeva's visits and Sherri's help with weekly activities. Sherri is also the volunteer coordinator for the Chelsea Kiwanis satellite at the Chelsea Retirement Community, keeping records of volunteer hours.

When Sherri Rizzo sees an unmet need she brings it to the attention of the administration and if staff is unable to address the need she finds a way to complete the task. Her example has led many other residents to volunteer their time and talents. While others may not be able to match the time she gives to volunteer service, her example calls others to examine what they can do to serve others.

CLINTON VALLEY KIWANIS COMES TO THE AID OF HOMELESS CHILDREN IN MACOMB COUNTY

Macomb County is a wonderful place to call home, that is, if you have a home. While most students attend school in new clothes, fully supplied, after a good night's rest in a secure and comfy home, there are currently over 1,700 school-aged children in Macomb County who are not as fortunate. They are homeless. They go to school from a shelter, a cheap motel, the family car or the crowded home of a relative. These children often find themselves moving frequently and falling behind academically. They lack basic needs like appropriate clothing, food, school supplies and transportation.

To help alleviate the difficult situation in which these children find themselves, the Kiwanis Club of Clinton Valley hosted its 16th annual wine tasting benefit last month to benefit the Macomb Intermediate School District's Homeless Education Project (MISD) and the Macomb Charitable Foundation (MCF) to provide clothes, food, school supplies, and, just as critical, transportation to ensure a child stays in their school so they don't fall behind. They also provide a summer camp for these children. During the 2022/2023 school year, MISD helped 1,326 homeless students (a 17% increase over the previous year), and the MCF assisted nearly 600 children of all ages and their families.

This premier event is powerful in keeping with our Kiwanis mission of "Improving the world one child and one community at a time", and Clinton Valley is grateful for the tremendous support of this annual event that we receive from many Kiwanis clubs in our area. We are better together!

# An Apple for Ryan

#### Woodhaven-Brownstown School District Students & the Kiwanis Club of Woodhaven

Each October, for the past 26 years, Friends of Ryan Sergent celebrate his passing as a High School Senior at Flat Rock High School. "What would Ryan have done? The answer is simple, he would have helped others. We began AN APPLE FOR RYAN non-perishable food drive at Bates Elementary and it quickly spread to all Woodhaven-Brownstown Schools. Long time Bates School Fifth Grade Teacher Evelyn lost her husband Dr. Sergent to cancer and in the next year, lost her son Ryan while he was running Cross Country practice as a senior at Flat Rock High School in the fall of 1997. To make sense out of tragedy, Ryan's Mom, Friends, and Kiwanis started our annual food drive. We gather food in all Woodhaven-Brownstown schools and deliver food to local food pantries.



Friday evening, the Woodhaven High School Hockey team lent a hand loading \$4,800°° worth of groceries purchased at Aldi's on two buses.
