DELEGATE CERTIFICATION FORM PROCEDURE (form on next page)

On the next page is the Delegate Certification Form on which to designate your club's delegates and alternates to the 108th Annual Michigan District Convention, to be held online August 16, 2025.

District Bylaws provide the following in Article VI, Sections 6, 8 & 9:

Section 6. At any District convention, each club shall be entitled to seat up to three (3) delegates, two (2) of whom shall be the president and president-designate, as well as nominate three alternates who may serve if any delegate is absent. Club delegates and alternates shall be active of the clubs they represent. However, the Lieutenant Governor or a Past Lieutenant Governor may represent any club in their division not otherwise represented by three delegates. Delegates shall be elected by each club prior to the convention and certified to the District by the club president and secretary. A current or past Lieutenant Governor representing a club may be certified by the Credentials Committee, or its designee.

Section 8. All officers and past Governors of the District who are active members of a club in the District shall be delegates-at-large to all District conventions.

Section 9. To be accredited, a delegate must have paid a convention registration fee.

Clubs are encouraged not to name a 2024-25 Lt. Governor, Lt. Governor-Designate, a District Chair, or past District Governor who is a member of your club as either a delegate or alternate as they can vote as a Delegate-at-Large.

If you desire to have the current or past Lt. Governor in your division represent your club as one of your delegates, the form below will be used to certify them as delegates. They should be entered into the box provided, **not** in the club delegate area. ***Please make sure this person has agreed to represent your club prior to entering their name.*** This person should not be a member of your club. The form **must** be signed by **both** the president and secretary of your club.

Please complete and return the signed form to the District Office at the earliest possible date, but before **August 1, 2025**.

No delegate may receive credentials for any club that has any indebtedness to Kiwanis International or the Michigan District.

This delegate form must be signed by both the club president and secretary. Forms not signed by both officers will be returned for completion. It is not the option of the secretary to sign for the president or vice-versa. No forms will be available at the convention.
