Budget 2025-2026 Work Session

Presentation and discussion of the budgets recommended by Finance Committee.

Budgets for District, Key Club and CKI were reviewed. Gov. Brian had challenged the committee to present a balanced budget this year, leading to cuts in expenses. There is still a budgeted end of year revenue take from reserves, however, it is less than in previous budgets. The line by line discussion yielded two changes in the proposed district budget; 1) adding \$750 for the March Leadership Retreat for It. governors, an annual expense that had been overlooked; and 2) restoring \$250 of the \$500 cut from district administrator's contract for "district office part-time help" and it was also noted that the committee does not have the authority to change staff contracts without consent. There were no amendments to the Key Club and CKI budgets.

Governor's Report - Gov. Brian

This year's club opening goal set with President Mulhaul is four clubs. Several traditional clubs as well as four Voices clubs are planned. The Finance Committee was asked to budget enough under membership to pay the \$40 dues for each new member in the four Voices Clubs. This District funded "scholarship" for Voice club members is for the first year only. District goals for the year were also reviewed, as was the theme, "Kiwanis Rocks."

Motion by Webb, second by Prettyman to approval the governor's appointments of Key Positions and Standing Committees and Special Committees for 2025-2026. Motion carried unanimously.

District Foundation & Kiwanis Children's Fund

This is the annual agreement between the District and the Foundation to formalize a relationship for the purposes of managing and distributing charitable funds. No changes to the agreement were made this year.

Motion by Webb, second by Placzek to approve the 2025-2026 Memorandum of Understanding Agreement with the Nebraska-Iowa District Foundation and authorize the governor to sign. Motion carried unanimously.

Membership

1. Membership & Existing Club Growth – Michelle Musgrave

Club boosts and re-membership (reaching out to former members to rejoin) are being emphasized. KI has another training series planned for club coaching. An article sharing the signs of a strong club could be put together and shared with all clubs.

2. New Club Building in 2025 – Michelle Musgrave & Gov. Brian

Club building continues in Aurora, Nebraska and is also planned later this year in Gretna, Nebraska. The possibility of a new club in Centerville, Iowa is being explored. Club sponsors have been found for two Voices clubs, which are expected to be virtual clubs. Two more Voices club sponsors are being sought.

3. Club Closures - Brian & Lisa

Woodbine, Clear Lake and Seward Helping Hands clubs have provided notice they are disbanding. Lt. governors will be asked to report any other clubs even hinting at closing so a discussion with district leadership can begin before a dissolution vote is taken.

Other Reports

- 2. Tomorrow's Leaders Fund

Clubs without a SLP are encouraged to donate to this fund held by the District Foundation. The governor may request use of these dollars to support Service Leadership Program efforts.

Finance

1. Treasurer's Report - Curt Reis

Financials for the 2024-2025 fiscal year through Sept. 1 were reviewed. The bottom line on the District's financials should be better than anticipated at the August meeting. Expenses are down. It is anticipated that the entire fiscal year numbers will be complete soon. There was concern expressed that CKI financials didn't show a lot of activity last year.

Motion by Webb, second by Boltz to approve the treasurer's report. Motion carried unanimously.

2. Finance Committee Report – Curt Reis

No dates have been set yet for 2025-2026 Committee meetings but a quarterly schedule is expected. The investments through Edward Jones continue to perform well right now. Overall, there has been a 6.88 percent gain since inception in 2022.

Other Business

1. District Calendar and Board Meeting Dates

The calendar for the year was reviewed. Proposed dates for virtual board meetings on Jan. 24 and April 18 were confirmed.

2. Policy and Procedures

A. Finance, non-allowable reimbursement: At the board's Aug. 2 meeting, the Finance Committee reported the general concept of the proposed non-allowable expense reimbursements. The Finance Committee met Sept. 8 to finalize the recommendation to add into District Policy and Procedure. See Attachment A for recommendation. These would be applicable to all reimbursement requests, including those of SLPs.

Motion by Hames, second by Prettyman to add non-allowable expense reimbursement language to District Policy and Procedure. Motion carried unanimously.

B. Redivisioning: The committee appointed to change policy and procedures as needed due to Oct. 1 redivisioning is still working on this.

3. Bylaws and Resolutions

A. Amendment 1

The District's Bylaws are no longer in agreement with the Kiwanis International's Standard Form District Bylaws, which were updated last year. This amendment creates alignment and would need to be approved by the House of Delegates August 2026 to keep the district in good standing. See Attachment B for Amendment 1.

Motion by Weaver, second by Prettyman to support the passage of Amendment 1 to the Nebraska-Iowa District Bylaws and send it to the delegates for a vote at the Aug. 8, 2026 House of Delegates meeting in Council Bluffs, Iowa. Motion carried unanimously.

B. Voices Resolution

With the Kiwanis Voices pilot program having only \$40 dues for that membership type and Kiwanis International asking the districts not to ask for district dues for Voices members, a question of compliance with bylaws was brought up at the August meeting. Advice from Kiwanis International Governance and other international leaders was sought. Some districts have approved a resolution to address these discrepancies. A consensus was reached that a resolution for this district should be put together. Additional consideration is to take place at the January board meeting. Like a bylaw amendment, it would also need to go before the House of Delegates.

4. Grants and other special funds

Three special funds were being tracked by District Office in 2024-2025. The Mental Health Matters Grant was a success. An additional \$800 of district funds was added to the \$2,333 Kiwanis Children's Fund District Grant when response from clubs was higher than expected. These grant dollars were to fund service projects focused on children's mental health. Eleven clubs received funding for projects before the Sept. 30 deadline.

There was no change in LaRue Estate Funds since August meeting. Remaining balance is \$1,200 and the next four traditional Kiwanis clubs to open are each eligible for a \$300 service project grant.

The Growing Kiwanis Fund was closed as of Sept. 30. This fund was created in 2023 for the Growing Kiwanis pilot project. A transfer of LaRue dollars into this fund went unused for the pilot project and were spent last year to help SLP administrators with club building.

5. Regional Trustee Elections

Terms expire this year for Andy Webb in Region 5 and Barrie Tritle in Region 6. Per policy and procedure, the trustees and lt. governors in each region need to work with the district administrator to decide on election date and procedure by Dec. 15. Candidate applications will be accepted Jan. 2 through March 1. Elections should be held in April, May or early June.

6. Award and Scholarship Committee Report

John Boltz is chair of the committee this year and a committee will be named soon. The first application is for Achievement Awards, with a deadline of Dec. 1.

7. District Standing Update

All necessary reports following District Convention have been submitted. The 2023-2024 financial compilations for the District and the District Foundation have also been submitted as required.

8. Club Leadership Education and Club Leadership Chats

Dates for CLE and CLC this year have been scheduled. No divisions scheduled in person CLEs in 2024-2025 and expenses were less than total fees collected from clubs. These dollars will be put into reserve and used to purchase hybrid meeting equipment (AV) for the district. More hybrid meetings, including CLEs, are planned for this coming year.

9. KI Lt. Gov. Leadership Summit

Kiwanis International is planning a leadership summit for lt. governors in Indianapolis. There is a \$250 registration fee for the March 27-29, 2026 event. Hotel costs and meals in Indianapolis are covered through that fee. Transportation to and from the event is not covered. As this would be a great opportunity for lt. governors able to attend, there was agreement that the district should be willing to offer support and at least help with registration fee cost.

Motion by Webb, second by Hames to add \$1,000 to the 2025-2026 District Budget to help with registration fees for lt. governors attending the summit in March. Motion carried unanimously.

10. Leadership Event, March 14

The annual Leadership Retreat will be held Saturday, March 14 at Lake Wanahoo near Wahoo, Nebraska. It is anticipated that attendance will be capped around 75, which has been the average attendance the last several years.

11. International Convention Planning

A few people have already expressed interest in attending the convention June 24-27 in Manilla. It is expected, however, that less Nebraska-Iowa Kiwanians than normal will be making the trip so a district event at the convention is not budgeted. Since it is unknown how many lt. governors, trustees and district officers may make the trip overseas, this year's budget has a consolidated \$20,000 line item for convention under the governor's section. These dollars will be split out for district leaders' travel.

12. District Convention 2026 - Brian

The Mid America Center in Council Bluffs will be site host for the Aug. 7 and 8, 2026 convention. Planning is already underway. Hilton Garden Inn will be the convention hotel and is located a short distance from the MAC. The board's Friday morning meeting will take place there.

NOTE TO BOARD:

During the July 24, 2025 Finance Committee Meeting, discussion about non-allowable expenses took place. Committee members were in agreement that verbiage needed to be added into policy and procedure.

At the District Board's Aug. 2 meeting, the Finance Committee informed the board members about the general concept being proposed and asked for input.

The Finance Committee met Sept. 8 and makes the recommendation that the following be added to Policy and Procedure. The committee further asks that the District Board waive the 30-day policy for written notice and consider approval at the October Board meeting, given that the matter was reported and discussed at the August board meeting.

FINANCE PROCEDURES

Non-Allowable Expenses, Limitations & Modifications (Page 59)

The amount payable from any of the accounts discussed above is strictly limited by the budgeted amount as adopted by the District Board. The Board may modify the initial budget amount during the year in accordance with the District Policies and Procedures.

The District reserves the right to deem certain expenses non-allowable and adjust/deny reimbursement accordingly.

Non allowable expenses include the following

- Alcoholic beverages
- Airfare costs in excess of lowest available airfare (for example, above coach or economy)
- Rental cars (this does not include Uber, Lyft, etc.)
- Personal items, entertainment, snacks or non-event-related meals
- Travel or travel-related expenses for family members outside of the district; the exception being if the spouse of the governor or governor-elect is invited to take part in a training or office-specific event hosted by Kiwanis International

These items may be waived for district staff under specific circumstances and with preauthorized consent by the Executive Committee.



Nebraska-Iowa District Bylaws 2025-2026 Amendment 1

Purpose: To be in compliance with Kiwanis International's Standard Form For District Bylaws, the Nebraskalowa Kiwanis delegates are asked to amend the District Bylaws as follows:

- change wording on background checks for district officers and lt. governors from "clear" to "satisfactory. A background check need not be entirely clear to be acceptable. Satisfactory is a more accurate term; and
- 2) provide a more in-depth and encompassing definition of conduct unbecoming of a Kiwanian by including the updated definition in Kiwanis International Policy.

Effective Date: Oct. 1, 2026

Financial Impact: N/A

Proposed Amendments to Article 3, Article 7, Article 9

Deletions as indicated with strikethrough and additions as indicated by underline.

Article 3, Section 2

d. The Governor, Governor-elect, Vice-Governor, Administrator, Treasurer, Regional Trustees and Lieutenant Governors shall have and maintain a elear satisfactory criminal history background check conducted and verified by Kiwanis International.

Article 7, Section 4

- c. Qualified candidates for Governor, Governor-elect, and Vice-Governor shall:
 - Submit a signed agreement provided by Kiwanis International to fulfill the duties of office.
 - Have a clear satisfactory criminal history background check conducted and verified by Kiwanis International.

Article 9, Section 2

- **a.** "Conduct unbecoming a member of the Kiwanis family" is defined in Kiwanis International Policy as any conduct that:
- is incompatible with the best interests of the public or of members of the Kiwanis family; or
- tends to harm the standing of Kiwanis in the local or global community.
- Constitutes harassment of another individual based on race, color, creed, national origin, age, or sex, including sexual orientation and gender identity; or
- Constitutes a criminal act that is clearly incompatible with the best interests of the public or of members of the Kiwanis family; or
- Constitutes repeated offensive or obnoxious behavior at Kiwanis events and activities as determined by at least two-thirds (2/3) of the board of directors of a club or district as it relates to conduct unbecoming charges at the club or district level.

The Nebraska-lowa District Board supports the passage of this amendment and sends it to a vote at the
Nebraska-lowa House of Delegates annual meeting on Aug. 8, 2026 in Council Bluffs, Iowa.
