Relations at the University of Kentucky's Office of Public Relations and Strategic Communications and a Part-time Instructor in UK's Department of Integrated Strategic Communication.

Prior to his service at the University of Kentucky, Marc served nearly 13 years as the Associate Vice President for Public Relations at his alma mater, Eastern Kentucky University, and 12 years as Vice President for Communications and Marketing at Campbellsville University.

Marc is the author of the critically-acclaimed book, 'PR Lessons Learned Along the Way: Strategies, Tips & Advice for the Higher Ed and Nonprofit Public Relations Professional' (Cherrymoon Media, May 2020). Since its release, the book has been named a

During Marc's nearly 35 years in higher education, his work has achieved measurable results garnering over 40 honors, including back-to-back CASE Silver Medal Awards for Total Institutional Relations Program. In 2015, he received the James C. Bowling Excellence in Public Relations Award. Presented by the UK Journalism Alumni Association and UK Department of Integrated Strategic Communication, the award is given to the "outstanding public relations practitioner with ties to Kentucky." That same year, he received the Distinguished Alumnus Award from the Eastern Kentucky University Department of Communication and the EKU Golden Apple Award for Teaching.

Additionally, the Kentucky Music Educators Association District 11 presented him with its Friends of Music Award and CASE Kentucky with its Beth K. Fields Service Award for Leadership in Advancement.

He has consulted organizations including the National Association of Music Parents, Witnessing History Education Foundation, FMB Advertising, JW Pepper, and Christian Appalachian Project.

In previous years, Marc has served on the Association of American Colleges & Universities Advisory Council on Communications and Public Affairs (two of his eight years as national chair), CASE District III (Southeast US) Board of Directors, and the International Town & Gown Association Board.

A trumpet player for more than 50 years, Marc performs with and is a founding member of the Madison Community Band, a regional wind band of approximately 65 members, based in Richmond, Kentucky.

Marc, a native of Paintsville, Kentucky, and his wife, Jennifer, are the parents of three children: Emily Fields (Mark); Elizabeth Muncie (Christian); and Jacob; and the grandparents of Annaleigh and Aubrey Fields.

The Legacy of Mr. Rogers

Jeremy Holbrook

(Mr.) Fred Rogers was one of the world's most influential people over the last century. His unique ways of teaching, challenging, and encouraging both children and parents became the foundation and blueprint for educational public television. With over 900 episodes of his famous program "Mr. Rogers' Neighborhood", the 2018 documentary, and the 2019 drama film starring Tom Hanks; many of us have learned unique things about the world's most famous neighbor; but in this break out session we'll learn about what inspired Fred to become Mr. Rogers, his family background, his hometown (Latrobe, Pa), and the everlasting legacy that he ultimately left behind.

This workshop will be led by Jeremy Holbrook; the Founder and Director of "The Big Idea Camp"- a character development program in over 100 schools in Kentucky, West Virginia, and Ohio. Jeremy also partners with The Fred Rogers Center in Latrobe, PA helping them work with schools across the country.

How to Geocache for the Gems of Berea Jennifer Napier

Did you know there's a hi-tech adventure waiting at your fingertips - anywhere you go in the world? Have you heard of Geocaching & Adventure Labs? These are apps you can download onto your smartphone (free versions are available), and learn about local areas, see local sights, and become an outdoor adventure explorer no matter where you go. Geocaching is a hi-tech scavenger hunt that enables you to find actual containers camouflaged into a location. Once you find the item, you'll sign the log sheet inside and replace the container as you found it for the next person. A GeoTour is a specific set of geocaches in an area to find in which you can complete a challenge issued by a local entity (examples: National Parks, State Parks, Tourism, Chambers, etc.). An Adventure Lab typically offers a self-guided walking tour of an area which highlights local facts and history, but requires you to complete a sequence of stages by answering trivia questions you can only learn by visiting each stage. The Berea Chamber of Commerce host a GeoTour and an Adventure Lab and you're trip to Berea, KY won't be complete without learning about this 24/7/365, hi-tech and family friendly activity. Attend this session to learn more and how to get started.

AMENDMENTS:

KY-TN District By-law change that must be voted on at DCON. (housekeeping amendment)

The change: The Kiwanis International Board decided to eliminate the new member add fee and charter member fee, replacing both with prorated dues for new members. All districts in North America whose dues billing and collection is handled by Kiwanis International *must* adopt this change. Additionally, districts *must* use the same percentage schedule used by K.I.

A club will be charged prorated dues for new members on a diminishing scale based on what month they join. The following Sept. 30, the club will be billed full dues for all members.

Proration schedule: At this time, in order for Kiwanis to make optimal use of the new platform at the best cost for the organization, the schedule is expected to be based on 1/12 of the full dues amount per month.

District Bylaw Amendment(s)

The move to prorated district dues requires a change to Article X, Section 2, of the Standard Form for District Bylaws, which will now be amended to read as follows. This is the language your district should adopt in its bylaws.

Article X – Revenue, Section 2. New member add fees are charged by the district in an amount determined by [choose one: the House of Delegates or the District Board]. Prorated district dues shall be charged for each new member of a club on the same prorated schedule used by Kiwanis International.

WHEREAS, Sponsor and College desire to secure permission from Participant so they can attend the Event, participate in Event activities and to make the other agreements set forth herein.

NOW, THEREFORE, in consideration of Participant's attendance at the Event on the Berea College campus, and other good and valuable consideration, the receipt, mutuality and sufficiency of which is hereby acknowledge, Participant agrees as follows:

1. Participant signs this Agreement to evidence Participant's knowledge and understanding of the Event's rules and regulations as well as Participant's obligation to abide by provisions of these rules and regulations as well as the policies of Berea College and applicable law concerning personal responsibility and behavior all times during the Event, including transportation to and from the College campus. Participant has read all of Sponsor's materials and are familiar with College's policies (available online at <u>www.berea.edu</u>), including, but not limited to those prohibiting discrimination, harassment or other misconduct. If Participant does not conduct comply with these rules and regulations as well as the standards of the Sponsor, then the Participant may be dismissed from the Event.

2.
