Club dues (if not already paid) are now past due. Please pay your new member add dues when a member is added – don't wait.

Club secretaries, please complete online reports monthly by the 10th. The district needs your club information. Is your club's membership information up to date on the Dashboard?

What is Corporate Membership? (This is a repeat)

A corporate membership allows your club to add a local company or organization as a "member" via a designated membership of an owner or employee.

- • The organization joins the club as a member, following the usual process. You have the employee join (name of employee put into the data base) and mark the membership as corporation with the name of the company.
- • The company is represented at meetings and events by the designated employee. Only this person is allowed to vote and hold office.
- • If the designated employee changes jobs, a new employee can be designated to take his or her place without being charged a new member fee. The club lets KI know the information.

There is no limit to the number of corporate memberships a company may have in a club as long as each member has a paid membership. An employer can send different employees to the meetings, but only as guest of the corporate member of the club.

NOT filing your club's 990 tax form could make your club vulnerable to steep fines and penalties.

Are you willing to take the risk?

Form 990 is due February 15th.

Go to irs.gov and click charities and non-profit tab at the top of the page to find your required filing for form 990

Records indicate that several clubs in our district are in revoked status. This means that your club has lost the tax-exempt status. Please take time to make sure that your club does not fall into that category.

Remember, clubs with foundations are highly vulnerable.

All Kiwanis clubs are designated a 501(C)4

All Kiwanis Club Foundation's are designated a 501(C)3 and can only be used for service.

If your club has had their tax-exempt status revoked, please reach out to a CPA in your club or community.

Clubs with 27 members or fewer will be judged in Group I. Clubs with 28 members or more will be judged in Group II. The top 10 finalists will be determined for each class. The top three selections from each group will be recognized as the gold, silver and bronze winners at the 2023 Kiwanis International Convention.



MEMBER SPOTLIGHT ON Charles Ridenour



Charles Ridenour is an attorney and a very involved member of the Kiwanis Club of Sweetwater (Tennessee). His family could easily be thought of as a family of lawyers, although there certainly are those in his family who are not lawyers. Five or six members of his family were and are lawyers including Katie, his youngest daughter. His oldest daughter, Tracy, is a Certified Public Accountant (CPA).


Born in Lebanon, Tennessee, the eldest of four children. Charles grew up in Sweetwater, Tennessee. His father attended Tennessee Wesleyan College, where he met Charles' mother and then attended Cumberland Law School after graduation. They moved to Sweetwater where he practiced law. Charles' mother was a third-grade teacher for 43

years. His siblings became successful individuals in their various fields – a banker, an entrepreneur and a teacher. His sister, now deceased worked at a local chair company. His wife Kathy is retired from the Department of Human Services.

Charles entered elementary school in Sweetwater and he completed all 12 grades in the Sweetwater Public Schools. Asked if he was a good student, perhaps even valedictorian of his graduating class, he responded, by denying that he was valedictorian and with characteristic "Ridenour humility and humor", (probably with a mischievous twinkle in his eye) he said that they let him out. He sang in the high school choir and performed in a school play. He had various part time jobs outside of school including one with the Sweetwater Utility Board which would eventually lead to an important professional relationship through his law practice.

It was scouting that caught his interest. At the age of eight he became a Cub Scout. As is typical of Charles with whatever organization he decides to become involved with, he became an active Cub and Boy Scouter. In his scouting career he earned many merit badges. He received several honors including the Silver Beaver Award, Award of Merit and many others. Ultimately, he attained the highest rank that a Boy Scout can earn and at age 15 he became an Eagle Scout. it is an accomplishment that is achieved and earned through hard work, creative thinking and industriousness. Throughout his lifetime he has continued an active involvement in

the scouting program.



Graduating from high school, he was accepted for enrollment in Tennessee Wesleyan College (now Tennessee Wesleyan University). It was decided that this would be where he was to go to college for at least two reasons. First, it was a good school and second it was 15 miles from home making it practical to live at home and commute. Charles studied hard and did well earning a place on the Dean's List. Graduating with a Bachelor's degree in Business Management, he entered the Nashville School of Law. While in school, Charles worked for the State of Tennessee in the Department of Revenue as an enforcement officer.

Charles met Kathy at a church picnic. He decided he wanted to meet her and approaching her, he introduced himself asking her for a date. She told him she knew who he was and agreed to go with him on a date. They attended the same church but he did not remember her although she knew him. In due time, they were engaged and married. Kathy is a graduate of Middle Tennessee State University. While Charles was in law school, she began her career with the Tennessee Department of Human Services from which she is now retired. Charles and Kathy have five grandchildren, which includes two sets of twins.

Earning his Doctor of Jurisprudence degree, Charles and his family returned to their hometown of Sweetwater, Tennessee where he has practiced law for 42 years. It is a small town and he does not specialize; he accepts a variety of cases, providing a wide range of legal services.

One of his jobs while in college was with the Sweetwater Utility Board, an institution that later assisted him in other ways. All through college he worked each summer for them.

They allowed him to work on holidays and breaks as he could and that job helped pay for his college education. That relationship was continued in his law practice; he is counsel for the Sweetwater Utility Board. As important as that professional relationship is, it should be understood that he is also counsel for a number of other organizations.

Charles keeps busy serving a number of local organizations. There is some travel, especially to Kiwanis conventions and conferences, and for a hobby, he loves to work in his yard






BOONE COUNTY KIWANIS MAKING A DIFFERENCE Submitted by Steve Sturgil
