Do all your club members know the District in which their club is located? Do they know the name of the current KY-TN Governor? If not, you could do a club orientation for your members!

To be a club in "good standing" any financial obligations (for example, dues or new member dues) must be paid. Your club must be in "good standing" to be eligible to have delegates at both the KI Convention in June and the KY-TN Convention in August.






#### A NEW KIWANIS CLUB IS BEING FORMED

We were saddened to learn that Past First Lady Joan Kleine recently passed away (March 2) following a number of serious health issues.

Born in Minnesota, Joan and past Governor Glen Kleine met and 62 years ago they were married. They resided in St. Louis before moving to Richmond, Kentucky where he was employed as a Dean at Eastern Kentucky University.

An elementary school teacher, she supported Glen in his work with Kiwanis and she eventually joined Kiwanis herself. Service was important to her. She served Kiwanis and her fellow Kiwanians as vice president and president of her Richmond club,

eventually serving Division 9 as lieutenant governor. Joan served her community in many ways: as a 4-H leader, Cub Scout leader, Madison County library board member, and the *Foster Care Review board for the State of Kentucky* in 13 counties. She was active in *CASA* (Court Appointed Special Advocate) and the *Cecilian Club*.

Family was important to Joan and that included her Kiwanis family. The love of young people which she also shared with Glen was profound. Of course, there were their own children, grandchildren and great grandchildren, but there also there were foster children, hundreds of Madison County students, Eastern Kentucky University students, and International students. It was especially important to Joan to make International students feel that her home was their home away from home and she maintained contact with many of them even after they returned to their own country.



Kentucky-Tennessee Kiwanians will remember Joan as that enthusiastic, energetic, friendly, smiling, Kiwanian in the electric cart always ready to help and to support others. Health issues made it necessary for her to move from place to place in that electric cart, but that didn't slow her down. She often arrived at a location, ready to go to work before the rest of us got there. We are going to miss Joan at our Kiwanis conferences and conventions. It just wasn't the same without her at the most recent Mid-Year Conference (March, 2023) that was convened in Alcoa, Tennessee this past week. Her life, her work and her enthusiasm will serve to inspire the lives of the rest of us as we follow her example in serving our communities and our children. Rest in peace, Joan.

## MEMBER SPOTLIGHT ON Jim Coltrin



Fort Oglethorpe, Georgia is very close to the Tennessee-Georgia state line and is approximately a 15-minute drive from Chattanooga, Tennessee. Jim Coltrin lives in Chattanooga but is a member of the Fort Oglethorpe (Georgia) Kiwanis Club. Jim has resided in Chattanooga his entire life and has lived in only two houses (more about that below). He has one older sister who is a physician in Knoxville. His father who is now retired, owned a carpet yarn company. His mother, also retired, had a wholesale nursery.

Jim's student life took a turn for the better when he was a high school freshman. He attended Westview Elementary and Ooltewah Middle and Ooltewah High School. He was a cross country runner on the high school track team, being 13<sup>th</sup> in the county, and he was a pretty good trombone player in the high school band. He worked several odd jobs including landscaping for his mother. He worked a few years as a retail sales person for a local sporting goods store, and he worked during the summers driving a heister for his father's carpet yard business. However, academically he viewed himself as a below average student. Then a lady about whom he can remember little, at an unusual pep rally he never completely understood (it was not connected to the athletic teams), offered \$100 to the student who would raise his/her grade point average the highest. To Jim, \$100 sounded very appealing and he was motivated. He went to work, raised his grade point average significantly, and won that \$100. That became the starter for him and he continued being a very good student for the remainder of his academic life.

Many of us have another person or persons to thank for helping us become what we are. The lady who awarded Jim the \$100 was, for him, one of them. Another was his high school freshman and sophomore algebra teacher; mathematics became his best subject. She apparently challenged her students, and Jim said, "She pushed me hard." He has wanted to contact her and tell her how much he appreciates what she did for him, but he has never been able to locate her.

#### **MEMBER SPOTLIGHT**

Upon graduating from high school, Jim continued his education at the University of Tennessee Chattanooga where he majored in Business Finance. That university was chosen because it was close to home and he was engaged in his father's business. Concerning university social life, he was non-traditional. When he was not taking classes or studying, he was spending his time building a house. It was finished during his junior year. Jim is very proud of that house and his accomplishment. He should be, and it is only the second house in which he has ever lived — his parents' house being the first – and he still lives in the house he built.

Jim's family is very important to him. He first met Penny, who attended a different college, at a Super Bowl party and with introductions they each moved on. It was later that they met again, this time at a Christmas party. Their relationship blossomed and it wasn't long until they were married. Rather than paying to use a private facility in which to get married, they built a pavilion behind his house for the ceremony; that pavilion was later converted into a large outdoor kitchen area. Penny is a sixth-grade teacher in Chattanooga. There is a daughter who is a teacher in South Carolina and two sons who are in high school.

He loved mathematics, and Statistics was one of his favorite subjects. A professor encouraged Jim to be involved in a program in which he learned how to do investment portfolios. That experience cemented his love of that business and following his university graduation he secured a position with Edward Jones, working there for approximately four years. He moved from Edward Jones to Raymond James. He is now the managing partner and owner of *True North Advisors* branch of Raymond James Financial, the Chattanooga office for that firm.

His dad had once been a commercial pilot, resigning from that job because it required him to be away from home and his family too much. When Jim was 10 years old his dad took him to the airport and introduced him to an airplane he had rented. Placing him in the pilot's seat his dad got into the other seat and that is when the flying lessons began. Jim took his first solo flight when he was 17 years old. Those were important years to

Jim as he bonded with his father. The lesson was well learned and he is using his dad's example to bond with <u>HIS</u> sons. Jim continues to fly and has used that skill to travel to many locations in North America.

Jim often flies to Kiwanis district conventions and conferences. On one such occasion he, Lynn Fant, and P.R. Cook were planning to fly to a district convention. There were friends attending that convention who were expecting them and when they did not appear, their friends became anxious. A phone call from Jim relieved those anxieties. He reported that he had inadvertently left a gas cap somewhere in Chattanooga, not on the airplane. Those of you who are pilots will immediately understand that forgetting to put the gas cap back on an airplane is not a good idea. However, be assured that Jim possesses adequate wisdom when he flies and as a pilot he has wisely and successfully dealt with many potentially stressful circumstances.

In 2000 while he was working for Edward Jones, a client who was a Kiwanian invited him to be a guest at a Fort Oglethorpe club meeting. Edward Jones is a community minded company that wants their employees to be community minded. Therefore, Jim did not hesitate to accept that invitation. He was highly impressed with what he found Kiwanis to be, in the meeting and in its projects. P.R. Cook encouraged Jim to join. Steve Phillips was also a positive influence. Jim found the meetings to be inspiring when, for example, one member who was a professional baseball player brought professional athletes to club meetings. Jim accepted the invitation to join and the rest is history.

Jim involved himself in the Kiwanis projects in that small but active club. One project was the golf tournament. Funds raised were used to support a Key Club sponsored by Fort Oglethorpe Kiwanis. In other projects, Kiwanians went to a number of schools to improve school playgrounds, and they supported a literacy center. Jim quickly became involved in these projects. A year later Jim was asked to run for office and he was elected vice president. Jim was on his way to being president-elect and president. Eventually Jim became lieutenant governor of his division, a position that he enjoyed very much. He enjoyed meeting new people and found Kiwanians to be welcoming and open individuals. Jim served his club again as president from 2021 to 2022.

Family is important to him and he wants to be able to spend quality time with Penny and his two sons and yet he is a busily active serving his community. He is vice president of the *Symphony Board*; he was quick to humorously assure us that he wasn't playing his trombone in the symphony orchestra. He also stays active as a board member of the *Joe Jackson Memorial Scholarship Foundation*. His position with Raymond James became busier due to increased responsibilities when his business colleague suddenly and sadly passed away.

Jim is considering his present and his future. He has flying as one of his hobbies and he has pursued kayaking. Much of what he does outside of the office involves his family. They spend as much time as possible at the lake swimming and scuba diving. He is considering a return to the trombone; he was not asked whether his family would be able to tolerate that. There is the attraction of travel. Jim and his family have already traveled to Europe, Canada and South America and they want to travel more. He remembers what his father did for and with him and he hopes to interest his sons in aviation and perhaps as they become adults, they will go into business with him. One thing is definite. Jim Coltrin continues to be interested in Kiwanis and hopes to do more. We all should observe this man. Who knows? He may be KT governor someday.

#### SATURDAY GENERAL ASSEMBLY AND WORKSHOPS

Governor Dwight presided at the Saturday morning General Assembly. He introduced several Kiwanians who gave reports to the assembly.

Finance Committee Chair P.R. Cook and Membership Committee Chair Carol Wisdom gave positive reports on the status of the Kentucky-Tennessee District of Kiwanis (KT). P.R. said that the KT District is doing well financially. Carol said that she was encouraged by our membership, and she charged us all with the responsibility of maintaining and growing Kiwanis.



Key Club Administrator Steve Phillips introduced our speaker, Key Club Governor Dalton Adams. Governor Dalton is the only KT Key Club Governor to serve two terms. Steve said that Dalton could have been International Key Club President but instead, Dalton decided he wanted to stay with the KT District Key Club. Governor Dalton announced that in spite of the COVID Pandemic, Key Club membership has grown to an all-time high of 4,546. Additionally, there was an increase in the number of projects at the Key Club Convention. Governor Dalton expressed appreciation for the support he has received, and he had high praise for all Steve Phillips has done for Key Club in the Kentucky-Tennessee District.

Strategic Planning Chair Bruce Damrow reported that the new Strategic Plan is now available for Kiwanians to view. Bruce recognized his other committee members who are Sue Fleschner and Leatha Catron.



Secretary Fran gave an attendance report for the 2023 Mid-Year Conference. There was a total of 100 people registered for the conference that included 79 full registrants, seven who were not full registrants and 14 guests. Fran said that contacting Kiwanians was somewhat difficult because of incorrect email addresses and phone numbers. She urged the membership to be sure that the KT office has correct contact information. Fran encouraged Kiwanians to register for the August 17-20, 2023 KT Convention in Lexington, Kentucky. There will be another project that will send 25,000 meal packets to those in need. She urged clubs and individuals to purchase space in the 2023 convention brochure. She also urged Kiwanians to register to attend the 2023 Kiwanis International Convention in Minneapolis and said we need to support Chuck Fletcher in his bid for Kiwanis International Vice President. She cautioned clubs to be aware of bylaw changes that will be announced soon. Fran announced the resignation of Vivian Heaton who has been the KT Office Administrator for 16 years. She reminded everyone that Vivian has been a tremendous asset and will be greatly missed.

Mark Garman, Chair of the Leadership Development Committee introduced several Kiwanians who are now Certified CLE instructors. 2023-2024 presidents and secretaries are to take CLE training. There will be a number of training possibilities from which choices can be made including training from Kiwanis International, training by Zoom and in-person training in each Division.



International Trustee Chuck Fletcher thanked Kiwanians for their support of his candidacy for Kiwanis International Vice President. Chuck's theme is, "Building a Brighter Future." He chairs the International Membership Committee and he said that membership growth is of vital importance. We all need to be a part of the team and tell the Kiwanis story if Kiwanis is to grow. Additionally, Chuck reminded his audience that we need leaders – presidents, lieutenant governors, governors – and he encouraged Kiwanians to seek and accept leadership roles.


#### THE AWARDS LUNCHEON AND WORKSHOPS
