- 1. Approval of the club Agenda for March 2024:

- 2. Approval of the minutes for the board meeting of February 2024: Shawn Moved and seconded by Kathy and Shawn for approval, which was given without dissent
- 3.Review and Approval of Club Financial Reports as of February 29th, 2024: Nicole Moved and seconded by Karen and Curt for approval, which was given without dissent.

Notes: Nicole had nothing to add or modify in the report she submitted,

- 4. Secretary's report: Charles. We now have 99 members on the KI Roster, with one new member to add, Lisa Parshley. Member dues can be paid by credit card online. Nicole prefers to pay by check and asked that invoices be forwarded to her. At the time of this meeting, there were four invoices of \$76.41 each.
- 5. Bylaws. Charles had heard from PNW Kiwanis (Robert Munger) that KCO is not in compliance. There is a Bylaws work page. New Bylaws can now be submitted online. One starts with the "Club Bylaws" logo on the Dashboard. Who will take this on? New Bylaws must be approved by 1/3 of total membership. Electronic voting? Notes: Shawn has been working on this.
- •Monthly Reports to KI. Meeting KI requirements will take some time to figure out and accomplish. This will require estimates from the Thurston County Food Bank about the number of meals provided each month, and the number of KCO volunteers working at TCFB. Also, we will need the number volunteers and the hours worked in the gardens. Similarly for the Wood project. Monthly reports will be circulated to all board members, as it is now set up.

Notes: Charles will be pursuing all this in the weeks ahead.

OLYMPIA KIWANIS FOUNDATION BOARD MINUTES Submitted by Charles Pailthorp, Secretary

Called to Order: Shawn opened the foundation meeting at TK.

- 1. Approval of the Foundation Agenda for March 2024. After a motion and second by Derek and kt, these were given without dissent.
- *Approval of the minutes for the Foundation meeting of February 2023: After a motion and second by Kathy and Curt, these were given without dissent.
- 2. Review and Approval of Foundation Financial Reports as of February 29th, 2024: Nicole Moved and seconded by Charles and Jonathan for approval, which was given without dissent. Notes: nothing to add except that there will be some Caring for Kids additions to this report.
- 3. MOU between the Foodbank and the Kiwanis Foundation: Shawn/ Mackenzie This was approved with the abstention of Steve since is serves on the board of the TCFB.
- 4. Secondary WSECU bank account signatures: Shawn moved and Curt seconded that no second signature is needed for all budgeted items. Further expenditures will be brought by Nicole to the Finance Committee for a recommendation to the Board. On the Foundation account (...3702) authorized signers will be: Shawn Myers, Matthew Grant, Jonathan Lindsay, Karen Fraser, Nicole Muegge, Charles (Don) Leaf and (Erin) Mackenzie McCall. (Joellen Wilhelm will no longer have this authority.)
- 6. Open floor Community Services Grants: In an email to Shawn, Jane Field asked about use of the \$7500 for scholarships. These funds have not been used for scholarships in the past. We have used this for donations to non-profit foundations and organizations. Matt noted that while further scholarship funds are needed, it would be redundant to move this money to scholarships. KCO now awards fifteen \$1500 scholarships. Matt will convey to Jane's group, of which he is a member, that the board prefers that this money not be diverted to fund further scholarships, that the money is better used as it has been past years.

MORE GARDEN NEWS! By Makenzie McCall

With the help of the Calliope crew, we planted several thousand onion starts. The radish, carrots, and spinach are starting to come up in the high tunnel. At the West Side, we are starting to prep the field for future cucumbers, parsnips, and beans. The high tunnel is a work in progress, we hope to have finished by the end of May for tomato plants.

The consistent, dry weather has allowed us to mow, till, and prep the fields for Spring Planting.

More onions went in this week at Calliope. Lettuce is starting to get planted at the West Side, and the greenhouse crew has potted up hundreds of pepper and tomato plants. Some of these Solanacea will get planted at the Gardens, and the rest will get sold at a **Plant Sale we are hosting June 1.** We hope to raise a little bit of money to support the garden staff, while at the same time get plants into the community.

Marshall Middle School came out to the Capitol Campus on Friday to make up for the snowy MLK Volunteer Day. The students did a great job weeding the garlic, giving this loved crop room to flourish away from the weeds,

Saturday, the Olympia High Soccer Team came out to help us plant over 1,000 starts of broccoli, cauliflower, and cabbage. This was a huge push for crops that will be harvested late Spring

Olympia Kiwanis **Foundation Scholarship**

Patrick D. Sutherland 1922-1995

Patrick Sutherland was President of Olympia Kiwanis in 1994-1995. He served in both the Washington State House (1949) and Senate (1951) and was elected Thurston County (1952) Prosecutor five times, 1974-1994. In 1994, he started the Kiwanis Law Enforcemen Officer of the Year Award program which continues today.



Pat Sutherland was born in 1922. He graduated from the University of Washington in 1946 and received his law degree from the University of Washington Law School in 1949. In 1949, he was elected to the Washington State House of Representatives from Seattle's 37th Legislative District. He served one term in the House and then was elected to the Senate in 1951.

In March 1959 he resigned to accept an appointment to the Public Service Commission, now known as the Utilities and Transportation Commission. He served on the commission through 1966. He also served as President of the Washington State Association of County Officials (WACO).

Pat was Thurston County prosecutor from 1974 through 1994. He was President of the Olympia Kiwanis 1994-1995. While a member of Olympia Kiwanis Club, he began the annual club recognition of local law enforcement officers with the «Law Enforcement Officer of the Year» program. These awards continue to be given annually to honor those law enforcement officers in local agencies who make a difference in their communities and their departments.

Pat Sutherland collapsed and died exercising at an Olympia athletic club in August 1995. He was 73. Pat will be remembered for his positive attitude and cheerful countenance.

- 5. Derek will pursue the prospect of future collaboration with Chehalis Kiwanis and whether this club could align as a satellite club. Chehalis now has only 4 members. It also has history like ours with a boy's home.
- 6. Proposal from Org support.com for Board support: Shawn The cost would be about \$30,000 per year, which all agreed would be prohibitive.
- 7. Secondary WSECU bank account signatures: Shawn The Board already has approved that a secondary signature is not required for checks drawn on the KCO accounts. This was affirmed without dissent on a motion by Shawn that was second by Derek. On the Cub account (...7194) authorized signers will be: Shawn Myers, Matthew Grant, Jonathan Lindsay, Karen Fraser, Nicole Muegge, and Charles Pailthorp. (Joellen Wilhelm will no longer have this authority.)
- 8. Open Floor. Jonathan on Portal buzz: KI still promises the Engage program but has not said when this might be available. He will look further for alternatives. Karen F asked whether we might set up an alternative for one year? Is Google Group enough, Charles asked? Jonathan will continue to look at the "Member Day" alternative. Shawn asked that we have a plan to adopt before the end of April.

OUR GARDENS GROW! By Mackenzie McCall

The winter rains are finally starting to break, allowing us the opportunity to open the fields and spread manure. The biggest news for this year is welcoming our new Gardens Coordinator, now Field to Food Bank Coordinator, **James Wirth**, to the gardens! James joined the Food Bank Staff in December and is responsible for managing the Kiwanis Food Bank Gardens. He has already been working with volunteer crews this winter, cleaning up the fields, repairing fence line at Calliope, harvesting overwintered crops, and getting the gardens ready for the 2024 season.

The greenhouse at the West Side is already full of plants. Volunteers planted around 900 bok choi starts in the Calliope high tunnel. The other half of the high tunnel is seeded with carrots, spinach, arugula, and radishes. Peas are seeded at the West Side and we planted 960 row feet of potatoes at the Capitol Campus.

James and Mac used the Thurston Conservation District's manure spreader to fully cover the field at Calliope. James hauled 60 wheelbarrows of manure into the fields at the Capitol Campus so that the fields would be ready for potato planting.

These next few weeks (and beyond!) we have thousands of plants and seeds going into the ground. In order to ensure that we get everything planted, we wanted to give our volunteers a wider look at the next month. Please consider when you (and some friends!) come help us get the season started right!
