

BOARD NOTES by Jonathan Lindsay, Secretary

Approved Minutes: Sept. 25, 2025, Club Board Meeting

Date/Time: Sept 25, 2025 | 12 pm Approved by the Board via email Sept. 26, 2025 Attending: Matt Grant, Karen Fraser, Anna Knudson, Shawn Myers, Jonathan Lindsay, Debra Clemens, Steve Hall, Joel Hansen, Curt Steigers, Sarah Beth Hernandez Huot, KT Thompson, Derek Valley. - 1. The agenda for the meeting was called to order and approved.
- 2. The previous minutes were approved after revisions were submitted by Karen Fraser.
- 3. **Finance Report** The club is currently about \$10,000 short of its budget, though this is expected to be offset by payments received this month that will appear in the September report.

The club is close to about 60% of club renewals, with Jonathan working to track and remind members who have not yet paid.

MOTION PASSED. to approve the Finance report presented by Shawn.

3. Budget Proposal (2025-2026) Shawn presented the proposed budget, which included the following points:

Membership Dues: The budget is based on a goal of 100 members paying \$200 each in dues

Fundraising Need: To balance the club budget, approximately **\$4,300 in fundraising** is needed for the administrative side of the club.

Fundraising Ideas: Strategies discussed included a silent auction, possibly at the next installation dinner (a previous one raised about \$3,500), and smaller events like the pancake breakfast. Deb Clemens suggested an **online silent auction** for the foundation, noting its success for other nonprofits.

Lieutenant Governor Dues: \$300 was budgeted in anticipation of having a Lieutenant Governor, which is calculated at \$3 per member.

Leadership Education: No budget was set for the Continuing Leadership Education conference, but the budget can be amended later if someone expresses interest in attending.

Proposed Expenses and Changes

Reception/Lunch Coverage: Shawn proposed adding \$100 a month to compensate the person handling reception. An alternative suggestion was to cover reception's lunch which was generally agreed upon.

New Point-of-Sale System (POS): A proposal was made to purchase a **tablet for approximately \$200** to modernize and simplify credit card processing. The new system would use a portable card reader and an app, allowing payments to be toggled between the club and the foundation on the same device.

A motion was made and seconded to approve the 2025-2026 club budget. The final motion was amended to remove the \$1,200 compensation line item for the reception role.

Olympia Kiwanis Foundation Board Meeting by Jonathan Lindsay Approved Minutes: Sept 25, 2025, Foundation Board Meeting

Date/Time: Sept 25, 2025 | 12 pm Approved via email Sept 26, 2025



The Foundation meeting was called to order immediately following the Club meeting. Attendance the same as for the Club Board meeting.

- 1. The agenda was moved, seconded, and approved unanimously.
- 2. The previous minutes were approved, incorporating suggested process changes submitted by Karen that were approved by email.
- 3. Finance Report The Finance Committee recommended approval of the financial report, which included the following updates:
- *Investment Transfer: A \$3,000 balance in account 5525 was transferred to the investment at the Community Foundation, and this will be reflected in the September report.
- *Children's Cancer Donation: The Foundation collected \$425 for children's cancer, surpassing the \$400 budgeted amount, and this will be sent to Children's Hospital. The final amount will be determined after the last collection lunch on Monday. *Johnson Fund: An additional \$4,240 was withdrawn from the Johnson Fund to cover half of the cost for "the well," and the payment check has already cleared the bank.

MOTION PASSED. to approve the Finance report presented by Shawn.

4 Foundation Proposed Budget

A motion was made and seconded to approve the 2025-2026 Foundation budget. * Don Law Estate Sale Contribution

The Foundation is expecting an "exceptionally generous" contribution from the Don Law estate sale.

KT will meet with the daughter on Saturday to receive the check and bring it to the Monday meeting.

- * Designated Purpose: The proceeds from this donation will go toward the Caring for Kids fundraiser.
- * Thank You Letter: Matt Grant (President) will write a thank-you letter to the Don Law family, and KT will provide the necessary mailing addresses for the family members, who are dispersed in different locations.
- **5. Caring for Kids Fundraiser**, As of August 31st, the Foundation has collected \$14,000 for the Caring for Kids fundraiser and is still "quite a ways" short of the overall goal (\$22,000). The previous "Raise the Paddle" event generated an unbudgeted \$5,000. The upcoming "Raise the Paddle" at the event on the 2nd will be applied to the next fiscal year's fundraising goal.

Note: with the \$5,005 raised at the Don Law Estate sale, this brings us to a total of \$19,005.

- **6. Day of Caring.** KCO will participate in United Way Day of Caring on 9/26 with over 60 volunteers at gardens and woodlot.

SO Long, for now, by outgoing **President Matt Grant**

As President, I've learned something simple but powerful: our work matters. In a time when national politics often feels paralyzed, it has been a joy to focus on what truly makes a difference, our community, and the way we come together to serve. As I step down, I feel enormous pride in what our club has accomplished this year.

Earlier this year, when federal cuts to USDA programs strained the Thurston County Food Bank (TCFB) and our local farmers, the need for food was greater than ever. At the same time, the Food Bank was seeing a steady 5–7% weekly increase in first-time clients. In the face of that challenge, our Olympia Kiwanian Garden volunteers rose to the occasion. Typically, we provide about 23,000 pounds of produce each year. This year, we are closing in on 40,000 pounds, nearly doubling our impact. Special thanks go to our new Farm Manager, Jess Colson, and to Derek Valley, Don Leaf, and every volunteer who made this possible. You met a moment of crisis with extraordinary generosity.

At a time when many service clubs are shrinking, ours has held strong this year. We welcomed ten new members this year and continue to hover around 100, a number that has remained remarkably steady for over a century. That growth is thanks to the quality of our programs and the personal connections each of you foster. Our future is bright because you keep inviting people into this work.

We have seen a legacy of charitable support from our members this year. Thanks to Kathy Thompson's coordination with his family, we received \$5,000 from **Don Law's** estate sale, in addition to a \$5,000 gift Don himself made earlier this year. Additionally, with the continued benefit from the Leighton **Johnson Fund**, our scholarship program has expanded to twelve awards recognizing service, leadership, perseverance, and vocational talent among local youth.

This year we also launched a new tradition: combining our Officer Installation with the Key Club Installation. . (continued on page 6)

Olympia Kiwanis Foundation Scholarships

Robert W. (Bob) McKay 1910-2007

Bob McKay was a 60 year member of Kiwanis and a leader of youth programs. He organized the Millersylvania Youth Camp and taught horticulture to many people.



Bob McKay was born in Portland, Oregon in 1910 and grew up in Puyallup, Washington. Bob graduated from Stadium High School in Tacoma in 1929 where he was a star end and pass receiver on the football team. His wife Beth Buchanan was a special education teacher in Olympia. They had five daughters.

Bob graduated from WSU in 1933 with a BS in Agriculture, after studying agricultural economics and poultry science. Worked for the Farmer's Home Administration from 1934 until 1947 in Pierce, Kitsap, Cowlitz, Wahkiakum, and Lewis Counties.

Bob retired after nearly 27 years as chairman of the Thurston County Cooperative Extension Service on June 28, 1974. During his long career, he assisted in organizing marketing cooperatives for land clearing equipment, breeding associations, and farm forestry groups. He also assisted in organizing the Millersylvania Youth Camp, the Thurston County Cattlemen, a horticultural association, and others.

He was past president of the Washington State County Agents Association and was winner of the National County Agents Association's Outstanding Service award. He also produced 5000 Christmas tree a year on his farm on Black Creek, southwest of Olympia as a member of the Northwest Christmas Tree Association and was active in Christmas tree research. Besides being an ardent handball player, golfer, and fisherman, Bob was a mountain climber with many major peaks to his credit. Bob died at home in Olympia, Washington at 98 years of age, on December 14, 2007.

AP30: KIWANIS BUDGET DEVELOPMENT PROCEDURE:

AP30:01 In August of each year, the:

- •President-Elect and Club Treasurer begin development of initial OK Club and OK Foundation budgets for the upcoming year based on actual experience of the previous 12 months. Incorporate known changes for the upcoming year (usually new programs, dropped programs or change of program emphasis) and input from all Committee Chairs.
- •Finance Committee reviews and makes recommendations.
- Board of Directors receives and considers initial draft of budgets.

AP30:02 In September • President-Elect and Treasurer incorporate all input. • Finance Committee (FC) reviews and makes recommendations. • Board of Directors considers and adopts budgets.

AP30:03 In April. • President and Treasurer review actual financial Year To Date data with special attention to results from Harbor Days and poinsettia fundraisers, and develop necessary midyear changes to the budgets.

- •Finance Committee reviews and makes recommendations.
- Board of Directors adopts changes to the budget.

Membership Committee Survey Results from Krystal Kyer

The Committee received 48 survey responses - online (25) and paper (23). Summary of responses:

- 1. Why did you join? HALF of the respondents said they joined because someone they knew asked them to. Others joined for their work, for opportunities to volunteer, or to support kids.
- 2. Why do you stay? networking /meeting new people, friends, volunteer opportunities / community service (garden, Key Club), to be informed/educated on issues in our community. The survey responses were similar whether they were completed on paper at the lunch or online.

What does this mean moving forward?

- * The KCO membership growth and education committee should promote ways to support member recruitment and retention, including the following:
- * Recruitment: Encourage current members to invite guests to events, share why they joined and what they/we do, and personally invite people to become members. If members stop sharing and asking, our membership will drop by half. Conversely, if more people asked others to join or asked one more to join then our membership could significantly increase.
- * Retention: Continue to offer community service opportunities including key (!) activities such as the food bank gardens and Key Clubs at high schools.

Retention: Continue to offer education programs and social opportunities such as (but not limited to) the lunch meeting.

Jess, along with Ethan, Willow, Jules and an invaluable set of volunteers have started what can be described as "fall harvest".

All three gardens have abundant crops waiting to be picked, cleaned, weighed and delivered to the Thurston County Food Bank for client families in need. Many of these crops are storable for future use, some are for fun, including pumpkins for the kids. All of our produce is valued.

Thurston United Way "Day of Caring" (September 26) included volunteers from Target Distribution Center, Backlund, Mistry Law Firm, St. Johns Episcopal Church, The Evergreen State College, Lifespan Construction and Thurston Young Professionals.

Volunteers from these organizations joined our corps of volunteers to harvest: 410 pounds of carrots (Capitol Campus)

127 pounds of beans (West Side)

75 pounds of beats (Calliope)

And a yet to be weighed harvest of squash from Capitol Campus and Calliope. In addition, the volunteers helped clean up the garden spaces. It was a very productive day; we appreciate the help!

Ethan, Willow and Jules are finishing up their Thurston County Food Bank employment with us. We will miss their spirit, assistance, knowledge and strong backs. We wish them well on their next ventures.

With the loss of Calliope Farm acreage at the end of this year, we have been looking for additional garden space. Several potential spaces have been identified and during the coming months we will make a decision of which garden space will fill our needs and be added to the two garden spaces we have at the Capitol Campus and the West Side gardens. Along with Jess, **Don Leaf** and **Joel Hansen** have been very helpful in this process.
