### Minutes of the Kiwanis Club of West Charleston Board Meeting August 14, 2025

In attendance were Board Members: Royce Tanner, Bill McDonald, Sharen Deitz, Betty Deneault and Ted Streit.

The July 17, 2025, minutes were reviewed. Various typos were discussed and then upon a motion by Sharen to approve the minutes as written with amendments and seconded by Betty, they were approved by unanimous consent.

Treasurer Ellen Bullock's report was reviewed. It showed that the Activity Account had income of \$3,294.50 and expenses of \$99.00 for the month of August, which gave an activity August ending balance of \$8,384.19. She reported the Administrative account had an income of \$1,700.08 and expenses of \$0 for the month of August, which gave an administrative balance of \$2599.80. After discussion the report was approved, with a motion by Betty and second by Sharen. A review of who has paid and not paid for the Corporate Regatta, was made. Members agreed to contact the parties who have not paid and see if we can get their payments before the next board meeting.

#### **Presidents Report** - Royce reported on the following:

The Capital District Convention is scheduled for August 21-24, 2025 in Arlington, VA. She suggested that the club set up a table to showcase our club. The board approved the placement of a table at the District Convention. Royce said she would design it. She then asked for advice on the use of the Club's 2022 5K T-shirts that have been sitting in the storage container since the race. It was decided to distribute them to area after school programs for their use. Ted stated that if anyone talks to an afterschool program coordinator and gets a number of shirts they would like, he would deliver them.
