The Redivisioning Task Force has been tasked with proposing names for the new regions for the March 3, 2023 Board of Trustees Meeting.

The Bylaws & Policies Committee has been tasked with making a recommendation on what to do with Trustee Roger Diehl's seat on the Board of Trustees given that his home club has been moved out of the region he was elected from. Their recommendation along with guidance from Kiwanis International will be presented to the Board of Trustees at their March 3, 2023 meeting.

- Motion made by Trustee Pippin that the Capital District partner with the Pacific Northwest District on a joint ICON Dinner aboard the Minneapolis Queen on Friday, June 23, 2023 at a projected per person cost of \$75. The boat holds 95 people, Capital would be allocated 60-65 spots on a first come, first served basis. ***Motion passed unanimously.***
- Motion made by Trustee Pippin that the Board of Trustees ratify Governor Wolff's appointment for the remainder of the 2022-23 year of Jana Stock for the position of Facebook Marketing Specialist. Ms. Stock would be paid for her work supporting existing club membership boosting efforts on a monthly basis out of existing funds in the Membership Committee line item of the District budget. ***Motion passed unanimously.***
- Motion made by Governor-Elect Lamb that the Capital District allocate its Kiwanis Children's Fund Grant of \$4,319.00 to the 2023 District Convention Meal Packing Service Project in partnership with Generosity Feeds/The Replenish Foundation. ***Motion passed unanimously.***
