Approval of Agenda & Past Minutes

With all board members in attendance, Governor Wolff announced that the board had a quorum to conduct business.

- Motion made by Past Governor Gardner to approve the agenda amended to add committee reports. ***Motion passed unanimously.***
- Motion made by Governor-Elect Lamb to approve the minutes of the November 19, 2022 Board of Trustees Meeting. ***Motion passed unanimously.***
- Motion made by Past Governor Gardner to approve the minutes of the January 28, 2023 Special Board of Trustees Meeting. ***Motion passed unanimously.***

Agenda Point: Finance - B&P Clubs in Good Standing

- Motion made by B&P Committee to update policy code 2B(c) to remove references to outdated KI procedures. ***Motion passed unanimously.***

Agenda Point: Finance - LTG Requirements

- Committee Recommended no change.

Agenda Point: Meetings - 2023 Leadership Team Training Conference

- Motion made by Past Governor Gardner to approve the contract for the 2023 LTEC to take place at the Hyatt Place Richmond - Arboretum from June 2-4, 2023. ***Motion passed unanimously.***

Agenda Point: Meetings - 2024 Capital District Midyear Conference

- Motion made by Trustee Pippin to approve the contract for the 2024 Midyear Conference to take place at The Resort at Glade Springs in Daniels, WV from March 8-10, 2024. ***Motion passed unanimously.***

Agenda Point: Finance - Redivisioning Task Force

- Motion made by Trustee Moore to approve the recommendations of the task force.
 - Divisions 1, 2 & 3 remain unchanged as National Capital Region
 - Divisions 4 & 8 become a new region to be named via contest.
 - Divisions 5 & 6 become a new region to be named via contest.
 - Divisions 9 & 10 become the Heart of Virginia Region.
 - Divisions 12, 13 & 14 remain unchanged as Southeast Virginia Region
 - Divisions 15, 16 & 17 is changed to Southwest Region
 - Divisions 18, 19 & 20 remain unchanged as West Virginia Region

Motion passed. Trustee Moore abstained.

- Governor Wolff directed the Task Force as its final act to administer the naming contest for 4/8 and 5/6 and report naming recommendations to the District Office by April 29th in time for a ratification by the Board of Trustees at its May 2023 meeting.
- Governor Wolff directed the Long Range Planning committee to develop a standardization for the size of Capital District Kiwanis Region so it can be codified in policy.
- Motion made by Trustee Hiscock to permit Trustee Roger Diehl to finish the remainder of his three-year term ending September 30, 2025 on the Board of Trustees representing the new Div 4/8 region to be named later. ***Motion passed unanimously.***
- Motion made by Trustee Gillette to permit Trustee Jamie Moore to finish the remainder of his three-year term ending September 30, 2025 on the Board of Trustees representing the revised Heart of Virginia Region. ***Motion passed unanimously.***
- Executive Director Wolff will facilitate an online election after the Midyear Conference for Divisions 5 & 6 to elect their Trustee to a three-year term starting October 1, 2023.

- Motion made by Trustee Hiscock to accept the resignation of Division 14 Angela Hollingsworth that arrived via e-mail during the board meeting. ***Motion passed unanimously.***
