ANNOUNCEMENTS

Gary Vander Meer thanked everyone who rang a bell for the Salvation Army last weekend. We spread good cheer, raised money for a worthy cause, and didn't get frostbite this time. Thankfully, it was warm and dry over at Schnuck's.

Bill Finuacane reported that last week's Freezing for Food campaign brought in 5,917 pounds of food, and donations of \$16, 969 to stock local pantries. That raises the overall value of this season's contributions to \$141,669. Once again, Bill and TD Ryan weathered the arctic cold.

PROGRAM

Shadow Gentry introduced Tom Matya, Executive Director for the past five years at Opportunity House, an agency that's helped provide work, safe affordable housing, and life-skills training for people with developmental disabilities in northern Illinois.

Over the last 60 years, Opportunity House has expanded its network of services to serve more than 180 clients currently. Most — 102 — are signed up for weekday programs that offer limited paid employment; some are now living in group homes with full-time professional staff. There is, of course, a waiting list — the agency is adding some housing, refurbishing older homes — but there are more applicants than there are spaces.

Opportunity House directs the Special Olympics program here in DeKalb, and helps clients schedule and find a way to get to medical appointments.

Tom noted that Opportunity House faces some key challenges this coming year, and is about to launch a major capital campaign.

For one, new employers coming to DeKalb — META, and other big operations — are able to offer higher starting salaries than not-for-profit agencies. This makes it more difficult to recruit and hold on to qualified staff.

For another, new legislation — the Dignity in Pay Act — takes effect quite soon, and this will have a major impact on clients who are hired through the agency. For many years, Opportunity House has contracted with companies — such as Ideal Industries — to offer supervised, paid work to disabled adults. Clients at the agency's workshop are paid for each switch or gadget they assemble, rather than a set amount per hour, since some workers are able to produce a lot more items than others.

The Dignity in Pay Act will end that practice, and though its intent — to raise the minimum wage for the mentally handicapped — is hard to dispute, most local contractors are already pulling away. Piecework at Opportunity House is down to half of what it once was.

This means that the agency will have to redouble its efforts to find community employment for the clients it currently serves and those who come to the door. Opportunity House's capital campaign will help create a new workforce development and training center. This will include a STEM exploration program (the first of its kind in the state), updates to the gymnasium, and an auditorium for group presentations.

Tom pointed out that Opportunity House is far more robust and better supported than almost any comparable program anywhere in the U.S.
