#### Highlights of the Thursday, 05 November, 2024 Weekly Meeting

President Nancy, welcomed all members and Guest Speaker, Jennifer Stebbing, Partner in the law firm of Stebbing Butcher

Graham Schram started the 50/50 draw, with Faye Prince and Judy Jones holding potential winning tickets, however no one picked the Joker from the available cards. The pot continues to grow.





Linda Moyer introduced Jennifer Stebbing, Partner in the law firm of Stebbing Butcher who spoke on the subject of Wills. Jennifer is a Certified Specialist in Estates and Trusts. No other lawyer in Ontario holds this specialist designation combined with three law degrees (LL.B. from Ottawa, J.D. from MSU and LL.M. (Tax) Osgoode), and the TEP, CPCA, and EPC designations. She also holds a B.A. from Windsor in International Relations.





Linda acted as a some-what

impromptu Funmaster by looking up the meanings of the credential letters that Jennifer has as a lawyer, leaving a smile on everyone face.

Jennifer opened with the fact that Linda's Introduction covered everything that she had planned in the first slide other than, since this was a general presentation, it was not legal advice and the information discussed was not confidential. She thanked the Club for asking her back to discuss Wills.

Jennifer indicated that, Estate Planning is more than just completing your will, it takes into account:

- Tax implications income, capital gains and estate administration tax (probate fees)
- End of life planning and post death planning (funeral/burial/cremation)
- Wealth transfer considerations
- Family situations (blended families, international beneficiaries)
- Charitable bequests

Jennifer explained what a Will is.

- A written document setting out your wishes after death
- Appoints the executor/estate trustee
- Provides for the payment of debts
- Can set out specific gifts
- Sets out who receives what portion of the estate
- Can set up a trust for minors or other persons
- Can state any funeral/burial wishes



## WHAT HAPPENS IF YOU DIE WITHOUT A WILL



Jennifer suggested strongly that we should all pull out our wills and review them every 5 to 7 years. She followed by asking for questions, which produced a lively Diescussion period.

Jennifer was presented with our official, "Thank You", for her presentation by Paullette Hauk who indicated that, in recognition of Jennifer's presentation, we have made a donation to a charity we like to support. That charity is the Brant Community Healthcare System Foundation.

The podium was handed back to President Nancy who called for Committee Reports and Announcements

- Phil Hoekstra announced that the sign-up sheets for the Christmas Luncheon, Thursday 19 December, had been email to everyone, and copies were on each table today and would be picked up at the end of the meeting.
