Highlights of the Thursday, 28 August, 2025 Weekly Meeting

President Nancy asked Members with Guests and a representative from each Inter club in attendance to stand and be recognized.



President Nancy called Ken McNaughton to the podium who opened by announcing that our speaker today was Peter Bowen, VP, Tax and Retirement Research, Fidelity Canada, Toronto. Ken said that Peter also leads Fidelity's research into issues regarding planning for, and living in retirement. Peter will be speaking to us about, Navigating the Retirement Road map.

Ken then called on Shirley Thai who has worked with Fidelity for a number of years to give us some background about Peter Bower.

Shirley Thai gave a brief in site into Peter Bowen's experience. He has been with Fidelity since 1994. For the past 11 years, he has been listening to financial advisors and investors and studying their changing needs. Peter is passionate about helping Canadians of all backgrounds and at various life stages better understand Canada's evolving tax landscape and sharing insights on tax and investing strategies. He has been interviewed many times on various subjects relating to Federal Budget analysis, Canadian Retirement Report, Canadian Tax and Retirement Research, and is published on the Web, as well a webcast and podcast. Shirley then asked us to welcome Peter Bowen to the microphone.






Peter Bowen was warmly welcomed and summarized his background with Fidelity and proceeded to talk about Navigating the Retirement Roadmap by giving example what can be done. He outlined details needed, and their benefits, 5 years prior and 5 years after retirement by having your specific retirement goals being documented and put in place. He used terms such as Cash-flow planning where funds, to avoid being overtaxed can be transferred at different times of your life.

Peter reviewed life expectancy changes that have occurred in the last 15 year, and the fact that people are not retiring at 65. Today because people are living longer some people retire to play, then go back to school to learn something they wanted to learn and then apply this new knowledge, to a

part time job that they enjoy. This in turn increases the family over all wealth.

Peter covered a number of taxation points, using several personal examples to underscore the accuracy of the information.
