# 2022 RANDOLPH FREEDOM FESTIVAL

## EXHIBITOR REGULATIONS AGREEMENT

**DEFINITION: I/WE, MY/OUR, MYSELF/OURSELVES SHALL MEAN THE EXHIBITOR, WHETHER AN INDIVIDUAL, BUSINESS OR NOT-FOR-PROFIT 501(c)(3)**

I/we agree:

- that I/we will receive a 10' x 20' space consisting of a 9' x 20' parking space with extra space to fit a 10' x 10' tent.
- to bring my/our own tent, table and chairs. (Rentals of these supply items are not available.)
- to arrive for setup of my/our space between 12:00 Noon and 4:00pm on Thursday, June 30th, the opening day of the 2022 Randolph Freedom Festival ("the Festival"). Exhibitors must check in prior to setup with the Kiwanis Club of Randolph Township, NJ ("the Producer") No exhibitor will be permitted entry to CCM prior to 12:00 Noon without permission.
- to remove my/our vehicle from the exhibitor area of the Festival during setup by 4:30pm.
- to staff my/our booth during all hours of the Festival, including the Rain Date of Sunday, July 3rd from 6pm to 11pm, if all or any part of the Festival on Saturday, July 2 is cancelled for any reason.
- that electricity is limited to 1 (one) standard household hookup per booth (120 Volt/15 Amp). (Pursuant to New Jersey law, no extension cords are permitted unless SOOW-Compliant and no power strips or adaptors are allowed. Rental of SOOW-compliant cords is available for \$25 for three days.)
- that ONLY QUIET generators with ratings of 59 decibels or less are permitted. (Exhibitors intending to use a generator must first notify the Festival via email to: [arleneprice@optonline.net](mailto:arleneprice@optonline.net))
- that my/our tent will be properly weighted (e.g., with sand bags and/or cinder blocks) to ensure everyone's safety, and that I/we will not stake into the pavement.
- to offer for sale only NEW products, appropriate for a family-friendly event. I/we further agree that if the Producer in its sole discretion determines that my/our products are not appropriate for the Festival, the Producer may take any action it may deem necessary, including my/our expulsion from the Festival without a refund of any fees paid.
- that I/we will display and sell ONLY what I/we have listed on the application.
- that while the Producer will attempt to not have multiple vendors selling the same products, it is understood and agreed that exclusivity as to products sold is not guaranteed.
- that not-for-profit 501(c)(3)s may not sell items of any kind without the permission of the Producer. (They may only promote and educate.)
- to conduct myself/ourselves in a manner appropriate to the Festival as determined in the sole discretion of the Producer. I/we further agree that the Producer may take any action for compliance with such conduct by me/us for the Festival as the Producer may, in its sole discretion, deem necessary, including my/our expulsion from the Festival without a refund of any fees paid.
- to be responsible for collecting all applicable sales tax, for securing any and all required permits, and complying with all government laws and regulations.
- to keep my/our space neat in appearance and in good order while exhibiting and/or selling.
- to vacate my/our space at the end of the Festival and to fully clean it, returning it to the condition it was found in.
- that my/our payment will be returned if I/we am/are not accepted.
- that there are no refunds for cancellations by exhibitors.
- that the Producer shall have the right, in its sole discretion, to cancel or close the Festival due to severe weather or other exceptional circumstances over which the Producer has no control. (The Festival is a rain or shine event. However, dangerous weather conditions may cause the Producer to shut down the rides. In that event, depending on the duration and severity of the storm, the Festival may close for the rest of the day.)
- that the Producer shall be the sole authority and arbiter to decide and to make any interpretation of all Rules for the Festival, and I/we will accept and abide by the final decisions of the Producer in all matters relating to the Rules of the Festival. I/we further acknowledge and agree that any such decisions of the Producer are final in all matters and not subject to any appeal or arbitration.
