## RANDOLPH KIWANIS FREEDOM PARADE

**Saturday, July 8, 2023**

**8:30 am Lineup, 10 am Kickoff**



Join us for the Randolph Kiwanis Freedom Parade on **Saturday, July 8, 2023**. The Freedom Parade celebrates the Freedom we cherish as Americans and honors the men and women in uniform who have served, and now are serving, our great nation. The Freedom Parade is sponsored by the all-volunteer, not-for-profit Randolph Kiwanis Club in partnership with Randolph Township.

**Time:** Lineup begins at 8:30 am; must be in your position by 9:30am. Kickoff of Parade is 10:00 am. All entries done by Noon.

**Where:** The Freedom Parade will kick off from the corner of Dover Chester Road and Quaker Church Road (For GPS purposes, 443 Quaker Church Road, Randolph, NJ 07869) Entries will be staged in the Fernbrook area of Randolph.

**Parade Route:** The Freedom Parade proceeds down Quaker Church Road, turns right on Center Grove Road, crosses Route 10 and ends at County College of Morris (CCM). The route is about 1.4 miles long.

**Restrooms:** Available at the YMCA; also Porta-Johns will be available.

**Optional Shuttle Service for Drivers of Groups to the Lineup Area:** Since there is no parking on Freedom Parade Day in the lineup area, beginning at 8:00am we will run an optional shuttle service. The optional shuttles are **for drivers of groups who already have dropped off the other members of their group at their lineup positions (we do not have enough shuttles to transport entire groups or bands).**

Two shuttles will run continuously from Parking Lot #1 at the County College of Morris (“CCM”) where the Freedom Parade ends to the corner of Dover Chester Road and Quaker Church Road where the Freedom Parade kicks off. **The last shuttle will leave CCM at 9:30 am.**

Drivers of groups may drop off participants at their lineup positions, drive to Parking Lot #1 at CCM to park and then return to their lineup positions using the shuttle service. When the Freedom Parade ends at CCM, everyone can walk to their cars in the CCM parking lot.
