Meeting of the 2023-2024 District Board of Trustees

December 2, 2023 | 9:00am | via zoom John Fry, Governor, Presiding

Call to Order

The Louisiana-Mississippi-West Tennessee District of Kiwanis International Board of Trustees met on Saturday, December 2, 2023, at 9:00am via zoom. Governor John Fry called the meeting to order at 9:04am and established a quorum with the following present:

Invocation by Andrew Dozier. Defining Statement recited by all.

Governor John Fry provided a brief thanking everyone for attending the meeting and stated our efforts are a marathon. While the finish line for this year is September 30, 2024, the real finish line continues in the future. He encouraged attendees to learn by stopping presenters and asking questions.

Governor-Elect Claude Vinson said he has been working to absorb all the new info from Kiwanis International, District, and Foundation, and he is happy that his home club, Germantown, is now more interested due to his leadership connection and excited to get outside of Germantown.

Consent Agenda

Ralph Carter moved to approve the following consent agenda. Andrew Dozier seconded the motion. With no discussion, all voted in favor. Motion carried.

After Kiwanis International's facilitator canceled due to health reasons, the Executive Committee canceled the Key Leader South event.

Ongoing Business

The Board considered the District Convention (DCON) 2024 budget (exhibit C). Darren Green moved to approve. Marcel Lashover seconded the motion. With brief discussion, all voted in favor. Motion carried.

Board Committees

The Board discussed the **Bylaws & Policies Committee**. Committee Chair Andrew Dozier presented a District Bylaws Amendment to add a Vice Governor position (exhibit D). The ad hoc Leadership Development Pipeline Committee also recommended the Amendment.

Ralph Carter moved to amend the amendment by removing "current or past Lieutenant Governors" from Article 8. Vacancies in Office, Section 1. Darren Green seconded the motion. John Fry, Claude Vinson, Oscar Brown, Ralph Carter, Laura Gilliland, Andrew Dozier, and Darren Green voted in favor of the motion. Bruce Hammatt and Marcel Lashover voted against the motion. Motion carried.

Darren Green moved to approve the amended Bylaws Amendment and to hold a Special House of Delegates at the Mid-Year Education Conference on March 2, 2024, in Natchez, MS. Claude Vinson seconded the motion. All voted in favor. Motion carried.

Next, the Board discussed the **Budget & Finance Committee**. Committee Chair Ralph Carter presented the LaMissTenn Kiwanis District, LaMissTenn Key Club District, and LaMissTenn Circle K District 2022-2023 year end financials (exhibit E). Claude Vinson moved to accept the report. Darren Green seconded the motion. After brief discussion, all voted in favor. Motion carried.

Next, the Board discussed the **Education Committee**. Committee Chair Marcel Lashover presented the following items as the 2024 Mid-Year Education Conference programs:

- **A.** Membership: panel of speakers from two or three clubs using the Two for Two Program
- **B. Fundraising & Service Projects**: panel of speakers from two or three clubs talking about their projects; QR code linking audience to a handout on each project discussed
- **C.** Club Networking & Co-Learning: randomized groups working through a short list of prompts

Laura Gilliland moved to approve the education topics for the 2024 Mid-Year Education Conference scheduled for March 2, 2024. Claude Vinson seconded the motion. After brief discussion, all voted in favor. Motion carried.

Chair Lashover reviewed this year's CLE (Club Leadership Education) topics and procedure. The Education Committee proposes to hold CLEs virtually over a series of weeks on the following topics: (1) President, (2) Secretary 101, (3) Secretary 102, (4) Treasurer 101, (5) Treasurer 102, (6) Membership Chair, (7) Board Member, and (8) Bylaws & Policy. The two 102 CLEs and Bylaws & Policy CLE are new this year. The 102 CLEs are a response to feedback received last year that the Secretary and Treasurer CLEs

are too advance for new clubs and new Secretaries and Treasurers. While Bylaws & Policy content was previously included in the Board Member CLE, the Education Committee wants to highlight and heighten the importance of policies. The Education Committee will meet next week to determine the dates. Laura Gilliland moved to approve the CLE topics. Andrew Dozier seconded the motion. After brief discussion, all voted in favor. Motion carried.

Next, the Board discussed the **Membership Committee**. Committee Chair Laura Gilliland reported the Membership Committee has secured four clubs to sponsor a new club this year: eLaMissTenn, Walker, Pinebelt, Hattiesburg, MS, and Dyersburg. ELaMissTenn, Walker, and Pinebelt have also identified two club coaches for a two-year commitment. The eLaMissTenn Club is working on a February 2024 club opening in Many, LA.

Committee Chair Laura reported that District Membership Coordinator (DMC) Eva Abate is working on club strengthening including a game plan for club boosts.

Committee Chair Laura has secured fifteen (15) Kiwanians as appointment setters to participate in new club opening efforts.

Next, the Board discussed the **Service Committee**. Committee Chair Oscar Brown is working to engage clubs in recognizing community honorees (firefighter, lawperson, teacher, layperson). He said he will send reminders to the clubs. Governor John suggested Chair Oscar add a District Foundation representative to the Service Committee. As District Foundation President, Andrew Dozier, will connect with Chair Oscar.

Next, the Board discussed the **SLP Committee**. Committee Chair Darren Green expressed he is experiencing challenges in engaging Committee members in scheduling a meeting. Executive Director Jen will help Darren with a doodle/google poll.

New Business

The Board discussed possible changes to the Finance Policy. The Bylaws & Policy Committee and Finance Committee will work to revise the Finance Policy and present at the next Board meeting.

Next, the Board discussed the procedure to collect charter dues for new clubs. Bruce Hammatt moved to approve the District collecting charter dues for new clubs and oversee the submission of charter dues to Kiwanis International. Laura Gilliland seconded the motion. After brief discussion, all voted in favor. Motion carried.

Next, the Board discussed the District office space lease renewal. The District's landlord, Celtic Studios, is proposing increasing the District's lease by \$0.08/sq ft for the 2023-2024 lease. This would result in increasing the District's monthly payment by \$26 from \$650 to \$678; a \$312 annual increase. Bruce Hammatt moved to approve the increase. Laura Gilliland seconds the motion. After brief discussion, all voted in favor. Motion carried.

Governor John Fry provided a brief thanks to everyone for attending the meeting and expressed his excitement to work with this team to improve the District over the next year.




Ralph Carter moved to approve the following consent agenda. Andrew Dozier seconded the motion. All voted in favor. Motion carried.

Ongoing Business

The Board discussed DCON 2023 in Lafayette, LA. DCON 2023 had 66 clubs represented with 240 Kiwanians.





Next, the Board discussed future DCONs. DCON 2024 will be held on July 26-28, 2024, in Tupelo, MS. The registration and attendance goal for DCON 2024 is 70% of club representation (~81 clubs) with 265 Kiwanians. DCON 2025 will be held August 8-10, 2025, in Memphis, TN.

The Board reviewed District Committee Chairs appointments (exhibit C).

Board Committees

The Board discussed the **Bylaws & Policies Committee**. Committee Chair Andrew Dozier reported that he is working with committee members to develop a plan.

The Board discussed the **Budget & Finance Committee**. Committee Chair Ralph Carter reported that he and the Executive Director, Jen Robertson, have been clearing issues within QuickBooks.

The Board reviewed the financials for LaMissTenn Kiwanis District (exhibit D), LaMissTenn Key Club District (exhibit E), and LaMissTenn Circle K District (exhibit F). Marcel Lashover moved to accept the reports. Oscar Brown seconded the motion. There was no discussion. All voted in favor. Motion carried.

The Board considered the 2023-2024 budgets (exhibit G) for the LaMissTenn Kiwanis District, LaMissTenn Key Club District, and LaMissTenn Circle K District. Bruce Hammatt moved to accept the budgets. Darren Green seconded the motion. All voted in favor. Motion carried.

The Board discussed the Key Club CREATE Funds. No action was taken.

The Board discussed the **Education Committee** and reviewed the final 2022-2023 Club Leadership Education (CLE) training participation numbers below.

The Board discussed the **Membership Committee**. Committee Chair Laura Gilliland reported that the Kiwanis Club of Elamisstenn, Baton Rouge will sponsor a new site in the Shreveport area in partnership with the Oklahoma-Texas Kiwanis District.

The Board discussed the Service and SLP Committees. Service Committee Chair Oscar Brown and SLP Committee Chair Darren Green had no report at the time.

New Business

The Board reviewed the 2023-2024 District Facebook Award Program (exhibit H) and 2023-2024 District Newsletter Award Program (exhibit I). Marcel Lashover made a motion to approve the programs as presented with the addition of a June 12, 2024, deadline. Andrew Dozier seconded the motion. With no discussion, all voted in favor. Motion carried.

The Board considered relocating the District office to The Bug Man building (exhibit J). The Bug Man property is a third-floor office space. It would be a cost savings compared to the current office location, Celtic Studios. Moving into The Bug Man space would involve travel and relocation costs including hiring a moving crew to move furniture. Marcel Lashover moved to keep the office at its current location of Celtic Studios, and to thank the owner and fellow Kiwanian, Mr. Paul Salvant, for his generous offer. Laura Gilliland seconded the motion. After brief discussion, all voted in favor. Motion carried.

The Board considered the Mid-Year Education Conference 2024 registration fee. Earlier in the year, the Board approved a \$25 per person registration fee for the Mid-Year Education Conference in Natchez, MS, on March 2, 2024. Upon review of the event's budget, the Finance Committee recommended the Board consider increasing the registration fee to \$35 per person to reduce the event budget deficit. Darren Green seconded the motion. After discussion, all voted in favor. Motion carried.

I also have been communicating with another Key Leader District Committee Chair from another district, and I have been sharing information with him as far as my time line is set up for what I do to prepare for Key Leader. I have shared the same plan with him that I've attached to this email.

Next month, December 2023, I will begin getting ready for Kiwanis Key Leader North, April 26-28, 2024, as we will begin updating the registration site so that I can ready to open in January. In January, I will begin recruiting Student Facilitators and Chaperones for Kiwanis Key Leader North. I will also be starting to recruit both new and returning sponsors in January and February. I did prepare a handout to share with anyone who is planning to coordinate a Key Leader Event which I shared at the District Convention.

Per Rebecca Huff:

I know we were all very disappointed that the Key Leader South weekend had to be cancelled at the last moment. And it is devastating that we still owed money to Camp Istrouma and possibly to Kiwanis International.

We did ask Cody at Camp Istrouma if we could move our deposit to the next scheduled camp, but he said "No" and not only that we have to pay 80% of the anticipated bill. I know he reworked the bill, but if I got a copy of it, I cannot find it in my e-mails.

I also know that the District has asked Kiwanis International to waive the \$6000 we were to pay them, but if they have responded to that request, I have no knowledge of it.

The only thing I do know is that last year's camp netted a profit of \$1480.81. That is not even enough to cover the total we owe Camp Istrouma not to mention that we had already paid our webmaster \$115 for his services from that amount.

If there is a plan of some kind to help the District recoup some of the money we will owe, please let me know and I will share it with the clubs in Division 9.

Proposed Bylaw Amendment No. 1:

Adding the position of Vice Governor

ARTICLE 3. DISTRICT OFFICERS

Section 1.

a. The officers of the district shall be the Governor, Governor-elect, <u>Vice-Governor</u>, Immediate Past Governor, Secretary, Treasurer, and a Lieutenant Governor for each division and a Trustee for each region of the district.

Section 2.

- a. Each district officer shall be an active member** in a club* of the district. Each trustee shall be a member* of a club* in the region from which elected. Each lieutenant governor shall be a member** of a club* in the division from which elected. However, if there is no member** from a club* in a particular division qualified and willing to serve as lieutenant governor, a member** of a club* in another division may serve. Each candidate for the office of The Governor and Governor-Elect, and Vice Governor also shall have and maintain a clear criminal history background check conducted and verified by Kiwanis International. (7/2014)
- **b.** The Governor and Governor-Elect and Vice Governor, before assuming office, shall have completed at least one (1) term as a Lieutenant Governor in this district and at least two (2) years as a District Trustee.

Section 7. The Vice-Governor has the further duties and responsibilities:

- **a.** To give priority to such training, orientation, and other activities that focus on education, leadership, and growth to prepare to later hold the offices of Governor-elect and Governor.
- **b.** Attend training of incoming district officers.
- **c.** Any other duties as assigned by the Governor.

Section 7 8. The Immediate Past Governor shall be a resource to the District Governor and District Board.

Section 8 9. The Executive Director has the further duties and responsibilities:

- a. Assist the Governor and District Board in conducting the business of the district
- **b.** Keep all records of the district.
- **c.** Be the executive in charge of the District Office and, subject to the approval of the District Board, select the employees.
- **d.** Submit to the proper officers, committees, or persons all communications received from Kiwanis International and cooperate with the Governor in forwarding all reports required by Kiwanis International.
- e. Attend and keep the minutes of the meetings of the District Board and the district conventions.
- **f.** Make a report to the district at its annual convention and such other reports as directed by the

- Governor or the District Board.
- **g.** Keep the financial accounts and records and be responsible for proper internal control procedures, including the receipt, deposit, and disbursement of district and sponsored organization funds in the manner authorized and prescribed by the District Board.
- **h.** Make available for inspection by the Governor, the District Board, or any authorized parties, the financial accounts, records, and books of the district and its service leadership programs.
- i. Be a member of the Finance Committee.
- **j.** Regularly review and advise the District Board on the financial condition of the district and its service leadership programs.

Section 9 10. The Lieutenant Governors have the further duties and responsibilities:

- **a.** Provide support and assistance to the clubs in their division.
- **b.** Plan and preside at divisional meetings, under the direction of the District Board.
- **c.** Assist the Governor and the District Board in communicating and implementing the plans and goals of the district in their divisions.
- **d.** Report to the Governor about the condition and activities of clubs within their divisions.
- e. Visit each club in the division as many times as required by the district.
- **f.** While serving as Lieutenant Governor-elect shall assure training of the incoming club officers.

Section 10 11. The Trustees have the further duties and responsibilities:

- **a.** Perform the duties as a member of the District Board.
- **b.** Provide support to the Lieutenant Governors in their region.
- **c.** Plan and preside at regional meetings, under the direction of the District Board.

ARTICLE 4. DISTRICT BOARD

Section 1. The District Board shall consist of the Governor, Governor-elect, <u>Vice-Governor</u>, Immediate Past Governor, Executive Director, and a Trustee for each region. The Executive Director shall be without vote.

ARTICLE 7. NOMINATION AND ELECTION OF OFFICERS

Section 3. The nominating and election procedure for officers to be elected at the annual convention shall be as follows:

- **a.** The Governor-elect shall be the sole candidate for the office of Governor. The Vice-Governor shall be the sole candidate for Governor-elect. However, in any year in which the Governor-elect or Vice-Governor was not previously elected by the district house of delegates or is no longer qualified to hold the office, other qualified candidates shall be permitted.
- **c.** Qualified candidates for Governor, and Governor-elect, and Vice-Governor shall:
 - Submit a signed agreement provided by Kiwanis International to fulfill the duties of office.
 - Have a clear criminal history background check conducted and verified by Kiwanis International.
 - Be endorsed for the office by his or her primary club.

ARTICLE 8. VACANCIES IN OFFICE

Section 1. In the event of a vacancy in the office of Governor, or Governor-elect, or Vice-Governor, the vacancy for the unexpired term shall be filled by majority vote of the District Board from among the qualified past Governors, current or past Lieutenant Governors, or current or past Trustees.
