

### How to file Articles of Incorporation for the State of Louisiana

Please follow the steps below to submit your Club's Articles of Incorporation. For Kiwanis Clubs located within the State of Louisiana only. The club should maintain copies of all documents for club records.

- 1. Complete and adopt the Resolution (Form A; page 2) at a club meeting. Club members must have been provided at least a two week notice of the meeting. The vote to adopt must be approved by at least two-thirds (2/3) of the active members in attendance.
  - With the adoption, sign and get notarized.
- 2. Complete the Articles of Incorporation (pages 3-5)
- 3. Send copies of the fully executed Resolution (Form A; page 2) and Articles of Incorporation (pages 3-5) to Rene Booker (rbooker@kiwanis.org) at Kiwanis International.
- 4. With Kiwanis International's approval, Kiwanis International will send the club a Consent page (Form B) approving the club to file the Articles of Incorporation with the State of Louisiana.
- 5. Complete the State of Louisiana's Transmittal Information form (pages 6).
- 6. Mail the Consent (Form B), Resolution (Form A; page 2), the State of Louisiana's Transmittal Information form (page 6), and the Club's Articles of Incorporation (pages 3-5) to the Louisiana Secretary of State with a \$75 check for the filing fee payable to Secretary of State.
- 6. With the State's approval, the State will mail a copy of the certified Articles and Certificate of Incorporation.
- 7. Mail a copy of the certified Articles and Certificate with the completed Agreement (*Form C; page 7*) to Kiwanis International (Attn: Rene Booker, 3636 Woodview Trace, Indianapolis, IN 46268).
- 8. Within 30 days of filing the Articles of Incorporation with the Louisiana Secretary of State, a copy of the certified Articles of Incorporation must also be filed with the Parish office of the Clerk of Court.
- 9. The club should retain the certified copy of their Articles of Incorporation for their club records.
- 10. NOT PART OF THE ARTICLES OF INCORPORATION PROCESS, BUT NECESSARY: Complete and submit a Letter of Authorization for Group Exemption Reporting (page 8) to Joanne Fregeau (jfregeau@kiwanis.org) at Kiwanis International.

**ARTICLE IV: NON-STOCK BASIS** 

This corporation is to be organized on a non-stock basis.

#### **ARTICLE V: DISSOLUTION**

Whenever requested by the Board of Trustees of Kiwanis International the proposed corporation will dissolve or change its form of organization, and no change in the corporate structure or in the purposes and powers of the proposed corporation should be made without the consent of Kiwanis International.

Upon the dissolution of the corporation, the governing board shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation, in such manner to such organization or organizations organized or operated exclusively for charitable, educational, religious, or scientific purposes, as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue law), as the governing board shall determine. Any such assets not so disposed of shall be disposed of by the District Court in the Parish in which the principal office of the corporation is located, exclusively for such purposes.
