Dear Members,

I just returned from the Governor Elect Conference (Nov 6-10) at Kiwanis International headquarters in Indianapolis. It was an intense program geared to tell us what to expect from our year with President - elect Michael Mulhaul (2025-2026), as well as to meet with the staff at KI and present our ideas.

KI is talking about adding four new Clubs in that year in our District. I am thinking that perhaps two should be formed within the Twin Cities metro as a starter.

During my stay I suggested that KI should become more involved with Club formations and membership than its current "Ivory Tower" perception. It should become more "hands-on" and some reform is needed. They have great educational and research capabilities. In my opinion, KI could initially become a "call center" for Clubs and Districts. A Club or District would submit say 50 names and KI would professionally call these prospects and send any leads to a local Club for membership or strongly help in the possibility of new nearby Club.

Most of us do not have the skills and knowledge to adequately sell the program. A professional call center would have both. For example, a prospect might be interested in service only to later find out that he/she had been interested in selfdevelopment. In this process we likely lose this individual.

A professional call center could limit these mistakes. It could communicate with 50 prospects within a day with enhanced success. I told President -elect Michael that if he were serious about realizing new Clubs and increased membership, we need a paradigm shift in thinking.

Until KI realizes the benefits of this type of approach, we must continue to use the old ways of increasing membership, i.e., verbally asking people to join. The more members we have the greater service we can do, benefiting more people within the process. Further, having more Kiwanis members within our communities brings an enhanced "shine' to our community service.

- Only 43 of our 103 clubs have completed the monthly report for October and the November report is now due. Lt Governors are making an effort to visit with your club and they need the information you provide in your monthly reports to make these visits meaningful and productive. If your club secretary is new or needs some training, let me know.
