BOD MINUTES OF MEETING: August 13, 2024

The Board meeting was called to order at 10:08 AM by President Janet Cederholm.

Board Members/Committee Chairs Absent Jim Cook, Becky Hopson, Larry Scilley, and Linda Rouhoff Other Day Makers, Members Present, Sue Johnson and Judy Zierdt

Approval of Agenda: Dave Bhaskaran moved, and Ruth Vrieze seconded the motion to approve the agenda with the addition of 3rd Quarter Audit Report and the change from \$15 per dozen to \$20 per dozen for the Rose Sale. Agenda was approved.

Approval of Minutes of Previous Meeting:

Helen Kolb made the motion to approve the minutes, of the meeting of July 9, 2024. Jim Schwinghammer seconded the motion. **Minutes were Approved.**It was moved by Dave Bhaskaran and seconded by Ruth Vrieze to approve the June 2024 monthly report to Kiwanis International. **Motion was approved.**A motion was made by Jim Decker and seconded by Garry Post to approve the July, 2024 monthly report to Kiwanis International. **Motion was Approved.**

Treasurer's Report as of July 31, 2024: The report was sent out to all board members in the packets before the meeting. Dave Bhaskaran moved to accept the report as presented and Helen Kolb seconded the motion. Motion was Approved.

OLD BUSINESS:

The Board and Committee structure for the 2024-2025 Kiwanis Year sent out in the packet and was acknowledged as informational. There was one correction from the distributed information. Under Committees and Chairs it should read Becky Hopson as Board Meeting Chair.

It was reported that the Scholarship payment for the Herb Erickson Scholarship for the 2024-2025 Kiwanis Year was sent to North Central University in Minneapolis in Cameron Stout's name.

Jim Decker reported that a satisfactory audit for the third quarter (April, May and June) of the 2023-2024 Kiwanis Year had been completed by Dave Bhaskaran, Jim Decker and Jack Zierdt.

BOD Meeting:

NEW BUSINESS:

The weekly meeting for September 3, 2024 (the day after Labor Day) will be cancelled. **This was done by Board Consensus!**

A motion was made by Helen Kolb and seconded by Ruth Vrieze to include a \$100 check to each of the three schools with the backpacks and school supplies.

Motion was Approved.

Backpacks, School Supplies and a \$100 check will be taken to Harriet Bishop by the 15th of August. The other Backpacks, School Supplies and a \$100 check will be delivered to Riverside Elementary and Pinewood Elementary following our meeting on August 20th.

The Projected Budget for the 2024-2025 Kiwanis Year was sent out in the board packet and reviewed at the meeting. The budget for 2024-2025 Kiwanis Year will be approved at the September 10th board meeting. Jim Decker moved and Jack Zierdt second the motion to approve the dues increase for the 2024-2025 Kiwanis Year. **The motion to increase the dues by \$10 per quarter was approved.** Jack will make a presentation to the club members explaining the dues increase at an upcoming meeting.

Dave Bhaskaran and Jim Schwinghammer moved that we donate 6 - \$500 scholarships to the Jeremiah Program this year. The motion also included approval of our annual \$250 donation for a welcome Basket. **The Motion was Approved.**

The annual Rose Sale will be held starting on Tuesday August 20th with the delivery date of October 10th. Roses will sell, again this year, at \$20 per dozen. We have ordered 125 dozen for this year's sale.

The board members agreed by consensus that we would contribute funds to the Food for Kidz program again this year. The funds will be donated to the program, for them to pack the food, if the Civic Center in Stewartville sells and the Kiwanis Club is not able to host it. At the present time the Stewartville Kiwanis Club has a date of Saturday April 5, 2025 scheduled for the Food for Kidz packaging service project if they can use the Civic Center.

Helen reported on behalf of the Youth Services Committee that the Advisors have had a picnic planning session with last year's 4th graders to have a 5th grad K-kids group as well as a 4th grade group for this next school year.


President Janet adjourned the meeting at 11:38 AM following a motion by Dave Bhaskaran and second by Jim Schwinghammer
