     from East Garrison (EG) regardless of price or proximity
  - 63% would not use transit even if given free monthly bus pass
  - Believe that EG homeowner should not be made to pay anything for transit through HOA or Mello-Roos
  - Are not willing to pay for transit that connects EG and CSUMB
- Top concerns about public transit inside EG are Extra wear on roads maintained by the HOA, Traffic and Safety





# 2. How long have you lived in East Garrison 148 responses







4. How often have you used public transportation since you lived in East Garrison?




5. Which of the following places would you be likely to go to via public transportation from East Garrison?

6. Which of the following factors are most important for you when you decide whether to use public transportation from / to East Garrison?




About half of respondents say that the following factors would not influence their decision about where to use public transit to / from EG:

7. At the following price points, how often would you use public transit that's accessible in or near East Garrison?





About 63% of respondents say they would not use public transit from EG at any price, including free




About 60% of respondents say they would use public transit from EG if regardless if boarding was near (500 feet) or far (over 1 mile)

10. What concerns, if any, do you have about public transportation inside East Garrison










77.7 % would not be willing to pay anything through the HOA for transit that connects EG to CSUMB.



## 14. What are the ages of children in your household? 148 responses





We should not become the 1st HOA in the USA forced to fund public transit

are there any organizations that subsidize bus passes for seniors, handicapped or those with little income?

We do not use public transportation and do not want to fund it. Those who use public transportation should fund their own just as those of us who have vehicles have to fund gas and maintenance at our own expense. Expecting homeowners to fund other residents transportation costs is ludacris and unheard of!!

Would love to see The Waves come to EG for transportation to CSUMB

I would use a MST Bus if it were available but at ZERO additional costs to the homeowners of East Garrison-we should NOT have to pay anything for MST to have a bus go through—our development constructed the bus stops on the public road of Sherman(InterGarrison)/whatever it is across from the Fire Station-the bus should go there at NO ANNUAL FEES to the homeowners or HOA. To be clear, I'm not saying riding the bus/bus fare should be free, but to add a stop in East Garrison for an existing bus line should NOT be of ANY cost to East Garrison homeowners or our HOA.

The last thing this community needs is another reason for residents to dislike living here—between the HOA headaches and now this ridiculous bus pass proposal, EG is practically a bingo card of reasons to regret buying a home here. Why pile on with double taxation? I have enough to complain about already.

If the MST is already providing transportation from Salinas to CSUMB, they should be able to make a couple of stops at East Garrison for the apartment dwellers who may use it more.

This is ridiculous and should not be funded at all. We are already taxed to provide funding for this. Absolutely no funding for this! We already pay taxes for this.

The new changes to the 61 MST have severely impacted my aboto run errands and the current start and stop times make it so I have to Uber in and out of Marina just to take the bus. It's roughly \$15 to Uber into Marina

EG residences and HOA pay our fair share on property taxes and Mello Roose to maintain roads and public infrastructure just like homeowners else where in the city, county and state. We should not be pay extra on top of that to fund a city/count/state own MST bus when our property taxes and income taxes are already cover the public infrastructure. This is unfair burden on EG residents/HOA. It must not be allowed to happen.



I appreciate having public transportation especially for seniors and those who did not have a license or money for a car for apartments and low income parts of EG.

Always have supported public transit but I think the county needs to think about how they are spending money on transportation. They have not managed money very well. Our roads are terrible in the county. I hope that leaders think about how the spend money of tax paying citizens. It's very frustrating. I am thankful to have a place at manzanita but I have been very frustrated with elected officials and the terrible road conditions. A shuttle to save on gas would be super helpful and appreciated.

I wish we had more rail systems like they do in Europe. I buses are slow and use the same roads as the rest of traffic. Buses are always inconvenient and not worth the time or money. That's why driving culture maintains the status quo.

The taxes I pay the county and the outrageous mello roos we are charged should pay for transportation. We would be the only HOA in CA if not the US, that makes its residents pay to fund public transportation.

HOA dues going toward funding this makes no sense at all.

We do not plan on using MST, nor should we be responsible for paying for others.

I do not support this and don't want to pay extra fees to fund this.



East Garrison HOA property owners already are double taxed through Mello-Roos. We have no law enforcement presence due to Sheriff ISON Department's incompetent leadership by Tina Nieto and County Supervisors. MST should not be paid for by East Garrison property owners - there is no legal precedent for an HOA to pay for public transit services anywhere in California or nationwide. This entire scheme was created over a decade ago by corrupt County Supervisors and the developers. It is illegal and should be challenged through litigation. East Garrison property owners are not receiving the County services we already pay for through Assessor property taxes and Mello-Roos line items for Services and Facilities.

The EG homeowners should not be made to pay anything for other people. Everyone should pay for their own stuff. Why would you make homeowners pay for other people's transportation? Majority of the residents here use their own cars. The state of California is already ripping taxpayers off, nobody wants additional burden. Please have some common sense. Also, public transportation will only bring more congestion, crime, noise and chaos to town.
